MARY ANN TERRELL

DIED, WILCOX, Oct 13, 1910

Mary Ann TERRELL, the subject of this sketch was the fifth child and youngest daughter of **Philemon TERRELL** and Margaret **RATCLIFF**, his wife. She was b. Feb 8, 1827 in Wilkinson Co. MS.

About the age of five or six years, she removed with her parents to Pulaski Co. AR, where she lived near Little Rock. This journey was made in a covered wagon, as was customary in those days, over a road which was simply an Indian trail. In those days, Indians were numerous and white settlers few, and many a night did she spend in wakefulness and fear, dreading an Indian attack.

On November 11, 1845, she was married to **Peter LEFEVRE** of Pulaski Co. AR. To this union were born three children, of whom the only one now living is Mrs. **Margaret Innis**.

After the death of her husband, she removed to Pointe Coupee parish, where her father and her youngest brother **Samuel Lafayette TERRELL** had preceded her.

On October 10 1855, she was married to **James Creath WILCOX** of Elizabeth City, NC. To this union were born four sons and two daughters. Of this number only two are now living, **Susan Elizabeth Humphreys** and **Cammilla Ann Humphreys**.

During the Civil War, the home was frequently visited by both Federal and Confederate soldiers and both received courteous treatment. At one time a skirmish took place near home in which Mrs. WILCOX came near being shot.

The deceased entered into rest Thursday, October 1, 1910, at the age of 83 years, eight months, and 5 days.

She leaves to mourn her loss, three daughters, seventeen grandchildren, and eight great-grandchildren.

W. H. & G. W. TERRELL & Bailey BARTON

I received this document in email a short while ago as part of documentation dealing with **Jane BROWN Barton**. In this particular document dealing with churches in the Saluda district / Pickens County SC were mentioned **W. H.** and **G.W. TERRELL**, albeit briefly. I'm contributing the document for those descendants that may be interested. W.H. and G.W. TERRELL were *possibly* **William Higgins** and **George Washington TERRELL**, born in North Carolina, later of Georgia and Alabama. I'm not 100% sure of that information as they are two individuals I haven't fully researched.

 In the 1700's churches were organized such that some members could meet at another location and be known as an arm. On the fourth Saturday in December, 1797 at the Secona Baptist Church conference, a group of people requested to be an arm of the church. This conference was held in the home of **Lewis WIMBERLY** which was located on part of a 300 acre tract lying on both sides of *Twelve Mile River*. The conception of what we now know as **Mountain Grove Baptist Church** occurred during this conference.

In February, 1798 the following people were set aside for the arm: **John HUDSON** (deacon), **Stephen VAUGHN**, **Lewis WIMBERLY**, **Noah WIMBERLY**, **Elizabeth HUDSON**, **Mary VAUGHN**, **Mary WIMBERLY**, **Winnie WIMBERLY**, and **Margaret LANGLEY**.

By the March 1798 conference, the arm asked **Wil-**

liam MURPHREE to attend them once a month. Mr. **MURPHREE** was the pastor for Secona at this time. (Flynn, Jean Martin, *History of Secona Church and the Pickens Area.*

1987)

This arm apparently became very strong because it almost "put Secona out of existence" (Flynn, J. M., 1987). This arm was the same one that in 1818 was constituted into *New Hope Baptist Church*, as a member of the *Saluda Association*. *New Hope* was listed in their minutes for ten years (1828). After this date, no further mention was made of an arm of Secona in the association minutes.

New Hope Church was listed in the District Union Meetings as being in District Two. These meetings were held quarterly. *New Hope Church* was not mentioned in the association minutes after 1828.

We can speculate about why this church became inactive. Land deeds and plats give clues to its eventual fate. We shall trace the ownership of the land and the parallel history of the church. **George SALMON** who had been granted land from the state of South Carolina in 1787 (Pendleton District, S.C. deed) sold one tract of land (290 acres) to **John FIELD, Sr.** in 1793. He sold another tract of 300 acres to **Charles LAY** in 1804. (Anderson County, S.C. deed books)

Evidently, **Charles LAY** later purchased 200 more acres of land (no known deed) because he deeded 500 acres of land to **W. H. TERRELL** and **G. W. TERRELL**. In 1814, this land was released to **John FIELD, Sr.** from **W. H. TERRELL**. Apparently, **G. W. TERRELL** had died or had moved to virgin land. **John FIELD, Sr.** owned extensive acreage in this area including land with a church or meeting house. In those times churches were located on private property. This meeting house must have been *New Hope Church* since **John FIELD Sr.** was a delegate to the annual association meeting in 1819. This was before Twelve Mile River Association was formed.

In 1822, **John FIELD, Sr.** gave this land to **Bailey BARTON, Esq.** Mrs. **Bailey BARTON (Jenny)** was the daughter of **John FIELD, Sr.** and **Anna MACONNEL Field**. This was conveyed by deed of gift as was the custom of this time. The deed states "more or less the same being of two surveys which will show from former deeds made from **Charles LAY** to **G. W. TERRELL** and **W. H. TERRELL** lying and being on the waters of Twelve Mile River in said state and district" (Deed of W.H. TERRELL, Oct. 25, 1814). See Figure

One. A ditch used as the boundary of the property ran through what is now *Mountain Grove Cemetery*.

By 1828, *New Hope Church* became inactive. This event occurred six years after the 500 acres of property upon which a meeting house was located had been given to **Bailey BARTON**. Ironically, Mr. **BARTON**'s final resting place was apparently the burying ground of the inactive *New Hope Church* which is today the site of *Mountain Grove*.

Bailey BARTON, Esq. was interred in this burying ground 25 years after he accepted the land as a gift. The marble slab which was the top of the box over his grave lays in *Mountain Grove Cemetery* as a tombstone. Originally, Mr. **BARTON**'s grave was covered by a marble box. refer to "Cap" **CANTRELL**'s memories in Chapter C, Memories. Mr. **BARTON**'s obituary appeared in the *Pendleton Messenger*, February 19, 1847. The **BARTON** home which still stands (1993) is owned by Mr. and Mrs. **Marshall T. ABBOTT** of Westminster, S.C.

The reason that *New Hope* became inactive remains unknown. While this church may have died down, a spark of Christianity was kept alive by residents of the area and rekindled in another location during the late 1820's and early 1830's. This congregation who adopted the name, *Mountain Springs*, consisted of several **BARTON** neighbors, including **Jacob GUYTON** and **Jacob LEWIS**.

TIMOTHY AND TEMPERANCE TERRELL

Born in 1782 in North Carolina,¹ **Timothy TERRELL** was one of twelve children of **Joel** (1751-1815) and **Elizabeth (RUSH) TERRELL** of Franklin County, North Carolina.² He was descended from a long line of **TERRELL**'s (Tyrrold's) of West Hagbourne in Berkshire, England that emigrated to the Colony of Virginia in the mid-1600's.³ The 1850 and 1860 censuses of Victoria County, Texas show Timothy's occupation as a medical doctor, but to date no record has been found of his having practiced medicine.

Timothy first married **Elizabeth BATTLE** of Raleigh, North Carolina, but she died, leaving no children. He married secondly, about 1811, **Tem-**

perance BARNES,⁴ called "Temple." Temperance was born in 1790 in North Carolina, according to the 1850 census of Victoria County, Texas, the daughter of **Lemuel** and **Michel (VICK) BARNES**.⁵

Hearing of available land in Texas, the TERRELL's, with their four children and son-in-law, sailed from Charleston, South Carolina and landed in South Texas at Port Lavaca⁶ in 1846. That was the same year that the Republic of Texas became a state and was admitted to the Union.

They made their way first to Jackson County where **Timothy** and his oldest son, **William**, appear on a poll list of 1846.⁷ The TERRELL's, however, soon moved to southern Victoria County, where Timothy, his son William, and his son-in-law, Dr. **Barnes SIMMS**, purchased 2214 acres of land on the San Antonio River for \$2,214. in cash in 1851.⁸ They were all neighbors and everybody worked together. The bottomland was very rich and covered with oak, pecan, and many other kinds of trees. Their land was twenty miles south of Victoria and a few miles west of the former community of Anaqua where a ferryboat operated across the San Antonio River.

Dr. TERRELL and his wife both died in Victoria County sometime between 1863 and 1870.⁹ The last known record of Timothy was on January 14, 1863, when he bought 653 acres of land on the San Antonio River,¹⁰ but neither he nor his wife are listed in the 1870 Victoria County census. Their place of burial has not been verified, but the most probable location is the TERRELL Family Cemetery on their former ranch on the San Antonio River, although there are no surviving headstones or markers for them.

Timothy and **Temperance TERRELL** had four children, all born in Nash County, North Carolina.¹¹

1. Their first child, **William Joel Tolliver TERRELL**, was born on April 24, 1824, married **Rebecca BERRYHILL**, and died on June 16, 1900. They had sons **Robert** and **Isaac Timothy TERRELL**. William and Rebecca sold their interest in the TERRELL land in 1866,¹² which was probably

soon after his father's death. After Rebecca died in 1891, William lived with his brother **Crogran**.

2. Timothy and Temperance TERRELL's second child was **Frances Jane**, who was born October 17, 1827, and died June 27, 1893. She first married Dr. **Barnes SIMMS** in Nash County, North Carolina, on February 5, 1845,¹³ and they had five children: **Robert Barnes**, **James Tolliver**, **Marcellius Julius**, **Elizabeth** (died young), and **Alice SIMMS**. After her first husband's death in Victoria County, Frances married a schoolteacher from South Carolina, **John M. STEVENSON**, and they had three daughters: **Francis**, **Cornelia**, and **Kate STEVENSON**. Their daughter, **Francis Jane**, married **James Somervell TUCKER**, and had **Alice**, **Pearl**, **James**, **Steve**, **Louie**, **Lillie**, **Lauretta**, **Dewitt**, and **Mary TUCKER**.

A silver tablespoon with the letters "FJT" engraved on the back of the handle, and an interesting story about it, have been handed down in the family for several generations. It is family tradition that when the TERRELL's left the Carolinas to go to Texas that Dr. TERRELL took some silver dollars to town and had six teaspoons and two tablespoons made from them. He gave the tablespoon with "FJT" engraved on the handle to his daughter, **Frances Jane TERRELL**. She passed the spoon on to her oldest daughter, **Francis Jane (STEVENSON) Tucker**, who later gave it to her daughter, **Pearl Elizabeth (TUCKER) Summers**. Mrs. Summers in turn passed the spoon on to her daughter, **Dede K. (SUMMERS) Prewitt**, who gave it in 1981 to her son, **Robert C. Prewitt**.

3. The third child of the TERRELL's was **Timothy Wheelock Ripley TERRELL**, born January 25, 1831, and died January 6, 1899. He served in the Confederate Army during the Civil War. He never married.

4. **James Crogran Ludlow TERRELL**, born August 27, 1834, and died January 24, 1919, was the youngest child of Timothy and Temperance, and was also a Confederate Army veteran. After living and ranching with his bachelor brother, **Ripley**, for many years, Crogran married **Lauretta Elizabeth WILKINSON**, daughter of **Robert P.** and **Mary F. (BROWN) WILKINSON**, pioneers of Berclair,

Texas, at Goliad in 1892.¹⁴ They had a daughter that died in infancy, and a son, **Ripley Ludlow TERRELL**, born in 1897, who lived a wild, but short life.¹⁵ He was killed in 1928, and was buried in the Berclair Cemetery, as well as his mother who died in 1957.

All four of Timothy and Temperance TERRELL's children died in Victoria County and were buried in the TERRELL Cemetery on the former TERRELL Ranch on the San Antonio River;¹⁶ gone, but not forgotten.

The TERRELL Cemetery (six marked graves) is located on private property under a small grove of trees in a pasture. From Victoria, drive south on Highway 77 several miles toward Refugio, turn right (west) on San Antonio Road (445), and continue about eight miles to the sixth cattle guard across the road. From there the cemetery is on the left side of the road about 600 yards west in a pasture, and cannot be seen from the road.

GOVERNOR JOSEPH MERIWETHER TERRELL *Joseph's* *Grandfather*

Joseph TERRELL came from a very wealthy family. His grandfather was **David Meriwether TERRELL**. He was a good citizen of Meriwether County and a faithful member of the Baptist church. He was also a successful farmer.

He bought land from the executors of the estate of **Thomas DARK** in 1844. He was a slaveholder and in 1850 had sixteen slaves. The farm was worth \$3,600.

His livestock included one horse, five mules, six milk cows, four working oxen, and six other cattle. He had fifteen sheep and ninety pigs. In 1850, his livestock was valued at \$95,000.

His farm produced wheat, Indian corn, ginned cotton, peas and beans, and sweet potatoes. In the dairy, 20 lbs. of butter were made.

David Meriwether TERRELL first married **Martha CHAPMAN**. They had two children, **Joel Edward Green TERRELL** (Joe TERRELL's father) and **Ann TERRELL**. After Martha passed away, David married **Hulda Janet (BOOZER) Russell**. They had a daughter, **Frances Hulda TERRELL**.

Joseph's Father

Joel Edward Green TERRELL received the education available in Meriwether County and then went to high school in LaGrange, Ga. As a young man, he studied medicine with Dr. **Joseph W. ANTHONY** in Greenville, and later went to the Atlanta Medical College. He graduated in 1855. In 1856, he graduated from Jefferson Medical College in Philadelphia.

On April 2, 1856 Dr. TERRELL married **Sarah Rebecca ANTHONY**. Dr. TERRELL died November 30, 1886.

Joseph's Mother

Mrs. **Sarah TERRELL** was born on August 13, 1832 in Wikes County, Georgia. She joined the Baptist Church in Greenville in 1853 and was a very dedicated member.

She was educated at the Baptist Female College in LaGrange, Ga., and was known for her supportive attitude toward her home and community. Sarah TERRELL died December 9, 1895.

Joseph's Birth

Joseph was born at their Talbotton Street house on June 6, 1861. Friends and neighbors of the family soon came by to visit their newborn son.

"Aunt Eliza", a TERRELL slave and much loved nurse of the TERRELL children, suggested a name from the Bible. The infant was named **Joseph** (although later he was known as **Joe**). He was also given his grandfather's name, **Meriwether**.

At the age of six years old, Joe went to **Wimbish-Anthony-Strozier-Gaston House** on LaGrange Street. His teacher was Mrs. **Mattie ANTHONY Strozier** who was also his aunt. **Hiram Warner HILL** was his childhood friend. When Joe TERRELL was eight, he went to Prof. **William Tinsley REVILL's** school.

Joe TERRELL was fourteen when his father offered him a job as clerk in his drugstore located in Greenville, however, Joe was much more interested in outdoor life, so decided to try farming for a year.

Lawyer Ambition

Joe always wanted to be a lawyer. He knew he could not accomplish his goals and be a farmer too. At nineteen he returned to Greenville and read law under the instruction of Major **John W. PARKS**. At age twenty he became a lawyer.

Lawyer TERRELL began practice in the justice courts. From the success there, his practice grew in Meriwether County and spread to other counties. He was known for his kindness to orphans and

widows. On November 9, 1885 Joseph was admitted to the Georgia Supreme Court.

Candidate for the Legislature

Many people of Meriwether County thought that Joe should be a candidate for the legislature in 1883. Two old friends of Joe's father were convinced of it and spoke to his father.

His father thought Joe could run a successful campaign also. Many people remembered Joe as a young farmer and realized they had liked Joe all his life. "He was unanimously nominated on the first ballot at the convention." He became a member of the important judiciary, local bills and temperance committees.

At the convention, Rev. **E. C. THRASH**, a Baptist preacher, was also nominated. TERRELL and **THRASH** became good friends. Rev. Thrash even named his son after Joe, **Joe Terrell THRASH**.

In 1883 the Georgia General Assembly was closed, but Joe returned to the legislature in 1886. He later became the chairman of the Committee of County Affairs.

Marriage



Joe became a busy man over the years, but he made time for the courting and marriage of Miss **Jessie Lee SPIVEY**. Her parents were, **Thomas** and **Emily ROBINSON SPIVEY**, and she was born in Harris County. Jessie became Jessie TERRELL on October 19, 1896.

Attorney General

Joseph was elected on October 5, 1892 to the office of Attorney General. Governor **W. J. NORTHERN** awarded him his warrant and commission on December 31, 1892. For the next ten years, Joe tried more cases than any other Attorney General before him and never lost a Georgia case.

Governor

Joe TERRELL became a candidate for governor in 1902. Because of his early services to the state almost everyone voted for him. He served two terms with distinction. During his time serving as governor he did many notable things:

1. Recommended that fertilizer tax be collected and be used for the education of farmers and their sons.
2. Enforced many laws on inadequate public schools.
3. Preserved Georgia's state records.
4. Added tax on franchises.
5. Military forces were reorganized.
6. Birds were protected.

All in all, he met the demands of the people. In February, 1911, **Joe** was struck with paralysis, but regained strength and began to work again.

Death of Mr. and Mrs. TERRELL

Joseph passed away on November 17, 1912. He was buried in the family plot of Greenville Cemetery. The pallbearers were four of his brothers and two brothers-in-law.

His wife Jessie Lee TERRELL continued to live in Atlanta until she died on October 14, 1923. She was buried next to her husband. She and TERRELL had no children.

One old home keeps Pikeville story alive

GUIN, Ala., July 25-An afternoon drive in almost any direction will take you to some spot, built a century ago, that is nothing more than a ghost town. Settlements sprang up about all kinds of human endeavor, where some towns became great cities, while others vanished. The latter was the case of Pikeville, once a county seat-

Driving along U.S. 78 seven miles north of Guin, you would never know the seat of Marion County was once here. Tall bushes, weeds and vines have practically (sic) covered the old town cemetery.

Just west of U.S. 78 the old highway once traveled by Gen. Andrew Jackson will lead you to the only house at Pikeville today.

You view the two-story frame structure, nestled behind tall locust and sycamore trees, which reminds you of Pikeville's illustrious past and another era. It was built about the time Alabama became a state. The white columns and the balcony porch reflect the antebellum home of the 18th century.

During its heyday, most VIPs passing through northwest Alabama, stopped at Pikeville to visit the colorful owner, doctor, lawyer and Judge **Jack TERRELL**.

Judge TERRELL's influence is still felt once you walk inside the living room, where he lived and worked for 43 years, 1839-1882. You'll notice the wide original planking on the walls and floor, the judge's chair, and many of his books on the library shelves reaching almost to the ceiling. Some of

his favorite pictures are still on the wall.

Besides being judge of Marion County nearly a half century, **Jack TERRELL** was a licensed physician. he rode his horse all over Marion County administering to the sick without charging a fee. He earned his livelihood as probate judge, and his non-paying patients always saw to it he was re-elected.

Mrs. **Rose Melton**, great-grand-daughter of the doctor-judge, owns and lives at Pikeville now. She has made a few changes in the old house. The two open fireplaces from the old rock chimney in the center of the house have been closed and butane heat installed. She has added siding to the outside of the house and build new columns on the front.

Legend has it among few of the old-timers remaining in Pikeville area that they still hear the doctor ride up at night, hitch his horse out front, and stomp in the living room to try a county case.

John Dabney TERRELL was probably either father, or grandfather of the above Judge **Jack TERRELL**. I believe the archive lists the papers as those of **John D. TERRELL**, not **Jack**. This is the first time I have heard of the judge being referred to as **Jack**.

As a matter of interest, I have been through GUIN and PIKESVILLE many times, but always in an 18 wheeler with no time to stop and explore the TERRELL history. *DFB*

GEORGIA FEVER

Reprinted in *FIRST AMERICAN GENERATION, Terrell Genealogy*, compiled by **Mildred TERRELL Thiele** and her daughter, **Exteen THIELE Morgan**, included is a letter written by **Edward BUTLER**, Revolutionary Soldier, to his brother-in-law, **John SHACKELFORD**, also a Revolutionary Soldier, of Halifax County, Virgin-

ia, published in **ROSTER OF REVOLUTIONARY SOLDIERS IN GEORGIA** by McCall:

Hanover, 12 June 1783,

Dear Sir: This leaves us in tolerable good health at present. Thanks be to God. How long we may continue so, I cannot tell, as we have a strange disorder raging in these parts at present. Some say it is not fatal, but only the effects of frenzy and imagination (but this I know, it is very catching). The effects of it are as follows (not only men, but women feel the effect of this disorder). They are at first somewhat thoughtful and melancholy, and after some time, appear pretty cheerful. Then appear to be in a frenzy, and after turning around a few times, they stand still with their faces somewhat towards the South, and then you will hear them utter with a loud voice: "GEORGIA." Was this word repeated only for a day or so, and then something else, I would not think much of it, but this is the last you hear at night and the first in the morning. It is called here the GEORGIA FEVER. Not all the sleep nor dreaming will make them repeat any other word. At our last Court, there appeared to be half the people there with the symptoms on them, but I expect if we have a good crop of corn, etc. this fall, which is promising at present, it will cure some of us. I, myself though laughing at the rest, still find others (I mean the home party) laughing at me. But - enough of this -- Let us turn now to serious matters. MR. **WINGFIELD**, his son **GARLAND**; **William TERRELL** and **PETER**, have been to Georgia this Spring and have purchased land at 10 and 12 Sterling per acre, in the new purchase in the neighborhood of Washington* Town, and also for several others of their acquaintances. I would not consent to go with them expecting great bargains would be sold in lands here. To which end I have ever since last winter offered my lands very cheap in comparison to what others ask that intend to move, but it seems now as if I should be caught at it, as I have an offer for my land and if I sell, I sup-

pose I must go to GEORGIA, too. If I sell my land, I shall go off this fall, pack and package. If I do not, I shall go myself. As Mr. **FALKNER** once said of Caroline and Halifax, we will have HANOVER in GEORGIA! Should be glad to have a line from you by the first opportunity as I want to know respecting the treaty with the Indians at Georgia, as I expect much depends on that. If Col. **LEWIS**, of your county, has not made up his complement of families to fill up his grant, and you think it worthwhile, get me down on the list. I want a thousand acres of land, if to be had. Let me know by the first opportunity, also when you intend setting off. I have advertised your land here agreeable to your ticket by Mr. **PATE**. I have no more to add, but our love to Sister and children, and remain Your Friend, etc., **Edward BUTLER**

This letter is followed by "At a court held in Hanover Co, VA, Nov. 6, 1783, the court being informed of a law passed by the State of Georgia requiring any persons emigrating from other states in the Union to the said State of Georgia, before they become citizens of the same to bring with them a certificate from the court of the county where they reside, of their being good citizens and, a friend to the rights and liberties of America. **EDWARD BUTLER**, who informs the said court of his intention of moving himself to the State of Georgia have desired a certificate of the same. Therefore, this court does certify that the said **EDWARD BUTLER** hath been long an inhabitant of the said County of Hanover, VA, and hath conducted himself in every instance as a good and worthy citizen, and uniformly given, undeniable of his attachment to the cause of America, and the Independence thereof." signed by **Richard CHAPMAN** LT. H. CO, **Thomas TRAVILIAN**, **William JOHNSON**, **Park GOODALL** and **George CLOUGH**."

And hath such shape, form and marks as appear by the plat thereof, hereunto annexed: Together with all woods, under-woods, timber and timber-trees, lakes, ponds, fishings, water-courses, profits, commodities, appurtenances and hereditaments whatsoever, thereunto belonging or in anywise appertaining: Together with privilege of hunting, hawking and fowling in and upon the same, and all mines and minerals whatsoever; saving and reserving, nevertheless, to us, our heirs and successours, all white pine trees, if any there should be found growing thereon: And also saving and reserving, nevertheless, to us, our heirs and successours, one tenth-part of mines of gold and silver only:

TO HAVE AND TO HOLD, the said tract of *one hundred fifty* acres of land and all and singular other premises hereby granted unto the said *John Terrill his* heirs and assigns for ever, in free and common soccage, the said *John Terrill his* heirs and assigns yielding and paying therefor unto us, our heirs and successours, or to our Receiver General for the time being, or to his Deputy or Deputies for the time being, yearly, that is to say on *the twenty-fifth* day of *March*, in every year, at the rate of three shillings sterling, or four shillings proclamation money, for every hundred acres, and so in proportion according to the *num^b*: of acres, contained therein; the same to commence at the expiration of *two*-years from the date hereof. *Provided always*, and this present Grant is upon condition, nevertheless, that the said *John Terrill his* heirs and assigns shall do yearly, and every year, after the date of these presents, clear and cultivate at the rate of *three* acres for every hundred acres of land, and so in proportion according to the number of acres herein contained; And Also shall and do enter a minute or docket of these our letters patent in the office of our Auditor-General for the time being, in our said Province, within *Six* months from the date hereof; And upon condition, that if the said rent, hereby reserved, shall happen to be in arrear and unpaid for the space of *Three* years from the time it shall become due, and no distress can be found on the said lands, tenements, hereditaments hereby granted; or if the said *John Terrill his* heirs or assigns shall neglect to clear and cultivate yearly and every year at the rate of *three* acres for every hundred acres of land, and so in proportion, according to the number of acres herein contained, or if a minute or docket of these our letters patent, shall not be entered in the office of our Auditor-General for the time being, in our said Province, within *Six* months from the date hereof, that then and in any of these cases, this present Grant shall cease, and determine and be utterly void; and the said lands tenements and hereditaments hereby granted, and every part and parcel thereof, shall revert to us, our heirs and successours, as fully and absolutely, as if the same had never been granted.

Submitted by **Bea Crouch** from *THE BATSON FAMILY in Virginia North Carolina and Georgia, Mississippi, Louisiana and Texas* published in 1959 by the author **Vivian Davis Bornemann**; 4719 Cartier Ave; New Orleans 22, LA. Related families include: **DALE, LOTT, HATTEN LONGINO; CULPEPPER; DAUGHDRILL; PRICE; DAVIS; SMITH; & TERRELL**. The book is not indexed, but Mrs. Crouch has read it extensively and assures us that all the TERRELLS and descendants are on the pages submitted. As far as we know, the book is out of print. You are very fortunate if you locate one.

Editor's Note: The book is a typed two column publication. Pages 55 --76 contain information on the **BATSON/TERRELL** families. This is too much material for one issue. Part One, here, includes the **TERRELL** information from pages 75 & 76. Future issues will include the descendants of **Nancy TERRELL** and **Seth BATSON, Jr.** The material has been retyped to conform to Trails format with capitalized surnames, etc. *DFB*

Editor's Note: Due to the missing child, I checked *Terrell Genealogy* by **Emma Dicken** to see what she wrote about **Moses TERRELL**. On page 252, I found the following. "The census of Amite Co. Miss in 1850 gave a **John TERRELL** aged 55, a

schoolmaster b. in GA. His wife **Sarah** aged 43 was b. in SC. We do not know that he was the son of **Moses TERRELL**. Children: **Mary S.** aged 22; **Griffin F.** aged 20; **James A.** aged 18; **William A.** 14 yrs.; **E. J.** 11 yrs; **Sarah D.** 5 yrs; **Frances A.** 2 yrs." If **Mrs. Bournemann** found documentation proving that this **John** is the son of **Moses**, she did not share it with us. Also, the 1850 census does not show family relationships. Even though these were in the household of **John TERRELL**, this census alone is not proof that all the children listed were born to **John & Sarah**. *DFB*

Micajah TERRELL serv. in the Amer. Revolution, sgt., Army, with Capt. **ROWAN** at Camp Belton. He signed the CUMBERLAND ASSOCIATION in 1775; came to MS ter. 1801. (Ref: NC Dept Archives & Hist., Rev. Army Accts., Vol. 1, pp. 23, 27, 128, canceled vouchers Nos. 3957, 4597, Wilmington Dist. NC Military Records). He had a large family. His son **James** was ancestor of **Nancy TERRELL Batson**.

NC 1st. **Isabella MC KAY**, d/o **Archibald & Katherine MC KAY**, widow of **Jack BLOCKER**. He m. 2nd **Amanda EDWARDS** in Williamson Co. TN. They were in MS ter. in 1802; **ROWLAND's Hist of Mississippi**.

He became an official Printer for Mississippi Territory in 1802, under Gov. **CLAIBORNE's** Rule; was a prominent Merchant and substantial Planter." On p. 384, **ROWLAND** [see *NOTE*] states: "The Gov. orders the Treas. Gen'l., to pay **James TERRELL** for Printing, \$140.00". The first set of Law Books compiled and used in Pioneer Miss. Ter., called *Toulmin's Digest*, was printed by **James, Timothy** and **Samuel TERRELL**, brothers. On p. 425, Mr. Rowland states that "the printing of the Digest was finally completed in Natchez by **Samuel TERRELL**, Sept. 1807."

NOTE: The "**ROWLAND**" she refers to is **Dunbar ROLAND**, author of *History of Mississippi*, S. J. Clark Pub. Co., 1925. He also wrote *Encyclopedia of Mississippi History*. I am not sure to which book **Vivian DAVIS Bornemann** refers. *Bea Crouch James TERRELL* operated his Print Shop at Washington City. The great feet of America trod upon the soil of that little village. The settlers who were pouring in, congregated (at first) in that area; they had SPANISH GRANTS, BRITISH GRANTS, and even GEORGIA, who claimed "the right of soil", gave some GA GRANTS. Two Dist. Ld. Offices were set-up, "one E. and one W. of Pearl River", and a Special Board of Examiners had to be apptd. to examine and adjudicate the conglomeration of Claims.

The Miss. pioneer **BATSON** Family were not too far away from there; the **BONDS** also; the **DAVIS** Family lived straight E. in Perry Co.

In the frontier days, horses with their "four-horse-wagons", were tied-up around the Old Courthouse; men were seen with hair looped together at the back of the neck with bow-of-ribbon, while some let it hang loose shoulder-length. A few men wore lace at their wrists and throat, but many wore belted-tunic-

shirts and pants-to-the-ankle, made of soft deer-skin. Often their feet were clad in deer-skin moccasins. They did lots of walking and comfort was necessary. Many of these men still wore knee-length breeches.

They were of the white race, but mixed-in with the group who tied-up at the Old Courthouse, were full-blood Indians and some half-breeds, trying to thrash-out their affairs thru interpreters, or with what little English they could mutter. The people E. of Pearl River were complaining loudly about the distance they had to travel TO GET MARRIED; In 1811, Wm. Flood was sent to the "Parish of Villochy", to appoint Justices at various places, at which time he apptd. **Jacques LADNER** for Justice in the area of Hancock Co., Miss.

At that time Mr. Flood left a set of **TOULMIN'S DIGEST** (Law Books) with Mr. **LADNER**, to accommodate the people who wished to oblige themselves. Probably because he lived in a thickly populated area, at that time, Mr. **LADNER** placed the Books in the home of **James DAVIS Jr.** (born before 1775), who lived on **Black Creek**, in Perry Co. These books passed to his son **James DAVIS III**, b 1813, (wife, **Jane SWETMAN Davis**), then to their son, **LeRoy Thomas DAVIS** (wife **Amanda BATSON**), then to their son **Walt DAVIS** of Perkinston, Miss. **Nancy TERRELL's** father, **James TERRELL**, had helped with the printing of the Books.

Amanda BATSON, was the daughter of **Nancy TERRELL** (Mrs. Seth Batson).

Many people living in 1959, will recall the set of Old Law Books, posing upon a shelf in **Walt DAVIS' General Merchandise Store** at Perkinston, (now **DEES Store**), at the beginning of the 1900's, where he enjoyed looking-up matters of litigation and jurisprudence for his neighbors; he could put his finger right on what he sought, for Mr. **DAVIS** often sat in his little store-office, reading the books late into the night.

The girls-in this family "liked to- dress, and have pretty hats". Grandma **Nancy TERRELL_Batson** always boasted "about her folks had an old family skutchin", (Coat of Arms), and for some reason, the origin of which has been lost by now, 'the very definite date of August The Second, was a day when every person possessed of the TERRELL Blood, "WAS COMPELLED TO ACCOMPLISH SOME GREAT AND FINE DEED!" When asked Why she replied* "The Terrell's Have Been Pledged To It, For 700 Years, because **Walter TERRELL** Did His Good Deed For The Day on AUGUST THE SECOND!"

She didn't know who he was - and neither do I, but this should be a challenge to those of Terrell Heritage, to search-out why this old custom has lived down thru the Terrell generations - - it may have a meaning, and therein may lie a clue to the family's origin, for it was about that time (1100 A. D.) that family-last-names were in process of formation.

Editor's Note: **Nancy TERRELL** may have been a Mississippi printer's daughter. She may not have known how to read, although I find that unlikely for a printer's child, either girl or boy. She and Mrs. Bornemann may not have known what **Walter TERRELL [TYRRELL]** did, but there are few, if any today who do not know that **Walter TYRRELL** was accused of killing **King William Rufus** in New Forest in a "hunting accident" on August 2, 1100. *DFB*

Note that the mother of **Edward A. WILFORD** was also born in PA and could have been a sister to Esther. Maybe something in this will give you a clue for further research. *DFB*

Looking for information on **William Nathan DICKS**, a Quaker who attended at various times the New Garden and Springfield Meetings in North Carolina and the South River Meeting in Virginia. Born in 1762, William married **Agatha TERRELL** (daughter of **Micajah & Sarah TERRELL**, founders of the South River [Lynchburg] Meeting) in 1787.

They had four children, and moved back to Virginia around 1793. A 1795 Lynchburg newspaper contains an advertisement of William's Windsor Chair making business. William died in December 1798 (recorded at New Garden MM, but his estate was located in Campbell County [Lynchburg] Virginia). It seems that **Agatha** moved back to the New Garden MM in 1800, and she stayed until 1811, when she returned to Lynchburg for a couple years. After selling off some property in 1814, she moved out west to Ohio.

Any information on **William DICKS** or the DICKS family (land records, houses, tax records, etc.) would be greatly appreciated.

Hi Don, I'm looking for information on **Curtis TERRILL**, son of **Nathan TERRILL, Jr.** and **Dorothy PHELPS**. Specifically, date and place of death.

Phebe TERRILL, Curtis's wife may be the person on the 1820 Clinton, Knox Co., Ohio census. From reading message boards, it appears that **Curtis** owned land in Knox Co., Ohio. Since his son, **Ira Curtis** was born in 1820, then Curtis would probably have died between the conception of Ira Curtis and the 1820 Knox Co., census.

I know that this isn't your line of TERRILL's, but I thought I'd see if you had any information. Thank You, **Jean L. Tvrdy** jlmmurray59@juno.com

Jean, While I do have some Ohio Terrells (etc) charted (mainly because they became geographically mingled with some of my Virginia Terrells), I have nothing on your Curtis or Ira Curtis TERRILL. Perhaps Dan Brinson, editor of our Society's quarterly magazine "Terrell Trails" could publish a query. Don C. Terrill (with the Terrell Society of America)

Dan, I have provided you cc copies of an ongoing discussion of whether or not **Edward Young TERRAL** was a Revolutionary Soldier. This is the family whose earliest traceable origin is Cheraw Dist., S.C. A couple of researchers have tried to connect them to **Richmond TERRELL** of New Kent Co, Va., but all such posted connections are bogus. They MAY be connected, but there are no believable theories.

In the attached letter, **Emry McNeil** (a researcher) seems to be saying that Edward is a R. S., but the "proof" he offers seem to prove the opposite. Assuming that he was a militia private in **1772**, this would not be qualifying. D.A.R. application records (according to McNeil) show several applicants, but none seem to be listed as members. (This confirms my own information.)

I suspect that **Edward Young TERRAL** may be listed as a Revolutionary Patriot for some sort of non-military service, but I don't have any evidence one way or the other. Don

Don,

I found your web site and see that you are the President of the Society. I was a bit standoffish as I have had some problems in the past sharing my research with others. On a couple of occasions, people have put my work on their web-sites just as if they had done the research. In another instance there was a man trying to get my information while he was employed by others as a genealogist.

While visiting the South Carolina Historical Commission in Columbia, I photocopied pay records for **Edward TERRILL** for 75 days service as a private in the South Carolina Militia in 1772. While in Washington DC on business, I visited the DAR headquarters where I photocopied page 2904 of the DAR *Patriot Index, Centennial Edition, Part 3*. This lists **Edward Young TERREL**, Private SC, born July 10, 1765, SC; died 1833 MS, married **Artalissa STEPHENS**. All I found about members based on EYT was a pending application by Mrs. **Eula TERRAL Julian** filed in 1953. It didn't list her as a member. Their record keeping leaves a lot to be desired. I made family contacts to find the following:

I have copies of DAR membership papers of No. 507770, **Marnell Brockman Livingston**, Pine Bluff, Arkansas and No. 539011, **Celia Carter Muths**, of Gulfport MS. I also have group sheets that reference to NSDAR No. 418610, **Eula Terral Julian** and NSDAR No. 458470, **Mary Terral Carter** (mother of **Celia Carter Muths**), all of which are based on **Edward Young TERRAL**, Pvt. SC.

In the book, *History of the Old Cheraw's* by Reverend **Alexander Gregg**, D.D., page 413, he lists **Edward TERRELL**, Private in 1772. Below him is listed Lt. **James TERRELL**, Barton's Regiment at Long Bluff and Lt. **Samuel TERRELL**. I have copies. James and Samuel are listed as uncles of EYT on the family group sheet. Edward's father was **Joshua TERRAL** and his grandfather was **William TERRAL**.

In *Memories of Mississippi* by the distinguished historian, **Dunbar Roland**, founder and first director of the Mississippi Department of Archives and History, there are many pages concerning the **Terral** family of South East Mississippi. EYT is listed as a Revolutionary War veteran. EYT's grave is in the "Old Salem" Cemetery near Vossburg, Jasper County, MS. It is marked with Revolutionary Veteran's stone. I have been told that it was placed there by the DAR. You can see that there is no doubt that my Great great great grandfather, **Edward Young TERRAL** was a Private in the South Carolina Militia, Revolutionary War. He went by the above spelling and that is the way it is spelled on his grave stone.

I hope this will be of some help to the Society.

Dear Don, I just got my newsletter and would like to share my documented info about **Edward Young TERRAL's (TERRILL)** Revolutionary record. He did in deed serve in the Revolution. His record can be obtained from the South Carolina Archives in Columbia, S.C. Claim no. 589 , Liber O. He served

for 75 days in the militia in 1782. Also his grave marker at Vossberg Cemetery in Jasper County states this record. I went in DAR on this record. I have done research on the family and will be glad to share what I have or exchange with people.

[From a TERRELL-L posting] I have been researching my TIRRELL ancestors in Northamptonshire, England. Unfortunately, parish registers for Wilbarston where they lived stop at 1749, so I can't prove where my oldest known ancestor was from. I've been asking around to see if there would be an interest in a Tyrrell/TIRRELL/Terrell and variants DNA surname project. This would involve males bearing one of the Tyrrell surnames. They would only need to use a swab on the inside of their cheek and return it to a chosen lab for analysis. I would be particularly interested in seeing if my TIRRELLs, who came to the US in 1914, are related to the TIRRELLs from Weymouth, Massachusetts who immigrated much earlier. Solomon was the son of **William TERRELL** and ___ **ACUFF**. Unfortunately, William's ancestry is still one of the unsolved mysteries of Terrell genealogy. Neither I nor other North Carolina researchers have yet figured out where he connects with other Terrells. Solomon was a very early settler in Kentucky, and appears in the 1810 census in Knox Co (p. 75). During lunch I went home and looked up your **Richmond TERRELL** on my database. I'm afraid that I have little to offer regarding Richmond's ancestry (listed as **James TERRELL**). I am, however, sending my listing of the descendants of Richmond TERRELL. From the source list (Endnotes) you can pick up the names and addresses (if known) of a few other researchers of this line.

From census records we know that he and his wife, **Patience**, had 10 children – 4 boys and 6 girls. Until now, I've had record of only two of those children: **John McTERRELL** and **James TERRELL**.

Your **Elizabeth** is new to me, and I would be interested in any information that you would care to share.

You will be interested to know that there was a **Celia Elizabeth DELKE** (1826-1883) who was one of the three wives of **John McTERRELL**. They had a son **James Richard David Batey Flemming TERRELL**, b. 24 Jul 1852 in Liberty Co, Ga.

I have substantial information on this line; however, we have never been able to figure out where this line connects with **Richmond TERRELL** who immigrated to Virginia in 1656. A couple of people have posted some theoretical connections, but they are contrary to known data. We'll make the discovery eventually (I hope). I saw your query in *Terrell Trails* newsletter. Although I have so far been unable to connect your TERRELL clan with the Virginia Terrells whose descendants constitute most of the Southern and Southwestern Terrells, here is what I have discovered.

William TERRELL (b. 1849) seems to be in the 1880 census, Arkansas, Columbia Co, Boone Twp. p. 151C. I cannot find him in 1870, but in 1860 I think he is in South Carolina, Chester Co, Cedar Shoals, p. 56, as the son of **Nelson** and **Lydia TERRELL**. In 1850 **Nelson, Lydia**, and son **William** are in North Carolina, Union Co, p. 47. **Nelson** is from South Carolina, but I do not know where he connects to the few Terrells who were living in South Carolina prior to 1850. A collateral source says that Lydia is **Lydia HORTON**. Don C. Terrill

Dear Don,

I had about given up on this family - you are the first ray of hope in months - **William** died in Arkansas in 1908. I think his middle name was **Hollis**. He was married to **Nanna Adeline GLADDEN** from S.C....they both died in Pike Co., Ark. His father was (?) **Avery Nelson TERRELL** from N.C. (?) and his mother was **Lydia Ann HORTON** dau. of **Hollis HORTON** and **Molcey JONES** of Union Co., N.C.

I was communicating with a man for a while and the messages stopped. I finally got on the phone and called 12 people with his name all over the US until I found him, only it was his wife. He had died and she knew nothing - just that he was doing family research...

It is about a 90% sure thing that **Avery Nelson TERRELL** was descended from **Richmond TERRELL** who arrived in Virginia in 1656. The problem is the absence of surviving colonial (and early U.S.) records which tell us how parts of this early family were connected. "Avery Nelson" is a very unusual (uncommon) name for a TERRELL. The last **Avery TERRELL** in this line died in 1545; although the father of your Avery Nelson TERRELL would have no knowledge of that fact. Of all the Southern TERRELL clans, the North Carolina branch has the biggest gaps in surviving records and information. These people pop up in southwestern states without leaving a clue as to their kinship. We can only hope that a surviving family Bible will turn up. I've been through the D. A. R's records, but found little in the way of surviving North Carolina TERRELL family Bibles.

Nelson, however, indicates in the census that he was born in South Carolina. Pre-1850 there were only two dominant South Carolina TERRELL clans. One preferred the spelling TERRAL. Most of the other migrated to Alabama and Mississippi, with only a few staying behind. There were probably a few other Terrells who lived in S.C. only briefly, and Nelson maybe tied to one of those. We can often tell the family connection by the tendency of families to migrate in groups. There are no TERRELL neighbors for Nelson TERRELL.

I'm sorry I cannot offer more. He is one of my unsolved mysteries. If you need a transcript of the census information that I described, please provide me a postal address and I will mail it to you. Don C. Terrill
