The information in this portion is from the database maintained by our Society president, Mr. Don C. Terrill. Other parts in later issues will contain the known descendants of Anthony M. TERRELL. That work is mostly information supplied to Don C. Terrill and the Society by Mrs. Nunnally and her cousins. Numbers in ^{super-script} following names refer to end notes indicating where Mr. Terrill received the information pertaining to that person. *DFB*

He married **(1) Willey TALLEY** 30 Oct 1817 in Halifax Co, VA. She was the daughter of **Daniel TALLEY** and **Mary Mickey Elizabeth MAC KEY**.

Generation No. 2

2. **Richard C. TERRELL**^{2,3,4,5,6}, born ca. 1750 in Virginia; died ca. 1797 in Halifax Co, VA. He was the son of 4. **William TERRELL** and 5. **Martha Cox**. He married 3. **Elizabeth ?**.

3. Elizabeth ?

NOTE: John A. Terrell, Jr.: Richard and Elizabeth resided in Pittsylvania Co, VA, and moved to Halifax Co, VA, in 1796.

- iv. **Elizabeth TERRELL**, born ca. 1782.
- v. **James TERRELL**^{16,17,18}, born ca. 1788 in Pittsylvania Co, VA; died ca. Dec 1850 in Caswell Co, N.C; married **Mary Emichael Elizabeth MacKey TALLEY** 19 Jan 1809 in Halifax Co, VA; born ca. 1794 in Halifax Co, VA; died 1857 in Caswell Co, N.C.
Powers (quoted by Wayland) claims to have found James TERRELL in the 1850 census of Caswell Co., N.C.; however, this researcher has made two thorough searches of that census and cannot locate him, nor is he indexed.
- 1 vi. **Anthony M. TERRELL**, born ca. 1790 in Virginia; died 20 Dec 1870 in Marshall Co, Ala; married **Willey TALLEY** 30 Oct 1817 in Halifax Co, VA. .

Generation No. 3

4. **William TERRELL**^{19,20,21,22}, born between 1730 - 1732 in Caroline Co, VA; died 1797 in Caroline Co, VA. He was the son of 8. **James TERRELL** and 9. **Margaret WATKINS**. He married 5. **Martha COX** before 1753.

5. **Martha Cox**, died before 1797. She was the daughter of 10. **William COX**.

William's will, dated 1792, was proved in court on 26 Jun 1797 *Terrell Genealogy* by Dicken, pp. 279-284):

The Will of William TERRELL

I **William TERRELL**, of Halifax County being of perfect sense and mind do constitute and ordain this to be my last will and testament in a manner and form following it is my wish and desire for all my Negroes to be valued and divided into ten parts equally.

Item. Give as follows one part to my son **Richard TERRELL** to him and his heirs forever.

Item. And give to my son **William TERRELL** one part of my Negroes and his heirs forever.

Item. Give to my daughter **Martha TERRELL** one part of my Negroes to her and her heirs forever.

Item. And give to my son **Joseph TERRELL** one part of my Negroes to him and his heirs forever.

Item. And give to my daughter **Nancy Childress** one part of my Negroes to her and her heirs forever.

Item. And give to my son **James TERRELL** one part of my Negroes to him and his heirs forever.

Item. And give to my son **Timothy TERRELL** one part of my Negroes to him and his heirs forever.

Item. And give to my daughter **Elizabeth TERRELL** one part of my Negroes to her and her heirs forever.

Item. And give my stock of every kind and household furniture to be equally divided between **James TERRELL, Timothy TERRELL, Martha TERRELL, Elizabeth TERRELL and Franky TERRELL**. It

is my wish and desire that my Negroes be lotted off into ten lots as equitably as possible and drawn for by the Legatees as how they may direct to prevent any disputes amongst my children. I wish and desire for a division to take place within twelve months after my death and if it should not be convenient for all the legatees to attend the division, I appoint my son **James TERRELL** to act for them in the division, also appoint him one of the dividers of my estate and any two others as the legatees may choose, but if any of the first mentioned children should be without a lawful begotten heir of his or her body, then that part of my estate that is allotted to him or her shall be equally divided amongst the above mentioned children. This is my last will and testament revoking and disannulling all will or wills heretofore made. In witness whereof I the said **William TERRELL** have hereunto set my hand and seal this twenty-second day of October in the year of our Lord Christ one-thousand seven-hundred and ninety two.

The Will of Joseph TERRELL

Georgia, Elbert County

Know all men by these presents that I **Joseph TERRELL** of the County and State aforesaid to this seventeenth day of April in the year of our Lord one thousand eight hundred and twenty-six, make this my last Will Testament Revoking all others heretofore made -- Item 1st. I give to my Son **William Cook TERRELL** the following named Negroes, viz, Hampton and Redon and two horses, one cow and one feather bed and furniture, already given. Second, I give to my Son **Joseph Reed TERRELL** a Negro Woman by the name of Lucy, with her present and future increase. Also one horse, three cows, four sheep and one bed and furniture already given. I give to my Daughter **Sarah Capell**, Darkies Beake and Gilda with all their pre-

sent and future increase, also two beds and furniture, one horse saddle and bridle and two cows already given. I give to my Son **James T. TERRELL** a Negro boy by the name of Caleb and one bed and furniture and two cows already given. I give to my Daughter **Margaret TERRELL** a Negro woman by the name of Julia and her children by the names of Taney & Moses and her future increase, also a Negro girl by the name of Filidy with her increase and a Negro boy by the name of Joshua, two beds and all her furniture, one horse and saddle and bridle, two cows and calves, the saddle and bridle already given. I give to my Daughter **Betsey Ham** a Negro woman by the name of Delia and her increase, also a Negro boy by the name of Daniel and, a Negro boy named Solomon, two beds and furniture, one horse saddle and bridle, two cows and calves, six sheep, already given. I give to my son **John W. TERRELL** a Negro woman by the name of Charity and her three children, to wit, Eliza, Lee and Marica, one bed and furniture, also one white counterpin[?] and one pair of sheets, two cows and calves, and five sheep, and one horse, and one yoke of oxen, already given. I give to my grandson **Jabez Batton Capell** a Negro girl by the name of Carrotine and her increase, except that her first living child that may be alive at the time of said grandson becomes twenty-one years of age, which Negro I wish and do hereby give to my granddaughter **Louisa Capell**. My other Negroes and all my plantation tools, household and kitchen furniture and stock of every description not already given and mentioned with the tract of land wherein I now live, all of which I wish to divide equally amongst my children. I do hereby acknowledge this to be my last Will and Testament. In witness whereof I have hereunto set my hand and affixed my seal this day and date above written. Lastly I appoint **Britton CAPELL** and **James T. TERRELL** executor to this my last Will and Testament.

Dicken: A James TERRELL reported for duty as a sergeant in Capt. **MERCER**'s military Company in **Geo. WASHINGTON**'s (Virginia colonial) Army on 9 Jul 1754, but we cannot be sure it was this James TER-

RELL.

This previously unknown will was located (ca. 1994) among the Miscellaneous Papers of Cumberland County's "County & Superior Courts, 1760-1850," at the Library of Virginia. This document provides proof of the sons of James TERRELL and identifies, for the first time, his daughters:

The Will of James TERRELL, Planter

In the name of God, Amen, I **James TERRELL** plant'r of St. Margarets Parish, & County of Caroline in the Colony of Virginia, am weak in Body but in a perfect Sense & memory, thanks be given to Almighty God. Therefore calling to mind the Mortality of my Body, and knowing that it is appointed for all men once to die, do make and Ordain this my last Will and Testament, that is to say, Principally revoking & disannulling all other Wills heretofore made by me; first of all I give & Recommend my Soul into the hands of God that gave it to me, and my Body to the Earth to be Buried in a Christian like manner; nothing doubting but at the general Resurrection to receive the same again by the might power of God; and as touching such worldly Estate wherewith it hath pleased God to bless me with in this Life, I gave and dispose of the same in the following Manner and Form, viz't.

Secondly. I lent unto my beloved Wife **Margaret** a Childs part of my Estate, be it in what place or of what nature or quality Soever, and after my loving Wife Margarets decease my will & desire is that part I lend her should be divided equally between my five oldest children, viz't **William TERRELL, Mary Herndon, my son James TERRELL, Betty Newton and Patty Hord.**

Thirdly. What I have given heretofore to my eldest son **William TERRELL**, being a full part of my Estate, to tedious to mention at this time, hoping he will take it kind enough of me, not being well able to give him any more of my Estate.

Fourthly. I give & bequeath to my son **James TERRELL**, the Tract of Land wheron I now live and my Still as it now stands, & also the fifth part of my Stock after my s'd Wifes part is taken out of my Estate, to him & his Heirs & Assigns.

Fifthly. I give & bequeath to my Daughter **Betty Newton**, one Negro wench named Janes, to her and her heirs and Assigns.

Sixthly. I give & bequeath to my Daughter **Patty Hord** one Negro wench named Fortune to her & her heirs and Assigns.

Seventhly. I give and bequeath to my son **John TERRELL** two hundred Acres of Land, lying on the north side of Muddy Creek in Cumberland County and five pounds of curr't money, to buy him some stock, to him and his Heirs & Assigns for ever.

Eightly. I give and bequeath to my son **Dudley TERRELL** two hundred Acres of Land lying on the south side of Muddy Creek in Cumberland County joining the s'd Land as I have given to my son **John TERRELL** and a fifth part of my Stock, to him and his Heirs & Assigns for ever. And the fifth part of my house hold goods after my s'd Wifes part, to him and his Heirs and Assigns for ever.

Ninthly. I give and bequeath to my Son, **Jonathan TERRELL**, three hundred acres of Land lying in Culpeper County, and the fifth part of my stock & household Goods after my s'd Wife's part is taken out, to him & his Heirs & Assigns for ever.

Tenthly. I give and bequeath to my **Daughter Neffe** one negro girl named Rose, and the fifth part of my Stock & house hold Goods after my s'd Wifes part is taken out of my Estate to her & her Heirs and Assigns for ever.

Leventhly. I have and bequeath to my Daughter **Mary Herndon** one negro boy named Charles, to her and her Heirs and Assigns for ever.

Twelfthly. Remembering from the beginning of my Will that all my just Debts & Burial Charges are to be paid before any division of my Estate made between my loving Children; also my Will and desire is, that if any of my aforesaid Children should be so disturbed at this my Will and Occasion Lawsuits to interrupt my

Will, that they him or her shall be paid by my Executors one Shilling Sterling and cut of from all other part of my Estate and the part of my Estate left them by this my Will should be equally divided between my Content-ed Children.

Lastly, I do appoint and Ordain my Son in Law **Thomas Hord** and my Loving Son **James TERRELL** Ex-ecutors to this my last Will and Testament.

In witness whereof I have set my Hand and fixed my Seal the eighteenth day of October, in the Year of our Lord Christ. One thousand seven hundred and sixty six.

Dicken: A. Mr. **Philemon TERRELL**, who it seems moved from Robeson County, N.C. to Liberty County, Ga. thence to Mississippi, left descendants living in Texas who claim descent from **James TERRELL**, son of **William and Susannah**. One of the family possesses a pair of silver knee buckles engraved with the initials "**J. T.**", which had been worn by his Virginia ancestor. Many years ago in writing of his ancestors, Mr. **Philemon TERRELL** of Texas, said that he had heard of three TERRELL brothers, **William, James** and **John** who were natives of Virginia. One he believed may have died without offspring, but the other two reared large families. **James** was his ancestor and he had sons, **Philemon**, his grandfather who moved to N.C., and he thought two others were **James** and **Edward**.

Compiler's note: As of 1986 Mr. **Lake E. TERRELL** [now deceased] of Sumter, S.C., was in possession of silver knee buckles which were said to have belonged to **Richmond TYRRELL** (b. 1624) ("*TERRELL Trails*," Fall 1986, p. 102). Could these be the same buckles? Lake is descended from **Timothy TERRELL**, son of **William TERRELL** and **Susannah WATERS** ("*TERRELL Trails*," Fall 1986, pp. 103-104).

Clarke: John's will (quoted next) was dated 8 Feb 1814 and probated in Caswell Co, N.C. in Jul 1814 (*Book G, pp. 21-22*):

The Will of John TERRELL

I **John TERRELL** of the County of Caswell & State of North Carolina being in perfect mind & memory tho in the decline of life calling to mind the certainty of death resign my body to dust from whence it came & my soul to Almighty God who gave it & as for my temporal property it hat pleased God to bless me with in this Life I dispose of as follows:

1st All my lawful debts & funeral expenses to be paid.

2nd I will and bequeath to my loving wife **Ann TERRELL** all my estate real & personal & stock with every other part not hereafter mentioned during life or widowhood.

3rd I will to my son **Jonathan TERRELL** fifty dollars.

4 I will to my son **Joseph TERRELL** fifty dollars.

5 I will to my daughters **Peggy TERRELL, Fanny TERRELL & Mary TERRELL** one bed & furniture each which they claim & one cow & calf each & also to my son **James TERRELL** one bed & furniture & sorrel mare which he claims & also one cow & calf & also my plantation whereon I now live at his Mother's death.

6th I will to my daughter **Lucy MURPHY** twenty shillings.

7th I will the balance of my property at my wife's death to be equally divided between my daughters **Betsy Herndon, Patsey Murphy, Peggy TERRELL, Fanny TERRELL, Mary TERRELL, Sally Murphy, Isabella MORE & James TERRELL** the balance of my estate not before mentioned at my wife's death. Also, I constitute & appoint my two sons **Jonathan & James TERRELL**, my sole esecutors of this Last Will & Testament. Nothing doubting their fidelity making void all other Wills hereto by me made in witness of the same I have hereunto set my hand this 8th day of Feb. in the year of our Lord 1814.

EDITOR'S NOTE: There is a controversy over the parentage of the following **William TERRELL** that may always be unresolved due to lack of surviving documents.

One theory (**son of Richmond and Elizabeth**) follows in this article.

Another theory is that he was the son of **William TERRELL**, merchant of London, England and brother of Richmond. This would make William **nephew to Richmond rather than son**. There are valid reasons for believing this theory. First, we do not know if the William TERRELL for whom Richmond claimed land for passage to Virginia was his brother (as many have assumed), his nephew (as supported by this theory), or another (yet to be discovered) William. Second, John D. TERRELL, Sr. of Alabama wrote to John Davis TERRELL that William and Susannah "married in New York City, then called New Amsterdam." The difficulty of travel between the colony of Virginia and what is now NYC in the 1670s make it unlikely that either William or Susannah were natives of the colony of Virginia --if this tradition is true. In those days a man usually courted and married a woman who lived within five miles of him. Furthermore, they usually married at either the home of the bride, the groom, or the nearest church.

The original theory, now discounted by most, is that he was the **brother of Richmond**. This would have made him over 50 years of age when he married Susannah. While not impossible, this was an era when few men lived more than 50 years, much less married and fathered this size family.

Regardless of which of these theories you accept, this does not affect the TERRELL ancestry above Richmond. It will make a tremendous difference in the maternal lines. *DFB*

The Will of Henry TERRELL

In the name of God, amen - I, **Henry TERRELL**, Sr. of Caroline County, Virginia, do make and leave these following lines, my last will and testament, as followith, viz.

I lend to my well beloved wife **Sarah Woodson** [*surname supplied by Lynch M. TERRELL*] during her natural life for the support of her, my children, and the rest of my family under her care five negroes named as follows: Golias, Daniel and Jacob, men; Bess and Fanny, women, and twenty five head of cattle and colts, twentyfive sheep, thirty head of hogs, and as much of my household goods and furniture and plantation tools as shall be thought needful for the support of her and my family under her care, by my executors and after her decease, the negroes Bess and increase and Goliah to be equally divided among my children by her, and the negroes lent and what lent her to be equally divided amongst all my children, their heirs, etc.

I lend to my wife during her natural life my home, house, plantation, and three hundred acres of and with adjoining the same; and further. It is my desire that my wife have under her care, and for her assistance toward the up-bringing and schooling of her children until they become of lawful age or marry, the negroes and land heretofore mentioned to them etc., and not to misuse or abuse any part or parcel thereof nor suffering it to be done. Second, I give to my son **George TERRELL**, his heirs and assigns forever at the age of twenty one years or marry all the land I had of my father and all the land I had of **Joel TERRELL** and all the land I had of **Roger QUARLES** that lies on the West side of a line to be run due North from mine and **Joel WOOLFOLK**, corner White Oak sapling by a great pine, the east side of a small branch or slash of Crooked Creek to mine and **Francis BURNETT**'s line; all of the above said land is in Caroline County, and two negroes and their Increase to wit; Wheeler, a man, and Margaret a girl and twenty five pounds current money (he not molesting, nor suffering it to be done by any under him, his mother in her privileges alone mentioned) and I give **George** and his heirs forever all the land I had of **Carl MC GEE**.

Third, I leave to be sold by my executors my water mill and two acres of land thereto belonging: my Smith's tools or box of files, seven hogsheads of tobacco, three in Hanover County in the hands of **Joel TERRELL**'s son **Henry**, and four at **CONWAY**'s, all the surplus parts of my estate as they shall think proper, and the money put into interest until the legacies become due.

Fourth, I give to my son **Charles TERRELL**, his heirs and assigns forever, at the age of twenty one years, all the remains of land I had of **Roger QUARLES** and my *Toping Castle* Plantation and all my lands thereunto belonging, and two negroes, Mancer, a boy, and Nell, a girl, and her increase, and twenty five pounds current money.

Fifth, I give to my daughter **Ursula TERRELL**, her heirs, and assigns forever three negroes

and their increase: Blackah, a woman, Simon, a boy, and Lymus, a boy, and twenty five pounds current money on the day of her marriage or lawful age.

Sixth, I give my daughter **Judith TERRELL**, her heirs and assigns forever when of lawful age or marriage, three negroes and their increase, Patts, a woman, Hannah, a girl, and Ned, a boy; and twenty five pounds current money.

Seventh, I give to my daughter **Abigail**, her heirs and assigns forever when of lawful age or marriage, three negroes and their increase: Polly, a woman, Tamer, a girl, and London, a boy; and twenty five pounds current money; and my desire is that if any of the above mentioned children die under age or not married, their part of the estate, as well land as other estate, be equally divided amongst my living children by my last wife their heirs and assigns forever.

Eighth, I give to my daughter **Ann Lynch** and her heirs forever, besides what I have given her before, one negro by named Abraham.

Ninth, I give to my daughter **Betty Moorman**, to her heirs, and assigns forever, besides what I have already given her before, one negro girl now living with her called Viles and her increase.

Tenth, I give to **Menoah CHILES**, Sr. - *bro. of his 1st wife Ann Chiles* - and assigns forever just as he hat devised in his last will one hundred and eighty three acres of land, part of the land I recovered of **John CHILES**; in consideration he, the said **Menoah**, his heirs and assigns performing faithfully the agreement made with **John CHILES** the 11th of June last, which one hundred and eighty three acres aforesaid are bounded according to the said agreement which is in my house.

Eleventh, I give to **John CHILES**, son of **Micajah CHILES** decease, to him and his heirs forever seventy acres of land or thereabout, it being the remainder of the land I recovered of him, be the same more or less, on the condition that the said **John CHILES**, his heirs and assigns pay to by executors for the use estate all the expenses I have been or shall be at in preserving and securing the said 250 acres which is given to the said **Menoah** and **John CHILES**.

Twelfth, I give to **Micajah CHILES**, son of **Micajah CHILES** deceased, to him, his heirs and assigns forever 375 acres of land I recovered of him on condition he the said Chiles, his heirs or assigns pay to me or my executors for the use of my estate all the charges and expenses I have been or shall be at in preserving and securing the same lands.

Thirteenth, I give to **Jonathan TERRELL**, son of **David TERRELL**, Sr. deceased, to him, his heirs and assigns forever the four hundred acres of land of the estate of **David TERRELL** deceased; if recovered by me or mine, he the said **Jonathan**, his heirs or assigns paying all the charges and expenses I have been or shall be at in preserving the said 400 acres of land for use of my estate; but if the said **Jonathan TERRELL** die underage, the said land to belong to his sister **Susannah TERRELL**, her heirs or assigns forever, she or they paying all costs or expenses as above; but if she die underage or before marrying, the said land to be equally divided between **Christopher and Rachel TERRELL**, their heirs and assigns paying all cost, charges and expenses as above mentioned.

Fourteenth, I give to my son **Thomas TERRELL**, his heirs and assigns forever, if he is now alive, if not to be sold by my executors and the money to be divided amongst all my children, their heirs and assigns forever, all my land in Albemarle County, Virginia, that lies above a great branch that comes down from a rich cove called Black Walnut, Barhat, a man, and Jane, a woman, and her increase, and forty five pounds current money, to be delivered and paid him, his heirs and assigns directly after the probate of my will.

Fifteenth, I give to my son **Henry TERRELL**, his heirs and assigns forever all the remainder of my land in Albemarle County if he is now alive, if not to be sold by my executors and the money to be equally divided amongst all my children, their heirs and assigns forever, and two negroes, to wit, Fran, and man, and Sonia, a woman, and their increase; and fifty pounds current money to be paid to him or assigns directly after the probate of my will if he is now alive.

Sixteenth, I leave, if they come, the goods I have sent for, for the use of my wife at least so many of them as my executors find convenient and the rest to be sold by them.

Seventeenth, I have a negro named Peter; if alive, to be hired out by my executors and the money put to interest until my son George come to age, and then to be divided amongst all my children, their heirs or assigns.

Eighteenth, I leave under care of my wife three negroes and their increase (for the time to come) to wit: Handy, a man, Lysey and Tamer, women; and my will and desire is if any of my five youngest children's negroes die before they possess them, that their loss, if possible, be made equal to them out of those last three mentioned or their increase; if not, to be equally divided amongst all my children, their heirs, etc.

Nineteenth, It is my will and desire that all my just debts be paid by my executors hereafter named.

Twentieth, and lastly, I do hereby appoint **Samuel HARGROVE**, **Henry TERRELL**, son of **Joel TERRELL** deceased of Hanover Co. VA. and my son **Thomas TERRELL** my executors of this my last will and testament. In witness whereof I have hereunto set my and seal this 26th day of 3rd month in the year of our Lord 1760.

- vi. **John TERRELL**^{71,72,73,74,75}, born between 1705 - 1710 in New Kent Co, VA; died Aft. 20 Sep 1783 in Franklin Co, N.C; met (1) **Elizabeth HARRISON** in Caroline Co, VA; born in Virginia; died in North Carolina; married (2) **Sarah ?** before 1741 in Caroline Co, Virginia.

John and Elizabeth were never married, and **John** was disowned by the Quaker church for living with **Elizabeth**. John Sr.'s family Bible does not list son **Richmond**, and his inclusion on this list is speculative (*see Dicken p. 277*).

Allen: **John** was called into court for his relationship with **Elizabeth HARRISON**. It was reported that he had taken Elizabeth into his home, even though he had a wife, **Sarah TERRELL**. [*Caroline Co Order Book 1737, p. 460*] Three children were born to John and Elizabeth out of wedlock. Each time, John and Elizabeth were tried by the court and placed under a bond of £50 not to meet. Even this did not stop them, and they left the Virginia Colony in 1738 [*Caroline Co Order Book 1741, pp. 41-42*]. The court was forced to bind out the 3 children to be raised by other families [*same, Order Book 1741, p. 437*]. They would be required to help with the family to pay for their upkeep. Finally, in 1749, **Sarah TERRELL** asked the court to allow her separate maintenance from her husband [*same, Order Book p. 425*]. **John** sold land in Caroline County in Mar 1741 (*same Order Book 1741, p. 93*) and in April of the next year (1742) the chancery court ordered **John** to place two Negroes, Beck and Amey, and one grey mare in the possession of **John MAULDIN**, in trust for **Sarah**. She was to "receive the profits from these for her maintenance during her separation and until she shall cohabit with the defendant or until the time of her death." [*same Order Book 1742, p. 100*]. It would have taken an act of the General Assembly to have granted her a divorce, but the county court

could grant her separate maintenance. **Sarah** was granted permission to take over her husband's estate because he had "fled the colony" with **Elizabeth HARRISON**. A number of the citizens of the colony of Virginia, who did not feel they could comply with the marriage laws of the colony, went to North Carolina to live.

From "*TERRELL Trails*" pp. 1076-1081 (Spring 1997), submitted by Mr. **James M. Allen Jr.** (Rocky Mount, N.C.), from N.C. Archives, Wilkes Co. Wills 1778 to 1948 (and printed again in his 1998 book):

The Will of John TERRELL

In the name of God amen I **John TERRELL** of the County of Franklin in the State of North Carolina being somewhat in Disposed in body but of perfect sence & Memory thanks be to God for his Mercies but knowing the frailty of human nature & that it is Decreed that all men must surely die do make & ordain this my last will & testament as followeth that I give & bequeath my soul to God who gave it & my body to the Earth to be Decently buried at the Discretion of my Executors & as to my worldly Estate:

I give and bequeath to my reputed wife **Elizabeth** who is called & known by the name of **Elizabeth TERRELL** with whom *I have Cohabitated ever since .. my furniture I desire is then provided 5 Negro slaves to wit Mingo big Jack old Saul Lidia & Willy also my Mill on Sandy Creek & all my household Furniture & such of my stock as she may think fit during her life & after her Decease to be Disposed of as hereafter shall be Decreed.

I hereby Nominate & appoint **Jeptha TERRELL & Joel TERRELL & Jenkins DE VANEY** Executors of this my last will & testament hereby revoking all other Wills heretofore made or Executed. In witness Whereof I have hereunto affixed my hand & seal this 20 Day of Septm. 1783 cs.

Notes for Timothy TERRELL and Mary Martin:

Samples: Marriage of **Jemimah** to **William REYNOLDS** is uncertain.

Wayland: Father of 14 children. Will dated and probated Feb 1763, Orange Co., N.C. The county seat of Orange was then called Childsburg, but later it was renamed Hillsboro, where his will is still on file. He was in VA. in 1741, when he witnessed a deed in Caroline Court. It is felt that he and his brother John moved to N.C. about 1743-44, probably after the death of their father. Timothy first settled in Bladen Co., where he petitioned for a grant of 600 acres 10 April 1745 (Colonial Records of N.C., Vol. 4, p. 764). Timothy was appointed by the Governor as a Justice of the Peace for Bladen at a Council held at Newbern 11 Apr 1749, was re-appointed 7 Apr 1750 and again 1 Apr 1751 (Vol. 4, pp. 951, 1046,1243, Colonial Rec.) Orange Co. was formed from Granville, Johnston and Bladen Counties, so he may not have moved. After his death, Orange was divided into Chatham, Wake and Guilford, which placed his home in Chatham, where some of his children lived. Land records show that the Earl of Granville granted Timothy 400 acres of land on 6 Sep 1754 on head branches of Terrill's Creek (Bk. 12, p. 49). He obtained other grants amounting to more than 2,000 acres, making him a man of wealth.

The Will of Timothy TERRELL, dated 9 Feb 1763

(from Orange Co, N.C., Will Book A, p. 29)

In the name of God amen. I **Timothy TERRELL** of the County of Orange and the province of North Carolina, Planta, being in my perfect senses and memory blessed by God for it I do this 1st day of February in the Year of our Lord 1763 do make and publish this to be my last will and testament of this my worldly estate in manner and form as follows -- that I have given to my Daughter **Jimimah** and my Daughter **Ruth** and my Daughter **Millin** and my son **Solomon** and my son **Micajah**, as much of my estate as I allot them. I give to my son **Nimrod** the plantation where I now live with part of the last survey I made in all to contain 350 acres,

he is not to molest his mother during her widowhood of the plantation or any part of the land. Likewise I give him a negro boy named Jack and my still, and a horse named Rock, he is not to have any of his estate till he comes of age -- I give to my son **Simon** 300 acres of land lying at the West end where I now live being part of two surveys and likewise I give him a negro boy named Roger, he is not to have it till he comes of age -- I give to my son **Simon** all the increase of a negro woman named Cate from this day and the remainder of that tract of land, that my son **Solomon** now lives on, he is not to have it till he comes of age. I give to my son **Moses** that tract of land at Deep river and all the increase that comes of a negro woman named Jinney he is not to enjoy ay thing till he comes of age -- I give to my daughter **Mary** a negro girl named Hannah -- I give to my daughter **Betty** a negro girl named Sarah -- I give to my daughter **Cozziah** a negro girl named Sussan -- I lend to my son **Daniel** a plantation on the last survey I made with part of the tract I live on, with part of another joining survey and if he has any lawful heirs to them forever or their assigns and if no such heir returns to **Nimrod** and **Simon**. I give to **Daniel** a mare named young Rone, bridle and saddle and I give him a bed and furniture and a cow and calf 260 acres of land lying east in Rowan County and I leave to be sold at Vendue likewise I leave 320 acres of land known by the name of *Terrell Richard* land to be sold at vendue. Likewise I leave my son **Richard** my great wagon. Likewise I lend the remainder of my estate until my beloved wife during her widowhood, for the support of her and her children and in case she marries to enjoy it no longer and after her decease or marriage for it to be divided into lotts and the lotts down for betwixt son **Solomon**, son **Nimrod** my son **Simon**, my son **Aron** and my son **Moses** -- I do appoint my friend, **John PILLS** and my wife two executors of this my last will and testament of this my earthly estate. Likewise I give my wife leave to give to any of the children that now lives with us, when they marry or comes of age, if there is any stock, as she can spare, to give them any part as she shall think fit or long-ing.

GENEALOGY? ASK DAN!

Q. My name is **Peter van Tarel** and I am living in Holland. My grandfather has done some research about our family tree. He ended up in 1650. Now I am looking where the name **TAREL** starts. It might be in France. I would like to know if my name could be linked to Terrell or other variations of them. Do you know if there is some proof of that? Do you have something like a family tree? Could you provide me information about my name please? I thank you very much. Peter van Tarel

A. We have many "family trees" that go from various individuals as far back as they believe they have proven their lineage. These vary from two or three generations to some who think they have the link back to Adam & Eve in the Garden of Eden. Personally, I am convinced the Adam & Eve chart is mostly mythology with no existing documentation to prove it. Unfortunately, most of these "trees" are in the possession of individual members. We do not have a comprehensive tree where we have attempted to combine them.

Our research deals with those who came to what is now the USA. These arrivals range from ca1635 to the present time -- latest that I have been informed of was 1948, but I am sure there are some that I don't know about.

We do not have any information on resources in Holland or any other foreign countries. Therefore, I cannot tell you who your ancestors were.

All I can give is some basic advice. Genealogy (family history research) begins with you and traces backward -- your parents -- your grandparents -- your great grandparents, etc. One should never begin with someone in history of a certain name

and try to trace the descendants of the person to prove that he/she is one.

In most cases the difference in spelling was due to choice of record keepers. For example, my oldest proven TERREL (that's right one L, and he could sign his name) d. ca1830 in GA. His grand children and great grandchildren of the 1880s after more of the general population learned to spell used two Ls and wrote it at TERRELL.

In the courts of our country, names that sound the same are considered to be the same regardless of the spelling. This does not imply that two persons of similar age, appearance, and same name are the same, but the government went to a lot of trouble in creating a "Soundex" index based upon the letters in the first 8 letters of a name. Consonants B, C, D etc., were assigned to groups of numbers from 1 to 6. They ignored double letters and coded them only once. D & T are coded 3, R is coded 6, and L is coded 4. All vowels, A, E, I, O, U along with Y which sounds like I, and sometimes either silent or combination of sound letters H & W were ignored and not coded. They kept the first letter, and coded the first 3 of the following letters that are assigned code numbers. Therefore, T is kept and r & l are coded making T64. Since there are no more letters with codes, a zero is added making T640. This will fit most of the TERRELL variations found in this country including TARL, TURL, TAREL, TARRELL, TYRREL etc. except TERRALD which technically codes T643 (the d on the end replaces the zero with a 3).

In your case, it is necessary to glean all the information you can about your personal ancestors from your living relatives. You need to learn as much as possible about them. Birth, when, where, to whom? Marriages, when, where, to whom. Death, when & where, where buried. As much as possible about their lives, where they lived, when, what they did, children's names, where each was born, etc.

When you run out of living relatives, turn to family bibles, deeds, any other court documents that chronicle their lives.

There is probably a Church of Jesus Christ of Latter day Saints (Mormon) in your city or one nearby. They have branches all over the world. Part of their believe involves finding out the names of their ancestors for use in Temple ceremonies. Therefore, they have amassed an unbelievable amount of genealogical data from all over the world. This is kept in or near Salt Lake City in the USA, but they have family history centers in most of the churches in larger cities. Volunteers in these branches can help you find out about any individual listed in their Salt Lake City main archive. They can order microfilm from the main archive that you can view in their facility. They have much of their information committed to CD-ROM that can be searched in centers with computers. Best of all, one does not have to attend the church or even be a Mormon to use their facilities. They share with everyone and will accept information from any family researcher. Usually a volunteer can listen to your problem (what you know, and what you desire to know) and suggest the next place you should look for info in your area.

Beyond the Mormon Church, I have no idea what might be available to you in Holland. I am confident that the government maintains many different types of records, but I have not idea where each different type is kept or how much of it is available to you.

In the USA, for example, birth & death records are kept by The Bureau of Vital Statistics and stored in local Health Department offices in the county where the birth occurred as well as in the State and Federal (US) Bureaus of Vital Statistics. However, only the person, a parent, or a sibling of the person can obtain a copy of a birth certificate. Death certificates are available to anyone for a fee, but the cause of death will be blacked out. Death records are compiled from information given by a living relative or friend who may, or may not, have accurate information so these should be viewed as information to be verified rather than accepted as fact. Marriage records are kept in county court

houses in the Probate Judge's office along with wills and estate divisions. Deeds and other records involving property are in the Circuit Court office in the county. Tax Assessor's office is helpful in finding current information about a certain piece of property such as where it is, how large it is, and can even provide an aerial photograph of the area containing the property.

Census records in USA are restricted for 80 years for privacy reasons. The only persons in the USA who can find themselves in the census records are those over 80 years of age.

I realize most the the above information is of little value to you -- unless one or more of your ancestors lived in the USA. However, you may be able to apply some of it to your search by determining where similar information is stored in the area where you and your ancestors lived.

The earliest use of the name that we have found was Ralf, Sire de Teril who lived on the Seine River near Paris France ca950 A.D. There is a village on the location today known as Triel, a transposition of two letters -- or so I am told. I have a cousin who lives in Paris and has been there. Also, I have another cousin who lives in the USA who has visited there.

Although we use the name in the masthead of our news letter, we do not claim that all TERRELL variations descended from him, or even that anyone living today is his direct descendant. We published an article in our newsletter a few years ago about a family who lived in Vaultravers in 1500s that Germanized the name to Vom (or Von) Graben, but there is no proof that they descended from Ralf.

At the time of Ralf, surnames were attached to individuals according to three things, either: where they lived, who their father was, or what kind of work they did. The most common was where they lived as in the case of Ralf. Each generation had a different surname as they moved and established estates. It was probably the late 1000s or early 1100s before persons started keeping the surname of their father and changing their first names.

Matters were further complicated by the fact that some nationalities started attaching prefixes to

names to indicate "son of." For example the Scotch put Mac or Mc in front of a name to indicate the son of another by the same name thus the son of Tyre became McTyre, etc. Some others put "O" in front so that the son of Toole became O'Toole. The Welch put "ap" in front of the name. Therefore Rice could become Aprice and since the A was not strongly pronounced, it often was mistaken for Price. Some nationalities still use dual surnames taken from both the father and mother as Vasquez-Gonzales, with the name of the mother first.

Before the late 1800s most (over 95%) of the general population was illiterate. They could not read or write their names. The few who could, some ministers, court clerks, census takers, etc. wrote names like they thought they sounded. This accounts for the many variations in the spelling of names as shown in the variations on our web page. I hope this helps. If you find an earlier use of the name, please share it with us. *DFB*
