MR. JACK ALLEN TERRILL PASSES

07/11/1919--01/14/2000

Shreveport LA -- **Jack Allen TERRILL**, 80, died Saturday, January 14, 2000 in Stuttgart AR while on a duck hunting trip.

Mr. Terrill was born July 11, 1919 in Selma, Grant Parish, LA and moved to Ruston with his family as an infant.

He graduated from Louisiana Tech in 1941 with a B. S. degree in Civil Engineering. He served as an engineering officer in the Army Air Corps during World War II.

Funeral services were held Monday, January 17, 2000 at 22:00 a. m. at Broadmoor United Methodist Church where Mr. Terrill was an active member since 1949. Rev. **Ed THOMAS** officiated. Burial took place at Forest Park Cemetery on St. Vincent Avenue. The family received friends immediately before the service.

He was preceded in death by his parents, **Charles & Irene TERRILL**, and his son **William Charles TERRILL**. He is survived by his wife of 52 years, **Frances**; two daughters, **Marjorie TERRILL Hodson** and husband **Mickey** of Summit NJ, and **Mary TERRILL Copeland** and husband, **Bud**, of Minden; one son **Steve TERRILL** and wife, **Christy**, of Shreveport; two sisters, **Doris TERRILL Hewitt** of Tulsa, OK and **Nan TERRILL Wibker** of Shreveport; and nine grandchildren; **Catherine TERRILL Hosea** of Goree, TX, **Charles Allen TERRILL, II** of Wichita Falls TX, **Christopher Michael HODSON** and **Elizabeth Claire HODSON** of Summit, NJ;

Kelly Marie COPELAND and **Lindsey Elizabeth COPELAND** of Minden; **David Layne TERRILL** and **Hillary Frances TERRILL** of Shreveport.

Mr. Terrill was a prominent member of the construction industry in Louisiana. He worked 38 years at Southern Builders, Inc. where he served as President and Chairman of the Board. He served two terms as President of the Associated General Contractors in Shreveport, as well as for the AGC State Council. He served 12 years as National Director of the AGC of America before being named a Life Director in 1985. He also served 14 years on the State Licensing Board for Contractors. One of Mr. Terrill's true loves was Louisiana Tech University where he was a Charter Member of the school's Engineering Foundation and was on the Board of Directors and a Privileged Director of the Louisiana Tech University Foundation. In 1966, he was honored as Distinguished Alumnus of Civil Engineering. During homecoming festivities this past fall, Mr. Terrill was recognized as Louisiana Tech's 1999 Alumnus of the year.

Pallbearers were **Jack GULLEDGE**, **Tommy FOLK**, **Tim DULANY**, **Christopher HODSON**, **Charles TERRILL**, and **Mike HOSEA**.

The family suggested that memorials be made to the charity of the donor's choice.

Mrs. TERRILL included the following information in addition to the preceding obituary.

Last year, he and his two sisters established an endowed scholarship at Louisiana Tech University in memory of their parents, to benefit a graduate of Ruston High School in whatever course of study he or she wished to pursue. After **Jack's** death, friends established an endowed scholarship in his name to benefit a Civil Engineering student, to be named by a committee from the School of Engineering.

Since 1978, Jack suffered two heart attacks, had by-pass surgery twice, and had lived with congestive heart failure for five or six years. He still loved to garden, fish, and hunt -- and lived life to the fullest that his condition would permit. He put his whole heart into everything he did.

On January 10th, we went to Ruston so he could make final plans for an "Old" Ruston High School Reunion (Classes of 1943 and before) which he instigated and chaired. Two years earlier, he planned and chaired a reunion of all who graduated from Old Ruston High == classes of 1939 and

before. They had such a good time they decided to have Reunion 2000, to include anyone who had attended the old school. That reunion took place in May with some of his committee members taking over.

Jack became quite interested in his TERRILL genealogy years ago and published the information. He distributed this to close relatives and to the SOCIETY for us to perpetuate through the LENDING LIBRARY.

He was unable to get farther back than his great-grandfather, **Goodrich TERRILL** who came to Louisiana in 1848.

Last summer, his cousin, Jimmy L. TERRILL and wife traveled to Virginia to try to find something on Goodrich's family and did so! Jack was elated that he could now trace his family back to England and Robert TYRRELL (1627-1683). Jack immediately contacted a person Jimmy had met in VA and another whose name he found in TRAILS. He put an addendum to his printed genealogy and distributed copies.

The following eulogy was presented by his son, **Steve TERRILL** at the funeral.

I was asked to speak on behalf of the family.

If you grew up with him, you probably called him "KID." If you knew him through work, you probably called him JACK or Mr. TERRILL. But, if you are family, he is PAPA.

I can't imagine a child growing up in a more stable environment. During Marjorie's, Mary's, and my entire lifetime, PAPA had one job, one wife, and one house. He worked at Atlantic Builders for 38 years. He was married to MAMA over 52 years and lived at 372 Atlantic for 50 years as of this month.

The way I used to describe PAPA to people was this, "He is the most honest man I know, but doesn't have very much tact." I believe everyone here knew that he wasn't one to keep his opinion a secret.

When talking about PAPA, two things that have to be mentioned are the construction industry and Louisiana Tech.

PAPA took great pride in the construction business, and believed that you should give back to the industry where you made your livelihood. He did just that through his work in the AGC, CSI, and serving on the State Licensing Board.

I first started estimating for PAPA in the summer during my years in college. I'll never forget his

estimating advice. He said, "At school, if you make 90% on a math test, you think you did pretty good. If you take off a \$10 million job and make 90%, we've lost a million dollars.

To this day as we drive through town, I will point out to my daughters prominent buildings around town that were built by Southern Builders. Each of my daughters' schools and the church that my family attends were built by Southern Builders. In fact, the last job that I worked on for PAPA was renovating this sanctuary.

As for Louisiana Tech, - oh how PAPA loved his alma mater. I am so thankful that he lived to receive his award as Alumnus of the Year for the University. It was well deserved.

While he loved the whole school, his true loves at Tech were the Engineering Department and the school's athletic department. Since Joe Aillet Stadium was built, nobody but Jack Terrill and Thomas Folk have ever owned tickets in box 39 on the west side. I don't guess I'll ever go to a game there without feeling his presence.

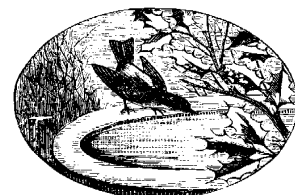
I'll let you in on a secret about PAPA. His bark was worse than his bite. He might fuss about trivial things, but when it was something serious of if you were really in a bind -- you always knew PAPA was there for you.

PAPA gave me only one piece of advice on parenting. "Don't ever do something that you said you're not going to do, and don't ever not do something that you said you're going to do." To the best of my memory, I don't remember PAPA wavering from that advice with his kids or in business.

In closing, I think it was only fitting that PAPA died while at the duck camp in Stuttgart. Either there or working in his garden.

How many of you think that by noon on Saturday that PAPA was already advising St. Peter on how the hinges on the Pearly Gates could work better if he followed PAPA's suggestions?

I don't know about that, but I'll bet you one thing. I bet PAPA already has a garden dug and knows when duck season starts in Heaven.

Confederate Papers Relating to Citizens or Business Firms [Terrells]

CONCLUSION: CONTINUED FROM LAST ISSUE

The actual collection consists of millions of loose papers accumulated by the Confederate Government in their dealings with civilians. Most of these papers consist of purchase documents relating to the procurement of food and supplies by the armies. These documents are often hard to read because of fading ink, bleed-through by ink, and overly-embellished handwriting. In most cases where a town (location) is named, no state is named. In the late 19th century the U.S. Government sorted these papers alphabetically, and they are now available in the National Archives as Record Group M346. The **Terrells** (shown here) are on Roll 1017.

Samuel Terrell vs. CSA [probably **Samuel L. Terrell**, b. 29 Mar 1821, son of **William A. Terrell & Hanna Sealy**, from "The Terrell Family of Marlboro County, South Carolina," manuscript by **Robert Davidson**, 1988 (unpublished)] A claim filed for \$26.00 for the use of his farm horse teams for 4 days. Claim filed in Franklin Co. Miss., Samuel was citizen of Itawamba Co. Miss. Claim filed Nov 1863. Claim is resolved by CSA Commissary Commission in his favor.

Terrell & Sham (Company) was paid \$60.25 for 6 Rain Brogans, 18 same, 1 same, and 17 wool socks at Bloomfield Ky., Sep 1862

Solomon Terrell was paid \$9.00 for 1 Brogan shoes at Joren Tannery (?), Feb 1864

Mrs. S. J. Terrell was given 81 yards of sheeting and 13 yards of shirting in exchange for 29 lbs. of washed wool at Enterprise (?), Sep 1864

S. W. Terrell was paid \$487.00 for tanning 191 lbs. of sole leather at Raleigh (N.C?), Sep 1863 was paid \$435.00 for tanning 145 lbs. of sole leather at Raleigh (N.C?), Sep 1863 was paid \$12.00 for tanning 16½ lbs. of sole leather at Raleigh (N.C?), Oct 1863 was paid \$231.00 for tanning 154 lbs. of upper leather at Raleigh (N.C?), Dec 1863 was paid \$324.00 for tanning 188 lbs. of upper leather and 42 lbs. of sole leather at Raleigh (N.C?), Jan 1864 was paid \$188 for tanning 125½ lbs. of upper leather at Raleigh (N.C?), Jan 1864 was paid \$449.50 for tanning 32 doz. hides into 244 lbs. of upper leather and 205 lbs. of sole leather at Raleigh (N.C?), Jun 1864 was paid \$220.00 for tanning 220 lbs. of upper leather at Raleigh (N.C?), Jul 1864

V. L. Terrell was paid \$500.00 for one 1st class horse at Gallitin, Miss, Nov 1863

W. C. Terrell was paid \$840.00 for 600 bushels of corn and 16,000 lbs. of fodder at "in the field", Jan 1863

Mrs. W. E. Terrell was paid \$16,000.00 interest on coupons redeemed on CSA cotton bonds she owned at Augusta Ga., Oct 1863

W. F. Terrell was owed \$786.00 due on account for 493 bushels of corn at (unstated), Aug 1863 (due but not yet paid). Receipt for payment (signed **Wm. F. Terrell**) issued at Selma Ala., Sep 1863

William H. Terrell [probably **William Higgins Terrell**, b. 1800, son of **John Dabney Terrell Sr. & Lydia Brisco Warren**, see **Dicken** p. 116. William died in 1860, and it seems probable that the Mar 1863 receipts were signed instead by his son **William Henry Terrell**] was paid \$370.00 for 50 lbs. of lard, 9520 lbs. of corn, 6000 lbs. of fodder at Greenwood Miss., 17 Mar 1863 (signed by W.H. Terrell) was paid \$4,621.24 for 318 bushels of corn, 9466 lbs. of fodder and 1½ gallons of tar at

Greenwood Miss., Mar 1863 (signed by W.H. Terrell) was paid \$128.75 for corn due him and received by the administrator of his estate **William C. Ross** at Noxubee Co., Miss., Mar 1863 (signed Ross) was paid \$162.75 for corn due to his estate at Macon Miss. Mar 1863 (signed Ross) was paid \$239.57 for wheat, peas and bacon due to the estate Jul 1863 (signed Ross) was paid \$239.57 for (hard to read) wheat, peas and bacon due to his estate at Noxubee Co, Miss., Jul 1863, paid Aug 1864 (signed Ross) was owed \$175.50 Terrell for (unstated) but not paid because funds were not on hand at (unstated), Dec 1863

Wm. H. Terrell was paid \$18.00 for shoeing horses at (unstated), Jun 1862 (paying unit is 1st Regt. La. Cav.)

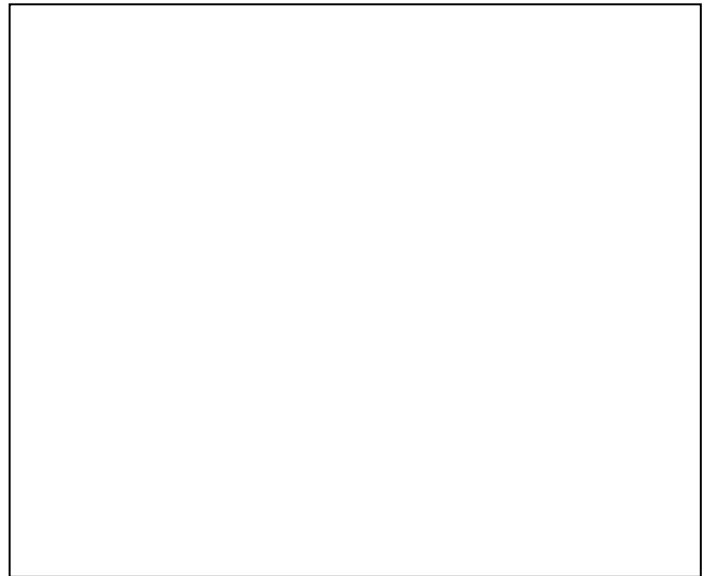

*GOLANSVILLE QUAKER
MEETINGHOUSE*

Pioneers in asserting the right to religious freedom, the Caroline Friends (Quakers) held their first meeting nearby on 12 March 1739 together with their partner, Cedar Creek Friends Meeting of Hanover County. At a meeting on 9 May 1767, members issued a call to their fellow Quakers to end slaveholding, the first such movement in Virginia. The Friends testimony against slavery contributed to declining membership as many migrated west to free states. The Caroline Friends continued to use their meetinghouse and burying ground until 1853. They then joined Cedar Creek and ultimately became Richmond Friends Meeting.

I just received the past issues of Terrell Trails I had ordered and had to comment on the article '**James Tyrrell - - Hero**'.

I completely agree with **J. A. Speares** statement, "I am not a biographer, much less an historian".

First of all in the introduction **Henry IV** who usurped the throne from **Richard II** was his cousin, not his son. Then the story skips from **Henry IV** to **Edward IV** omitting that **Edward IV** himself had usurped the throne from **Henry VI**.

He leaves out that Richard's first struggles are with the Woodville Yorkists over control of the young princes and have nothing to do with **Henry Tudor**. Neither **Richard's** party nor the Woodville party can safely exist without destroying the other. He also omits that **Richard III** has the young princes declared illegitimate and seizes the throne himself.

I don't know who murdered the princes, but Richard is the one who benefited most from their death from a historical point of view as previous usurpers of **Edward II**, **Richard III**, and **Henry VI** all

discovered as long as a legitimate heir existed people would rally to their support.

The story makes it sound as if **Richard III** heir was murdered when he died a natural death. This death leaving Richard heirless destroyed his main advantage to being king from the people's view point of preventing a long unsettled minority for a king, as was the case of **Richard II** and **Henry VI's** heirs.

Richard could have prevented the popular support (which the story omits) for **Henry Tudor's** invasion by producing the princes. By failing to do this, he was deserted by most of his supporters.

Also **Henry Tudor** and **Edward of York** had pretty much an equal claim to the throne, once Henry VI was murdered.

I was given your email address by a fellow Terrell researcher and I'm writing in the hope that you can point me in the right direction. I am preparing a book on my family line and I've reached an impasse.

I know that the Terrells in Georgia and Alabama I am related to are neither well known nor prosperous. I'm not related to the **Solomon, Micajah, Richmond** set nor to the **Charles R. group** in northern Alabama nor **Joseph Terrell** nor **Elijah Terrell** nor **William & Susannah Waters Terrell**. As far as I can tell, we are independent of all other groups.

I'm hoping you can point me to resources for two documents:

1. Proof that **James Allen Terrell** arrived on a ship
2. Proof that **James Allen Terrell** served in the military during the War

Here is what I know:

James Allen TERRELL (b. March 1833 in Ireland) was "transported" from Killarney Ireland in 1849-1850 for horse-thieving. (It was an act of mercy, but that's a different story.)

It is possible that the ship landed in Georgia, but I don't know when, where, or the name of the ship. Can you help me?

[In that era, one could enter the USA at any port where seagoing vessels docked. The most common however, were Boston, NYC, Philadelphia, Baltimore, Charleston SC, Savannah GA, and later Ellis Island. There are numerous books containing passenger lists. Most large libraries have a collection of them. If he was deported from Ireland

as you believe, there should be some record of his exile there.]

On 9 November 1851 he married **Julia Ann JONES** in Gordon or Calhoun Co. Georgia. Julia is the eldest daughter of Rev. **William Fletcher JONES & Nancy McLin GILLESPIE Jones** of Calhoun Co. GA.

The family story is that "**Jamie**" (soon to become "**Jim**") didn't feel compelled to serve in the Civil War. Since he was a recent arrival, it wasn't his fight. However, he realized the community expectations and served as groom, veterinarian, and horse wrangler for the South. How can I find out if this is legend or fact?

[There is a set of volumes on *Confederate Soldiers from Georgia*. Most medium and larger libraries have the set. If yours does not, they may be able to get a set through interlibrary loan. However, if he did not officially enlist, he may not be listed.]

The older children are born in Gordon Co. GA, according to the censuses. My great-grandfather said he was born in "Dairzvull", which I am guessing is the equivalent of Adairsville.

[You are probably right in that assumption. It is the town name closest to that pronunciation.]

A. In a word, *No*. At least not that I could find while doing this issue. The following may give you some idea of the size of the haystack and may contain something that "clicks."

[The obvious question that comes to mind is, "Have you checked marriage and other records in the Osage County area of OK?" Even if she married young, the marriage should have been in 1912 or later. Don't overlook Indian Agency records.]

ROGER TYRRELL--THOMPSON LINE

Roger TYRRELL came from Hereford, Eng. to America in the ship *Lion*, reaching Boston Sep. 14th 1632. He remained in Boston and Roxbury for a few years. In the summer of 1637, he visited western Connecticut, probably with or following Capt. **UNDERHILL'S** Co. in the Pequot war. He probably went as far west as Fairfield. He returned to Boston in the fall,

and there met the Davenport Eaton Company a part (of) whom had come from Hereford, his old home. He married **ABIGAIL**, daughter of **Thomas and Isabel UFFORD**, in the winter of 1637-8, and with the New Haven Company, came to New Haven in the spring of 1638. He remained in the Hereford quarters of that Company until Aug 28, 1639, when he went with the Milford Company to that place which place was reached and the settlement compound (?) Sep. 1st 1639. He was accorded the rights of Freeplanter of that Colony, he having been refused those rights by the New Haven Company at the Meeting in Doc. **NEWMAN**'s barn July 4th, 1639, he not being a member of the Puritan Church, but still belonged to the Church of England. He was Bapt'z and admitted to the Milford Church in July 1644. His oldest children were Bapt'z in August, and his wife the following Nov. He was prominent in the affairs of the Colony and Church until his death in 1692. [From **M. S. Turrill** copy of **Cornelius B. Harvey's "Buck"** book now in hands of my cousin in Phoenix, AZ]

MY DIRECT LINE

I. **ROGER TYRRELL**, (**TERRILL**¹) b. 1610, Stephney Wapping, England, and came to Boston on Sept. 14, 1632 from Nanzey, England. In 1637 he married **Abigail UFFORD**, the daughter of **Thomas UFFORD** and his wife **Isabel BRYAN**. Being of the Church of England he was one of eight persons rejected by the New Haven Company. All eight of these people were later accepted by the Milford Plantation and given rights of Free Planters. The names of **UFFORD** and **TERRILL** are both engraved on the stone balustrade of the Memorial Bridge in Milford. **Roger** and **Abigail** had 11 children as follows:

171.18 **JARED TURRILL**, b. Oct. 18, 1762, d. Sept. 27, 1833, m. Feb. 22, 1789, **Hannah BUCK** (#73), b. May 15, 1768, d. May 27, 1855. **Jared TURRILL**, spelled **TURRILL** on his grave marker, was by occupation a farmer,

although he had learned the trades of tanner and harness maker. He was active in town and religious affairs. He was a communicant and a pew holder in the New Milford Congregational Church, where for thirty years of his married life he attended with his family.

In April 1777 at the age of 15, he joined a company at New Milford, CT, and served in driving the British from nearby. [Family records - I have not yet found official records to verify this.] The company was discharged at Peekskill, NY, not long afterwards. As to my grandfather **Jared Turrell**, says Prof. **M. S. Turrell**, "I knew but very little about him. He was always represented to me as a very hard working man; a shoemaker by trade, serving a seven years apprenticeship; tried to cultivate for a farm near New Preston, in Litchfield County, CT; in 1818 came with his family to Ohio, over the Alleghanies by wagon, and down the Ohio River from Pittsburg to Cincinnati in a flat boat; purchased eighty acres of land six miles from Cincinnati, in Columbia Township, Hamilton County, on which he lived about fifteen years until his death. He was in religion a Congregationalist in the East; and a Presbyterian in Ohio; a consistent Christian, and left behind that of which his descendants are ever proud, a good name through his entire life."

"My grandmother, **Hannah BUCK TURRILL**, will be ever present in my memory. She lived after my grandfather's death, in my father's [**Heman Bassett TURRILL**] family, and I knew her intimately from the time I knew anyone, until my twenty-fourth year, when she died. I remember her occupying a certain chair in the chimney corner, working industriously at her knitting, even when her hearing was weakened by age, her eyesight dimmed with blindness, and her fingers almost benumbed. She made all children her warm friends, telling us often of many scenes that transpired in her youth, of her brother [**Josiah BUCK**] who served in the Revolutionary War, and the bright blue uniform he wore, of her uncle **Roger SHERMAN** in the Continental Congress, how he used to come to her father's on Thanksgiving Days and always brought her a present; of other brothers and sisters who,

Grew in beauty side by side

Who filled our home with glee.

Whose graves are severed far and wide,

By mountain, stream, and sea.

"And OH! How it pleased me, and her also, the year before her death, when I visited her early home on Long Mountain, CT; for the various gifts I brought home to her were some apples from trees whose fruit she had enjoyed, and whose flavor even then, she well remembered, thus reviving vividly the memories of her childhood, and recalling reminiscences of her youth, her home, and that orchard's delicious fruits. One bright spring day, when the breezes were loaded with balmy perfume, from the fragrant roses and wild wood flowers, --when the forests were glassy with new-come perfume, and the grass and grain-buds swelling and raising their tapering like fingers heavenward, we laid our grandmother away in her last repose, in the beautiful hill-crowned cemetery of Pleasant Ridge [Ohio], and within the shadow of the church where she long worshiped." On her monument are the words, selected previously by her, and expressive of her gratitude to God. 'Return

unto thy rest, O my soul, for the Lord hath dealt bountifully with thee.' Around the lattice that encloses that sacred spot, are the rose and eglantine; and their fragrance and sweetness are fit emblems of her purity and loveliness of character. Many kind thoughts, many cheerful smiles, many glorious pictures of the past are mine; but none, no, none are brighter, than my childhood memories of thee, my dearest grandmother. "**Hanna BUCK** was gifted with intelligence and sound common sense, a keen judgment of human nature and the fitness of things, coupled with a cheerful lively disposition made her popular in the society of which she moved. Her advice was valued and her opinions respected, by all who had the pleasure of her acquaintance. She was, while in Connecticut, a member of the First Congregational Church, at New Milford. During her latter years, she was a communicant of the Presbyterian Church. Her memory is honored by a numerous and respectable host of descendants.

Her husband, **Jared TURRILL**, was a brother of **John TURRILL**, the husband of her sister **Elizabeth**.

"As I have said, his father **Caleb TURRILL**, was of honorable descent and married **Abigail BASSETT**, one of the French Huguenot families, that fled from Picardy, and settled in Connecticut in the first half of the 17th century. This **Caleb**, was the progenitor of a most remarkable family of eleven boys and three girls, a total of fourteen. Their names were **Enoch, Caleb, Issac, Stephen, John, Joel, Job, Jared, Benjamin, Doctor and Major (twins), Abigail, Mehitable, and Freelove**.

They may be justly called a fighting family, surely they cannot be twitted with lack of Patriotism.

"Nearly all of these boys bore arms in defense of the mother country, against France or against the mother country for independence. **Stephen TURRILL** enlisted under **ABERCROMBIE** at the age of fifteen, and participated in the Canadian struggle. Later, he served in the Revolutionary War under **WASHINGTON**. It is said that he witnessed the surrender of **CORNWALLIS** at Yorktown, and died in Vermont aged 101.

John TURRILL was likewise in the war, on the continental side, and suffered long as a prisoner in the terrible Jersey Prison ship, at New York..

Doctor TURRILL was a seventh son, and died unmarried at the age of 21.

Benjamin TURRILL was drowned while fishing in the Housatonic Falls. Very few of their descendants are left, in New England. They are scattered over the Middle and Western States."

He was ten years old when he came from New Milford and lived on the Pleasant Ridge farm with his father and afterwards there as part owner for over forty-five years.

The obituary notice of him said, 'He was a kind father, a good neighbor, and influential citizen, an elder in the Presbyterian Church and a true Christian, esteemed and beloved by an extensive circle of relatives and friends, and after a short, but very painful illness, has gone to his home and his Saviour in Heaven.'

He was one of the charter members of Pleasant Ridge Lodge, No 282, F. And A.M., and was buried with Masonic honors by them at his death." His remains rest at Pleasant Ridge Presbyterian Church Cemetery. He was also a physician, being a graduate of the Ohio Medical College of Cincinnati.

After graduating a Farmer's College on College Hill, in Sept. 1850, **Merwin** selected teaching as a profession, and after three years employment in the country districts of the Cumminsville Graded Schools, from Jan. 1854 to June 1873, when Cumminsville being annexed to Cincinnati, he was re-appointed Principal of the same schools (called the 26th Cin. District), until June 1885, since which time, he has retired from service.

He was also one of Hamilton County Board of Examiners of Teachers, and from 1867 to 1872 he was yearly elected the Corporation Clerk of the village of Cumminsville. During his school employment, he has also been a frequent contributor to education periodicals and literary magazines, and has acted as Secretary for several years, for the Executive Committee of the Ohio Teacher's Association. He also has a deservedly extended reputation as a geologist, and possesses a valuable cabinet of minerals of Ohio and other States. Mr. Turrill is also of the Masonic Order, being a charter member of Hoffner Lodge, No.

253, of Ohio, and has attained the 32nd degree in Ohio Consistory; he also was one of the organizers of Cumminsville Presbyterian Church in 1855, and an enthusiastic worker in the Chatauqua Literary and Scientific Circle. He has also a decided inclination for traveling, and uses his vacations in arranging railway [and boat] excursions for teachers and others. During the past year [1886] he has been one of the building committee in erecting a magnificent Masonic Temple, and also a beautiful Presbyterian Church both about two squares apart on Hamilton Pike, in Cumminsville. He resides [resided] at 4314 Hamilton Ave., Cincinnati, OH.

He was born Oct. 4, 1859 in village of Lockland, OH, and died in Riverside, CA., Nov. 9, 1945. He's parents were **Adam SCHWARZ (SCHWARTZ)** born ABT 1834 in Hesse-Darmstadt, Germany, and **Marie (Mary) GRUNINGER**, born Jan. 20, 1824 in Wurtenburg, Germany, died July 20, 1904 in Cincinnati.

Mary and Charles and their five children moved west to Flagstaff, AZ in May of 1919 and afterwards, in 1926, to lived in Perris, CA and Riverside, CA.

After her husband's death, **Mary** lived with her daughter **Jean** at Beaumont, CA, till her death. Mary was an educated musician who played the organ at church and the piano in the silent movies.

Charles was a tailor by training although he and his brother **Fred**, about 1882, built a hardware and furniture store at "Schwarz Corners" in Cincinnati.

In his early marriage years, he was a member of the Odd Fellows Lodge. He started a tailoring business at Harriet and Wyoming about 1890.

In Flagstaff, he with his teenage sons cleaned the costumes of movie actors, filming on location near Flagstaff.

Charles was Secretary of the Democratic Party of Northern Arizona; a deputy sheriff and was part of a mountain rescue of a local Navaho chief's son.

My grandmother taught piano which included my mother.

Grandfather **Charles ("C.C.")** wanted to be a painter of pictures as a youth, but as his mother was from the "old country" and insisted he have a "regular trade," he had to take painting lesson in secret. In his retirement years, I would visit their home in

Riverside and watch him paint. I also remember that he had a great sense of humor and liked to do slight-of-hand magic tricks on me when I was very young.

Mother loved her music and in my youth, there was always a piano at home. She lead a jazz band her school days in Perris, CA, sometimes playing Saturday night dances at Lake Elsinore, CA. She was Valedictorian of her graduating high school class.

I remember in the WWII years, my uncles, aunts and cousins would gather around the piano and sing old time songs. Later she had her organ at home; she was the church organist or church pianist; and entertained on the piano at DAR meetings in later years. Even in her 80's, mother would be coaxed to play the organ tunes we all loved, when we would visit her at her home.

When I left home in 1952 to do my service in the Marines, mother went back to work after 20 years of taking care of her family. She was deeply committed to her church and religious music was part of her life. She was fortunate to secure a long term of employment with the Homer Roderhaver Company in Los Angeles.

After my sister **Mary** was married, **Leo** and **Margaret** moved to Chula Vista, CA. where mother obtained, through the efforts of Uncle **Merwin**, a position as Registrar at Chula Vista Junior High School. (Dad's history is in Thompson document). She retired after 14 years of service. Both are buried at cemetery in Bonita, CA, along side mother's sister Jean.

Sherman grew-up in Inglewood, CA and spent eight years in the US Marines, after which he spent 2 years at Compton College. He was always active in journalism in school but realized his real love was in the graphic arts. He enjoyed drawing the cartoons for his school newspapers.

In 1957, after getting married to Sarah, he enrolled at Chouinard Art Institute in Los Angeles. (Now called Cal Arts and since moved to Valencia, CA.) There he spent the next three and one

half years of intense study. In 1959, he won the Jose Drudis Painting Scholarship and won a first place award in the student art show for his cartoon work. It was while a teacher assistant that in 1961 he was referred to an animation studio for his first job.

Since that early start as an apprentice at Churchill-Wexler Films executing educational and medical classroom films, he has spent 20 years in the animation studios. He has been a president of the Screen Cartoonist Guild in Hollywood, CA. He has been a producer and executive producer on theatrical shorts and television cartoon specials that has won nominations in the Oscar and an Emmy awards.

As a partner and member of the Board of Directors of "Take One" in 1978-80, he was instrumental in establishing major animation studios in Taiwan, Korea and in Mill Valley, CA. Sherman joined Ogilvy & Mather Advertising, Los Angeles in 1981 as Senior Animation Producer and has supervised the production of their clients animated commercials.

In 1994, he was made a Partner (vice president). In 1993, he was elected by his animation peers as a Governor at the Academy of Television Arts and Sciences. In 1998, Sherm retired from O&M. He is living, with his dogs Barney & Lydia, in Sun Valley, in the San Fernando Valley of Los Angeles, CA.
