Furthermore, OFFICE DEPOT manager agreed to print this issue for the same figure if I can get it to her in 2 weeks or less from the time we printed the spring issue.

These two issues should save us about **\$259.00** over offset printing costs.

These rates are not likely to hold until even the fall and winter issues, but all future issues will be done by the lowest bidder.

We save a lot by using Bulk Mail. Unless rates increase before the end of the year, we will save **\$67.40** by mailing spring & summer in one mailing and fall and winter in the next.

These measures are a long way from \$700.00 per year, but they are a step in the right direction. Maybe this will buy us enough time to make some solid decisions about future dues, etc.

The item at left on printing cost reduction efforts; the item above on postage rate comparisons; the one that follows on Minimum Dues; and the Lending Library Gain (Loss) recap will provide you with all the data we have to make an intelligent decision about the future of the Society. Please study each of these carefully. Then share your thoughts with us.

#386 MR. CHARLES BRYCE TERRELL 1928-2006

Charles "Charlie" Bryce TERRELL, 78, of Cheyenne died Sept. 15 peacefully in his home.
He was born May 25, 1928, in El Paso, Texas, to **Charles Alexander TERRELL** and **Addie Ella HUST TERRELL**.
Charles Sr. was a railroader and Charlie and his siblings spent time living in Texas and New Mexico. Charlie spent part of his early years in New Mexico on a ranch with his grandmother, **Alice Rose SKINNER Hust**. He was educated in Houston School and Austin High School in El Paso, graduating in 1946. While in high school, Charlie was affiliated with FFA.
Charlie was an employee of Mountain States Telephone and Telegraph Company (later known as Mountain Bell) in El Paso and New Mexico.
He held various positions in the plant and marketing department and was named Outstanding Salesman in El Paso Marketing in 1964. In 1967, Charlie transferred to Laramie and was in charge of communications for the University of Wyoming. In

1970, he transferred from Laramie to Cheyenne and retired as a staff manager for safety in seven states.

Charlie had numerous nicknames, including Chuck, Chas Bo and Son.

Charlie is survived by his wife of 13 years, **Jacqueline Louise CONNER TERRELL** ; a daughter, **Daphne Diane TERRELL RAMEY**, her husband, **Mark**, and their children, **Stetson Buck**, **Remington Steele** and **Allegra Doe**, all of Cheyenne; sons, **Charles TERRELL**, his wife, **Carla Denise KEEL** and their daughters **Whitney Nichole** and **Kaitlyn Carley** of Arkansas, and **Toby Leigh TERRELL**, his wife, **Lisa Marie BOYCE**, their son, **Casey Robert**, and daughter, **Kelli Kayleen**, of Pinedale; a stepson, **Christopher Todd HOUT**, his wife, **Donna Marie HAVENS**, and their sons, **Garrett Lee**, **Austin Dean** and **Casey Todd**, all of Cheyenne; sisters, **Elgeva TERRELL Cantrill** and **Hope Collette TERRELL Sanderson**, both of El Paso, and **Sharon Faith TERRELL Soper** of Georgia; and a brother, **Don Leigh TERRELL**, of El Paso.

Charlie was preceded in death by his parents; and a brother, **Ronald Rex TERRELL**.

Charlie was blessed to have loving care and support provided by **Billy Slagle**, **Diane Slagle**, **Katherine (Katie) Barbour**, many caring members of Jackie's family and several devoted friends.

As a special gift, Charlie donated his body to science. A memorial service will be 3:30 p.m. Tuesday at Wiederspahn-Radomsky Chapel of the Chimes. Memorial contributions can be made to United Medical Center Hospice.

TERRELLS IN VOLUNTEER ARMY UNITS IN THE SPANISH-AMERICAN WAR PART 1

Don C. TERRILL, copyist

These records are copied from National Archives of the United States Record Group 94.12.2, "Compiled Military Service Records of Volunteer Soldiers in the War with Spain." All information is extracted from the paper documents held by the Archives.

During the war with Spain, volunteer soldiers served in either State units, territorial units or in Federal units whose membership was not limited to any one State or territory. On 22 Apr 1898, Congress passed an act stating that any existing militia organization that volunteered in a body would be accepted as a unit. States or territories could also raise new units of volunteers to serve in addition to those that were already in the State militia. The April 22 act further provided for volunteer units to be recruited and controlled directly by the Federal Government. The act authorized the Secretary of war to enlist a maximum of 3,000 men from the nation into voluntary units. The troops created under this act were the 1st, 2d, and 3d Regiments of U.S. Volunteer Cavalry. On 11 May 1898 Congress authorized the creation of three regiments of Federal volunteer engineers and 10 regiments of Federal volunteer infantrymen. A Volunteer Signal Corps was created by acts of Congress approved on 18 May and 7 Jul 1898.

These records were maintained by the Adjutant General, and the purpose of these records was to substantiate military service for pension or disability claims. Therefore, there is not much information on the activities, heroism, or awards of the individual.

All unit histories are taken from *War with Spain Correspondence, Vol. 1*, Apr 1898 - Jul 1902 (U. S. Government Printing Office, Washington, D.C., 1902).

TERRELL, Frank P. - Co G, 2d U. S. Volunteer Cavalry Regiment. Entry rank: M/Sgt. Appears on muster-in roll dated 23 May 1898 at Ft. D. A. Russell, Cheyenne, Wyo. No further information. Annotated "Entry cancelled."

TERRELL, Robert R. Jr. - Co B, 3d U. S. Volunteer Infantry Regiment. Entry rank, Pvt; discharge rank, Pvt. Appears on muster-in roll dated 21 Jun 1898 at Camp Price, Macon, Ga., as age 18, height 5' 8", complexion brunette, eyes dk. brown, hair black, born at Decatur Ga., occupation carpenter. Enrolled 11 Jun 1898 at Bainbridge, Ga., for 2 years. Residence Whigham, Ga.; person to notify: Mr. **R. R. TERRELL [Robert Raines, Sr.]** of Whigham, Ga.

On special duty as orderly Capt. Gilchrist Feb. 2 to 10 incl. On furlough in U.S. from Mar 15 to April 11, 1899. Sick in qtrs Sept. 23, Oct 16 to 20 incl. Nov 14, Apr 12, sick in Regt. Hosp. Sept 11 to 13 incl, 1898, Jan 15 to 18 incl., 1899. All in line of duty. Pay due from day of enrollment June 11 to day pervious to muster in June 20 incl. 1898."

Dear Sir

I have just received a communication from Hon. **Thomas Ward** Ass Adgt Genl. Washington D.C. in reference to my son **R. R. TERRELL Jr.**, Private Co B. Rays Regiment stating therein that he had sent you my son's Furlough etc. My son came home on that Furlough and was sick when he left Santiago, Cuba, and has been quite sick ever since. Hon **J. M. J. Griggs**, Congressman from this District notified me that he had my sons furlough extended 30 days. This, I learn,

is not a fact. I wish if practicable to have my son mustered out with his regiment. Dr. **Jones** says that in the course of a week or ten days that my son can make the trip to Macon. Will you be kind enough to advise me what to do in this matter. Thanking you in advance and assuring you that the same will be duly appreciated etc.
