**TERRELLS IN  
VOLUNTEER ARMY UNITS IN THE  
SPANISH-AMERICAN WAR  
PART 2; CONCLUDED**

These records are copied from National Archives of the United States Record Group 94.12.2, "Compiled Military Service Records of Volunteer Soldiers in the War with Spain." All information is extracted from the paper documents held by the Archives.

During the war with Spain, volunteer soldiers served in either State units, territorial units or in Federal units whose membership was not limited to any one State or territory. On 22 Apr 1898, Congress passed an act stating that any existing militia organization that volunteered in a body would be accepted as a unit. States or territories could also raise new units of volunteers to serve in addition to those that were already in the State militia. The April 22 act further provided for volunteer units to be recruited and controlled directly by the Federal Government. The act authorized the Secretary of war to enlist a maximum of 3,000 men from the nation into voluntary units. The troops created under this act were the 1st, 2d, and 3d Regiments of US. Volunteer Cavalry. On 11 May 1898 Congress authorized the creation of three regiments of Federal volunteer engineers and 10 regiments of Federal volunteer infantrymen. A Volunteer Signal Corps was created by acts of Congress approved on 18 May and 7

Jul 1898.

These records were maintained by the Adjutant General, and the purpose of these records was to substantiate military service for pension or disability claims. Therefore, there is not much information on the activities, heroism, or awards of the individual.

Remarks: "Assignment as recruiting officer with selected recruiting party from Headquarters 4 Army Corps at Mobile Ala June 8, 1898 by G.O. 16 and in compliance with G. O. 61 A. G. O. current series. Ordered to proceed to Waco Texas and recruit

Remarks: "Absence on detached duty as Recruiting Officer June 9 to Jul 18, 98, S.O. 16 Hdqts 4 Army Corps. Detailed as Battalion Adj. Aug 2, 98 S.O. 65, dated same date Hdqts 2d Texas. Granted 30 days leave of absence from Sept 29, 98, under G.O. 130, A. G. O. Reported for duty Oct 26, '98."

### FOREWORD

This is the WHENCE BOOK of the Bradley Tyrrell family and, therefore, a highly personal document, not intended for distribution to any but the author's immediate family and a few of the collateral relatives who have expressed some interest in the subject. The author has been accumulating the data over a period of twenty years or more and in so far as the limitation of time and sources would permit of further verification, they are considered accurate. Genealogical research is a never ending project, subject to continual correction, but one must stop somewhere if he ever expects to put the data into chronological form. . . ."

[The first 10 pages of English ancestry in the original work is based upon work by **Joseph Henry TYRRELL** of England. To conserve space and to avoid what I personally consider to be incorrect information based upon wills rediscovered by the TYRRELL FAMILY HISTORY SOCIETY in England during the mid 1990s, that information is omitted from this article. *DFB*]

## THE TYRRELL FAMILY IN AMERICA

**William TERRELL** arrived in Virginia from England, perhaps via the West Indies, early in the seventeenth century and became the progenitor of the southern branch of the family. Mr. **Edwin Holland TERRELL** traces his own descent from this early Vir-

ginia settler and considers this branch direct descendant of the Essex family.

Our own immigrant ancestor was **Roger TYRRELL** who with **Peter PRUDDEN** and others founded Milford, Connecticut in 1639. He landed at Boston sometime between 1632 & 1637.

In 1940, the author carried on some correspondence with a Miss **Katherine WELLS** of New Milford, whose uncle, General **Henry Stuart TURRELL**, retired army surgeon, was interested in genealogy and had prepared a manuscript on the Turrell family. Due to his death within the year following his retirement, this manuscript remained unpublished. Miss Wells sent me a copy which is now in my files.

General Turrell states that "Roger Tyrrell arrived in Boston in 1632 on the ship, *Lion* from Hereford, England. He remained at that place for a time and then went to Roxbury. He was in Wethersfield, Connecticut in 1636. In the summer of 1637-38, he went to western Connecticut with Captain UNDERHILL's Company in the *Pequot War*. He married **Abigail UFFORD** in the winter of 1637-38, probably in Wethersfield. She was the daughter of **Thomas** and **Isabel UFFORD** of Suffolk, England, who sailed for Boston on the ship *Lion* with **Roger TYRRELL**. Neither he nor the Uffords left England because of their religious beliefs as they were member of the *Church of England*." I have checked **HOTTEN's passenger lists** and **BANK's Typographical Dictionary** but failed to find Roger's name listed. **WINTHROP's Journal**, 1, 92 state, "Ship *Lion*, **William PIERCE**, master, sailed from London on June 22, 1632, and arrived Boston September 16<sup>th</sup>. He brought 123 passengers whereof 50 children, all in health, 12 weeks abroad and 8 weeks from land's end."

It may be that Roger was among the fifty listed as children, although it is difficult to understand how a youth old enough to make such a journey at that early date would have been too young to be listed by name.

The *General and Family History of the State of Connecticut* says "**Roger TYRRELL** descendant of English Progenitor Roger TYRRELL, (this could be **Sir Roger TYRRELL** of Hampshire, 12<sup>th</sup> Century - W. B. T.) came to this country about 1637 with the Eaton and Davenport Company. In 1639, he married **Abigail UFFORD**, daughter of **Thomas** and **Isabel UFFORD** who came from England on the ship *Lion* in 1632, locating first at Roxbury and finally a Milford."

**ATWATER's History of New Haven Colony** states that "Roger TYRRELL came to Milford from Wethersfield."

It must be presumed that General TURRELL, who doubtless had sources of information not easily available to this author, was reasonably accurate for it is fairly well established from my own research that Roger was in both Roxbury and Wethersfield prior to 1639.

As to the parentage of Roger and the country from which he came, there is much confusion. This author has in his files two lengthy reports from the Society of Genealogists, London, covering their research on the subject. No definite information could be furnished regarding any Roger TYRRELL from Hereford. At the suggestion of the Society, I wrote to a number of incumbents of likely parishes in Hereford asking for a search of baptismal records from 1603 to 1630 but this failed to develop anything important.

Banks, *Topographical Dictionary* gives *Stepney* as the parish from which Roger came. There I requested the Society for a second report but this yielded only **Tyrrell of Stepney**, a London merchant, married **Margaret ROTHBOTHAM** of St. Faith's. So far as the dates are concerned, this is the probable period in which the marriage of Roger's parents took place. Further evidence of a **TYRRELL** family in Stepney is shown by a marriage in 1643 of **Francis TIRRELL** to **Avis DREWE**, Stepney.

Stepney is a suburb of London. There were many **TYRRELLS** in London in this period, but no record of the names Roger or Jacob.

It should be noted, however, that there was a **TYRRELL** family of some importance in *Suffolk*, from which county the **UFFORDS** came.

The report of the Society casts some doubt on the name **Abigail UFFORD**, quoting Banks, *The Planters of the Commonwealth* (1930), as authority for passengers on the *Lion* as including **Thomas UFFORD**, **Mrs. Isabel UFFORD**, **John UFFORD**, and **Isabel UFFORD**. So many other authorities designate **Abigail UFFORD** as the wife of **Roger**, however, that there seems to be little doubt as to her parentage.

Isabel and Abigail are sufficiently close phonetically to account for a possible discrepancy. The memorial stone bridge in Milford is inscribed with the names of the founders and early settlers – among them, **Roger TERRILL**, **Abigail, his wife**.

According to General **TURRELL**, Reverend **Peter PRUDDEN** supplied the pulpit at Wethersfield during a part of 1638. It may be therefore that Roger and his bride returned with him to New Haven in 1639. **Roger** is presumed to have been present at the famous meeting in **Deacon NEWMAN's** barn and to have been one of the ten or eleven men rejected because he was not a church member. The New Haven Company had decided that none but church members should be admitted to the rights of Free Planters. The Hereford Company, of which Roger apparently was a member, established their own settlement under their pastor, Peter PRUDDEN, at Milford where they enjoyed all the rights of Free Planters excepting acting as judges when New Haven and Milford joined in common court.

Peter PRUDDEN served as minister at Milford from 1639 until his death in 1656.

Milford was first laid out with two parallel streets and the entire plot surrounded by a stout palisade. Each planter shared the expense proportionately and received land for his contribution based upon his estate and the size of family. Each agreed to build a house within three years. Roger's home lot of two acres was #49 on West Street facing West Brook. Each settler was given land outside the stockade for cultivation. From the Milford records: "Roger's Tyrrell hath for his first division 10 acres and to equal it to other lands, 5 acres, in all 15 acres lying on Wegam Hill. Roger Tyrrell hath for his half division of land nine and a half and twenty rods on Bever Pond. Roger Tyrrell hath for his second division of meadow two acres and one rod lying in Oyster Meadow." Two other grants gave him 16 and 17 acres respectively.

Barber's *Connecticut Historical Collections* states: "Milford is one of the oldest towns in Connecticut – one of six plantations which composed 'Old Jurisdiction of New Haven,' started in

1639. First purchase February 12<sup>th</sup> from the Indians. The consideration was 6 coats, 10 blankets, 1 kettle besides a number of hoes, knives, hatchets, and glasses. The instrument was signed by **ANSANTAWAE the Sagamore** and others. Afterwards at other times other purchases were made. A reservation by the Indians for planting consisting of 20 acres was purchased for 26 pounds – with the understanding that **ANSANTAWAE, wife and sons**, in case of danger were granted liberty to sit down for shelter in some place near the town where the townsmen should think most fit. Indian name for the town was **WEPAWAUG.**"

Roger subscribed to the Covenant of the *First Congregational Church of Milford* on July 28, 1644. His name appears on page 2 – also on page 2, "Abigail, wife of brother Roger Terrill." – 1644. First listed are the "Seven Pillars" in Peter PRUDDEN's handwriting -- then following, "persons after added" the names of Roger and Abigail as noted. The records show him to have been a man of importance in the church and colony.

**Thomas UFFORD** eventually joined his son-in-law in Milford and united with its church in 1644. The following taken from an old record in Milford Library by this author in 1946: "On March 25, 1657, Roger Tyrrell appeared before the court consisting of Governor **Theophilus EATON**, Deputy Governor, **Stephen GOODYEAR**, and Magistrates **Francis NEWMAN**, **Benjamin FENN**, and **William LEETS**, in behalf of **John UFFOOTE**, who was charged with fornication against **Martha NETTLETON**, with child to UFFOOTE, with Martha's father requested the Court's permission for UFFOOTE to marry her. Petition granted. John UFFOOTE fined ten pounds and Martha five pounds."

Roger died 1683 – burial place unknown. His estate was appraised at L 677.S8.d5.

Roger and Abigail had eleven children, seven of which reached maturity.

**John TYRRELL**, oldest son of Roger, was born in Milford in 1644 and lived there all his life. He married **Abigail (TYLER?)** about 1673. He served in King Phillip's War in 1674. Two daughters and six sons were born to John and Abigail. In John's 76<sup>th</sup> year, he and his wife were provided for by his seventh child, Josiah, as evidenced by the following document taken from the Milford records: "I, **Josiah TERRILL**, in consideration of five acres of land made sure to me by my brother, **Samuel TERRILL** of Milford aforesaid by deed bearing date March 31, 1720, do from this day provide for and honorably maintain our father and mother, John and Abigail TERRILL, so that my brother, Samuel TERRILL, or his heirs, executors, or administrators be no way charged or forced by law or other ways through my default to maintain whole or in part our father and mother aforesaid."

**Samuel TERRILL**, second son of John, was born April 2<sup>nd</sup> 1678. He married (1)**Mary SMITH**, daughter of **Walter**, November 4, 1707; (2)**Abigail BALDWIN**, August 17, 1710. They had at least 5 children – **Samuel**, August 31, 1708; **Jesse**, February 5, 1711; **Mary**, March 16, 1713; **Abraham**, September 14, 1715; **Phineas**, 1725; and perhaps others.

**Phineas TYRRELL**, son of Samuel, was born in 1725 (?). He married **Phebe OATMAN** of Stratford July 7, 1747. U. S. census of 1790 lists Phineas in Woodb ridge town and "six males under sixteen." According to *Genealogical and Family History*

*of the State of Connecticut, Vol IV*, (1911) Phineas, born about 1730, settled at Seymour, Connecticut and lists the following children: **Eliakim, Phineas; John, Phobe**, and **Ann**. Phineas died in 1791 predeceasing Phoebe, his wife, who died in 1803.

“**Eliakim TYRRELL**, son of Phineas, was born April 10, 1760 at Seymour Connecticut, died March 15, 1807. He married **Elizabeth**, born February 10, 1760, daughter of **Joseph and Eliza TWITCHELL**. Children: **Philo**, Aug 5, 1780, married **Fannie UNBERFIELD**; **Josiah**, March 12, 1782; **Truman**, November 23, 1784; **Elizabeth**, January 25, 1786; **Nehemiah**, June 24, 1788; **Amy**, November 26, 1791; **Eliakim**, January 6, 1793 married **Chloe MARTIN**; **Phineas**, April 20, 1794, saddlemaker; **Solomon**, July 23, 1797; **Isaac**, April 27, 1800; **Andrew**, August 12, 1802; **Julia**, July 12, 1805.” *Genealogical and Family History of the State of Connecticut* U. S. census 1790 lists Eliakim in Woodbridge Connecticut, with 5 white males under 16 and 2 females. Nehemiah, age 2, would be included in this listing. Of Eliakim’s military record, the Adjutant General’s Office, Hartford, Connecticut, by Colonel **K. F. CRAMER** (September 1, 1939) states: “The name **Eliakim TERRILL** appears on the records of this office as follows: Private in 3d Company, Captain Samuel PECK’s from Milford, in 5<sup>th</sup> Bn, **WADSWORTH’s** Brigade, Colonel **William DOUGLAS** commanding. Battalion raised June 1776 to reinforce **WASHINGTON’s** army at New York: served in City and on the Brooklyn front; engaged in retreat to New York August 29-30; stationed with militia brigade under Colonel **DOUGLAS** at Kip’s Bay, 34<sup>th</sup> Street on East River, at time of enemy’s attack on New York, September 15<sup>th</sup> and forced to retreat hurriedly; at battle of White Plains, October 28. Term expired December 25, 1776.”

**Nehemiah TYRRELL** was born in Woodbridge, June 24, 1788. In September 15, 1851, in “his book,” he wrote New Haven as his address (Woodbridge is a suburb of New Haven). He married **Mary BURRITT**. To Nehemiah and Mary TYRRELL were born four children: **Mary E.**, November 21, 1812, died young; **Henry**, October 30, 1815; **Mary A.**, February 26, 1818 and **Charles**, August 18, 1822.

**Henry TYRRELL** was born in Connecticut October 30, 1815. He married **Jeanette WOOSTER** of Derby, Connecticut, March 29 1836. They moved from Litchfield, Connecticut to Racine, Wisconsin, in 1843. The census of 1860, 1<sup>st</sup> Ward, Racine, Wisconsin, lists Henry as a grocer. Later he became interested in a small sawmill and timberlands in northern Wisconsin and probably lost heavily in this venture. The same census (1860) shows Henry and wife, Jeanette, and six children: **Frank** age 20 male, teacher, born Litchfield, Connecticut, **Ahira**, age 17, male born Litchfield, Connecticut, **Jennie**, age 15, female, born Racine, Wisconsin; **Julia**, age 9 born Racine, Wisconsin; **Charles**, age 6, male, born Racine, Wisconsin; “**Willie**”, age 2, male, born Racine, Wisconsin.

Upon the death of his father, **Henry**, December 24, 1875, the oldest son, **Frank**, wrote as follows to his uncle **Charles** in Ansonia, Connecticut: “He passed away seemingly without pain or struggle, his life going out like the extinguishing of a lighted candle .... The funeral was largely attended by the old settlers and the Masonic fraternity by whom the remains were buried

with Masonic Honors in accordance with the expressed wish of Father during his last sickness.”

His wife, **Jeanette**, moved to Delavan, Wisconsin, to live with her married daughter **Jennie**. Later she resided for a time with her son, **William**. She died March 13, 1905, at the home of **Frank TYRRELL** in Whitewater, Wisconsin.

**William Hull TYRRELL**, sixth child and youngest son of Henry, was born November 8, 1857. He came to Delavan, Wisconsin from Racine, probably in 1878, and started to work for **Jamin H. GOODRICH**, his brother-in-law, in J. H. G.’s grocery store on Walworth Avenue. **J. J. PHOENIX**, W. H. TYRRELL’s future partner in business says, “W. H. TYRRELL was a ‘gay young blade.’” His widowed mother came to Delavan and lived with her daughter, **Jennie Goodrich**. William married **Allie BRADLEY**, daughter of **W. W. BRADLEY**, and sister of **Eva** (who later married **J. J. PHOENIX**) on December 24, 1879. His mother came to live with him on the corner of Walworth Avenue and Fourth Street. William was an extrovert, lively and full of fun. He loved to dance – had a song for all occasions – could do a jig or two – and frequently did!

He became associated with **W. W. BRADLEY** who had a tailor shop and small store; was later joined by **J. J. PHOENIX**, and together these three developed the outstanding retail store in Walworth County, **W. W. Bradley & Company**. Tyrrell and Phoenix were aggressive, public spirited citizens. They took the lead in all community affairs – were instrumental in promoting the **Water Works** in Delavan, the **Electric Light Company**, paving, etc.

William was a good trader and made many real estate deals in connection with his father’s modest estate and with the dry goods and clothing business in which he and his partners were interested. He was a remarkably able salesman and refused good offers from several wholesale clothiers, preferring to stay in and help develop his own community. In 1905, by a series of trades and investments, he and J. J. Phoenix came into control of the **Globe Knitting Works**, which had moved to Delavan some years before. The name was changed to **Bradley Knitting Company** and the product sold to retailers only. During the succeeding quarter of a century this became one of the largest and most important knitting mills going to the retail trade.

He was a charter member of Lodge #59, Knights of Pythias, Delavan.

William died June 6, 1937, leaving two offspring, **W. Bradley TYRRELL** and Mrs. **Esther McDonald**.

Among the notable “homecomers,” probably the most unusual group will be the Tyrrell “boys,” Franklin, Ahira, Charles and William whose combined ages are 308 years, or an average of 77 years. Franklin Tyrrell, the eldest is 86 years, Ahira is 83, Charles is 71 and William H., the youngest is 68. Franklin and Ahira Tyrrell were born in Litchfield, Conn., but came to Racine with their parents Henry and Janet Tyrrell in October 1843, five



years before Wisconsin became a state. The other two were born in Racine. Ahira Tyrrell continued his residence in Racine longer than the rest of the family having lived here continuously for 65 years. The original family home of the Tyrells was in "Sage" town on Huron street. Ahira Tyrrell lived for many years at 1520 Wisconsin street. He is the father of Henry H. Tyrrell, register in probate of Racine county under the Judges Belden and now located in Milwaukee.

Franklin and Ahira Tyrrell live at Whitewater, Wis. Charles H. Tyrrell is located in Los Angeles, Calif. And the home of William H. Tyrrell is in Delavan, Wis.

The Tyrrell group unbroken by the passing years will be guests of Henry F. Tyrrell during the home coming week at Racine Country Club on whose campus they will find their old swimming hole from the well-known Wisconsin farm. These former Racine residents will find . . . [last sentence not legible *DFB*]

**WALLACE BRADLEY TYRRELL**, college administrator; born Delavan Wisconsin, October 9, 1883; son of **William Hull** and **Allie BRADLEY T.**; A. B., Beloit College, 1906; married **Kate P. ROOT** July 25, 1907; children – Katherine Bradley (Mrs. Robert M. Welsh); William Root (deceased); Nancy Elizabeth (Mrs. Leslie J. Kuplic), Wallace Bradley; John Jay.

Production manager and vice president Bradley Knitting Company (Delavan, 1907-18); director sales and advertising, 1919-26, 1931-32; advertising business, Chicago, 1934; life insurance, 1935; Home Office Agency, Washington National Insurance Company, Evanston, Illinois, 1936-38; vice president Beloit (Wisconsin) College 1938-42; acting president, 1942, president (ad interim) 1943; vice president and treasurer since 1944; trustee 1920-38 and since 1942.

Member Logan-Saharl Beloit College Expedition to Africa 1925. Treasurer of School Board, Delavan, Wisconsin, 1920; president Walworth County (Wisconsin) Y.M.C.A. 1924; director Army-Navy Y.M.C.A. ## **TO CALIFORNIA IN AKHAMOUK**

(A Letter to Eastern Friends from San Diego, August 24, 1926)

The trip to California was decidedly worth while. Now that ten days have elapsed, certain rough spots have completely faded and only interesting memories from Wisconsin to this golden land of sunshine remain. But I would not have you think there were too many rough spots. Most of them were negotiated, I hope, without my precious passengers knowing much about the dangers; yet when there is only one man in the party and he accepts full responsibility for seventy-three hundred pounds of weight in a package much too large for many of the roads, that chap is privileged to feel that he has done an autumns job in full measure. But I enjoyed it thoroughly.

Southern California, of course, ended our journey. But if you have not seen the Black Hills put them on some future itinerary. They are delightfully interesting. You can appreciate that they impressed us to mention them after going through so many lovely places later. In the Far East they would be mountains, but in this land of great upheavals they seem but hills. And as one skirts them in late afternoon, he sees at once why they are called Black. We spent an extra day there, beside a rushing brook of blue mountain water.

The road across Wyoming is dusty but fairly good in dry weather. We were able to make very excellent runs except on detours. For part of an afternoon we were in the bad lands. I stopped for half an hour and the children raced over the reddish grey hummocks like the healthy Indians they are. Whatever this wry face of Mother Nature may lack in other respects, it held high potential to them as a place to coast.

The children can tell you exactly how many Cow Boys we saw in Wyoming and whether they compared more-or-less favorably with those we feast our eyes on in the movies. Certainly Hollywood's "cow hands" could be no more picturesque than the all-wool-and-a-yard-wide punchers of the range. On the whole I think the children concluded that a certain group who rode up one Sunday morning to play poker in front of a certain village store in Montana were nearest cinema form. We watched the same while the proprietor of the place froze ice cream of rich red hue by the side of the players and the brine ran undiked across the gaming table.

One of the many stickers on Akhamouk's plate glass front bears witness to the fact that we filled up with gas one day at Arvada on the Powder River. We wondered why the price of gas need be thirty-nine cents a gallon, for the match from my cigarette ignited the water in the horses' trough much to our surprise and amusement. Thus we learned by chance how the river got its name.

Another day we passed Buffalo Bill's ranch and that noon ate lunch in the public park named for him in Cody. The children spent an hour of awe in the little museum amongst relics rich in the lore of earlier days and that afternoon we started our climb into Yellowstone.

What a riotous time the Gods of old must have had in that place of wonders! And what a wonderful time the people of America are now having in the same spot. Thousands of vacationists during the summer went in and out each day, and a goodly portion of them roughed it. At Old Faithful Camp there were over four hundred automobiles the night we drove in. The manager of the hotel there told me it was becoming a matter of some concern to the hotel manager for while there are more park

visitors each season, the hotel business is falling off. Auto tourists, apparently, carry their own with them, just as did we. We went north from Gardner through Livingston and Great Falls. The latter two cities are modern, lively and made a splendid impression on me. The spirit of Montana men is wonderful, for after years of drouth and crop failue, they are optimistic. The crops there are spotty this year. I talked with one farmer -- an ex-Badger -- who hailed us when he saw the license plate and he expects thirty-five bushels to the acre. The next valley, however, was dry and parched. Wherever they have irrigated, prospects are excellent.

We are all glad we went to Glacier, in spite of the terrible detours. It is like Switzerland on a grander scale. We hiked to the foot of Grinnell Falls and rode horseback over narrow, twisting mountain: trails to Iceberg Lake.

We saw elk, deer, bear, Mountain Sheep. We fed crumbs from our lunch to precocious ground squirrels and we caught glimpses of strange birds of beautiful plumage.

We camped at Many Glacier, St. Mary's and Two Medicine, [locations in Glacier National Park] spending most of our time at the first named. At Glacier Park we put up at the hotel for the first time on the trip, and reveled in such luxuries as linen and tub.

But you must not conclude from this that here we took our first bath! Most tourist camps have showers. The term is quite inadequate, however. There should be a classification of shower baths and a thorough revision of the nomenclature. Under the present scheme of things anything that will belch or drip cold water, muddy or otherwise, upon the head of a dusty traveller, shivering in a fence corner, is farmed a shower. How many crimes are committed in that name!

From Belton [Montana?] to Bonner's Ferry [Idaho] we continually dodged forest fires. At one spot the pumps were only three wiles from us and we could plainly hear them. Of course, the smoke was very thick. We missed many wonderful views because the air was so heavy and for several days Old Sol was merely a big red ball in the sky.

The roads were improving as we approached Los Angeles and San Diego and for the most part we sailed along on highways through Spokane and south to Walla Walla. The trip south through Washington was a revelation. We passed by thosands of acres of ripe wheat where great combination harvesters and threshers were being pulled by huge tractors or dozens of horses. Whitman County modestly proclaims on road signs that it fills the world's bread basket. When they bring out fifty to sixty bushels to the acre as they were when we passed through, it would seem the county is doing its share.

The Columbia Highway properly ranks high in the world's most famous scenic drives. For nearly two days we drank in all the glory of the countryside when the smoke would permit, for even there they suffered from the terrible forest fires.

Welcome letters and telegrams were waiting for us at Portland and again at Los Angeles. These and the sudden departure of the cook stand out as high lights, for we were at Portland only over night. By this time all of my passengers were anxious to get to San Diego, even though the children had never been there. So we hurried on south to Grant's Pass. This was familiar ground,

for some years back I had made the trip in a Flivver [Model T Ford].

Grant's Pass to Crescent City to Eureka looks easy on the map. But one must not depend on caliper in scheduling this trip. Only the tremendous experience of insignificance when twisting and turning through a forest of Redwoods, many of them older perhaps than Christianity itself, saves one from cursing the roads. South from Eureka the roads are marvelous and even then one gets more than a day's journey through the forest.

Just as we were within reach of the ferry at Sausalita the lights flickered, the engine stalled and Akhamouk rolled up to the curb exhausted. I heard a strange sizzling sound and, glancing down in the direction of this new noise, beheld a "forest fire" of our own beneath the car. Any driver can imagine how quickly I hustled the occupants out of the all too narrow door. Grabbing the trusty extinguisher, I tried to put out the blaze by lying on my back and squirting the thing upward, but found that I was getting more of it in my eyes than on the flames. Then I pulled up the floor boards and put it out in a jiffy. A wire from the battery had rubbed so insistently against the frame of the car that a short had resulted and before I could get to it had welded itself firmly. This, I think, was our most exciting moment.

Good roads and excellent schools line and dot California in a way I never had seen before, and throughout our journey south from the Oregon line to San Diego our wheels seldom touched dirt. Good roads have become a fetish with Californians. They spend more and more money each year on them, but that's part of the upbuilding of this wonderful civilization out here. Easy and quick transportation makes everybody in the west neighbors.

We like Southern California. Each day brings new experiences and acquaintances, yet a short sojourn is hardly enough to crystallize one's impressions. But somehow I can't help feeling that the blue of the Pacific and the purple of distant hills hold enduring as well as endearing qualities.

Akhamouk rests contentedly in a park lot with a "For Sale" sign hung on its hood.

[Apparently *Akhamouk* was a name that Mr. Tyrrell picked up during his African expedition and attached to the vehicle (described in the first of the letter as "seventy-three hundred pounds of weight in a package much too large for many of the roads," and later above as "the car") that he used for this trip. There were 2 photos in the original, but they did not reproduce well enough to tell what either might be. *DFB*]

## TERRELL ENLISTMENTS IN THE REGULAR ARMY 1798 THRU SEPTEMBER 1857

Copied by Don C. Terrill

The following data is copied from "Registers of Enlistments in the United States Army 1798-1914," National Archives Record Group M233. Each record consists of a one-line entry, and even those entries may have substantial data missing. Such information as is recorded is here included. The "Remarks" section is taken almost verbatim from the "Remarks" column on the original Army journal. Dates have been reformatted to make them more readable. Some abbreviations have been spelled out for readability.
