TERRELL TRAILS has been printed by offset printing since the mid 1980s. The cost is less than quick copy. The bulk of the printing costs is for making plates for offset printing, the number of issues printed after the first one is reduced almost to paper cost. The only way to reduce this printing cost is enough to matter is to reduce the number of pages. If we cut back to 20 pages per issue instead of the current 30 pages, it will reduce our costs about \$400.00 per year. This won't make up the \$700.00 per year that we are currently losing, but it will help.

We have a suggestion to e-mail issues to members who have the equipment and connection to accept it that way. E-mailing issues to members who will accept it will eliminate the bulk mail benefit. If we continue the 30 page issues, we could only mail about 100 copies of each issue by first class mail for our current postage cost.

That would require stopping all free publicity copies and having at least 50 members receiving TRAILS electronically. Also, my email limits each outgoing message to a maximum of 25 recipients in an effort to reduce SPAM. Therefore, those receiving TRAILS

via e-mail will have to be divided into groups of 25 or less.

PDF is not necessary for emailing the issues. They could be sent as .HTM or even .TXT, but would lose the page formatting. Sending it as .RTF would keep the formatting, but the member would have to use WINDOWS or some other software that can read that format.

PDF requires downloading the current Acrobat Reader to view. That would still leave us with 'Quick Copy' hassle and costs on those who want hard copy.

Another possibility is to upload each issue to the web site and let members download it from there. The only catch is that we will either have to assign a member access code to restrict entry to the issue or anyone who accesses the site can download it FREE! With our current restrains of 3MB, we could have only one issue at a time on the web.

Mr. Marshall observed, "I noticed in my Maryland Genealogical Society bulletin that hourly research rates for members are \$20 (non-members are \$30). My opinion is that if I can get some genealogy data from someone just from being a member (e.g., from

TRAILS) it is worth at least \$20 per event. It might even be interesting to suggest that members send in whatever they want (say \$5) in their next renewal (as a donation) for each event that they feel has helped them. Since I only have two societies that I am a member of it would not be a big deal for me, but some people might object to that (particularly since people provide free advice on Genealogy sites on the web). I personally look at how much effort it would be to travel to a place and what that would cost and if you put a dollar amount to that it would be in the hundreds. Suggesting an additional donation for help received through TRAILS might bring in a little revenue."

There is the possibility of putting a charge upon the services that Don & I do "Free" at the present time. Don freely shares his info and as far as I know the donation only one that as been made by recipients of his generosity.

I routinely copy bits from TRAILS back issues when someone wants to know what is said about a specific person on a specific page in TRAILS and e-mail that info back to them. I also search the database that I created to publish the "Gems" series from for the same individual if the time frame is right. This is done with the hope that they will appreciate the info and join us. Very few have joined us.

I may be able to put a lot of the data that I have not been able to publish in TRAILS into searchable data base and offer it for a fee. However, I have tried that once or twice in TRAILS in the past and have not had any takers.

Mr. Marshall asked, "As far as reducing pages would any of these suggestions help?"

a. "Making it one column wide. This may not reduce pages, but makes some lineage easier to read. Although, as I'm looking at the latest one, some of this might look uglier."

In most cases, changing from one column to two columns actually reduces the number of pages required for the same information because it eliminates the space wasted at the end of short lines such as lines containing only name, DOB, DOD, etc.

However, if we are to convert to either .TXT or .HTM and make TRAILS available on the web, we

will have to go with one column because WORD automatically does only one column in those conversions. Two columns cannot be done in .TXT under any circumstances. Two columns can be done in .HTM only if the info is first placed in page length or shorter tables. This is too time consuming for me with my limited computerize.

b. "Queries are good to print right away, but if we decided to cut down on pages, you could defer some articles (for example, old obituaries or historical facts) or maybe put them on the TSA web page and reference them (maybe change them every quarter)." Deferring material has brought me to the point where I have enough material in hardcopy and in the computer to publish TRAILS for the next 20 years or so. I would like to see this material put into concise hard copy and made available to the researching public before I die.

Putting info on the web site will make it available to everyone who can access the site, but it will not be available to those who either are not computer literate or who do not have the equipment to access our web site.

c. "Maybe consolidate the CHANGES section (just list name and member #). If we had a secure way to access the TSA web page and members didn't mind we could put that info there."

CHANGES is not a big section in most issues. If you will check, you will find that it is not in every issue. Usually there is less than one column of members who moved or changed e-mail addresses. In some issues I extended it with obituaries etc. but I believe these instances have been rare.

No one has suggested reducing the type size to get more info into fewer pages. When we started, I tried reducing type and cramming as much as possible into each issue. I was quickly informed that some of our members were not blessed with my eyesight and that they would prefer a larger print. Since that time, I have done most of trails in 12pt type. In some instances involving long articles, I have used 10pt but I try to stay away from anything smaller. IF the membership will agree to electronic issues either directly by e-mail or on the web site, we can use smaller print

and they can convert it to whatever they prefer after they receive it.

That would still leave us with the same dilemma with members who need a printed copy.

In summary, I see only three ways of extending the life expectancy of the TERRELL Society of America, Inc.:

1. Reduce pages from 30 to 20 beginning in 2007;
2. Raise dues;
3. Recruit our TERRELL relatives and increase membership. That is the purpose for which the postcard applications we mail with most issues are intended.

GENEALOGY? ASK DAN!

Q. Can you please tell me what the Terrell Society's stand is on the line of descend for **Robert TYRRELL** 1594--1643? My searches so far have yielded two different opinions:

From Robert & Agnes of West Hagbourne, Berkshire
From George & Elizabeth (Montague), Thornton,
Buckinghamshire

A. The TERRELL SOCIETY, as an organization, does not have an official opinion on anyone's ancestry. Our goal is to collect, preserve, and distribute information as it becomes available to us. We hope this information will be sufficient for you to form your own opinion.

As for Robert of Reading, ENGLAND, there are two conflicting theories as you have outlined.

1. Robert & Agnes of West Hagbourne, Berkshire Co. ENGLAND, or
2. George & Elizabeth MONTAGUE, of Thornton Hall, Buckinghamshire, ENGLAND.

My personal opinion is that #1 is correct. The reason for this is a group of wills that were rediscovered during the mid 1990s by the TYRRELL FAMILY HISTORY SOCIETY in England. [I say rediscovered because BARNHILL listed some of them in her 1934

book, but probably did not have access to the actual wills or any knowledge of their content.]

The wills of the brothers in these generations named other brothers in various capacities. Also, these brothers were in related businesses, Robert was a tailor; another was a broadweaver, and another a leather merchant, etc. Members of the English Society concluded that this lineage is valid. They published information stating that in their newsletter and we have republished it in TERRELL TRAILS.

Theory #2 was "created" by **Joseph Henry TYRRELL** in England before 1910 for **Edwin Holland TERRELL** of San Antonio, TX. J. H. TYRRELL had completed a book on his line of TYRRELL, ie, the Irish lineages when Edwin met him in England about 1906. Edwin was U. S. Ambassador to Belgium at the time. The opinion -- that Robert must have been an undocumented son of George -- led to documented lineage back to kings. Both BARNHILL and DICKEN along with several others based their writings upon the information secured by Edwin Holland TERRELL. That information is still in print in our library volumes, but in my opinion is incorrect. Until the mid 1990s, we did not have any conflicting evidence to challenge the 1910 theory.

J. H. TYRRELL documented nothing -- neither in his book, nor in the information that he provided to **Edwin Holland TERRELL**. His writings consist of nothing more than a series of descendant charts with names and some dates.

One could sit down at the dining table and create such a work on any chosen surname in a few weeks based totally upon the whim of the author, publish it as fact, and without evidence to the contrary, no one would detect the fabrication.

Ancestors of Richmond TERRELL

Generation No. 1

1. Richmond TERRELL^{1,2,3,4}, born 7 Mar 1796 in Georgia; died ca. 1852 in Iberville Parish, La.. He was the son of **2. Richmond TERRELL** and **3. Mrs. Sarah LISLES**. He married **(1) Marie Adelaide La VERGNE⁵** 30 Jan 1826 in St. Gabriel, Iberville Parish, La.. She was born 1807, and died Bef. 1850.

She was the daughter of **Pierre La Vergne** and **Genevieve HERBERT**.

From War of 1812 personnel records: Richmond TERRELL, 8th Regt. (Meriam's) La. Militia, entered Private, ended Private. Appears on muster roll for Capt. **Jacques De VILLIER's** Co of Inf., 8th Regt. La. Militia, for 26 Dec 1814 to 4 Mar 1815, roll dated 4 Mar 1815 at Donaldsville, La., rendezvoused 26 Dec 1814, discharged 4 Mar 1815, remarks: "Sick at home" Remark on muster: "The men in Capt. Jacques De Viller's Co reported sick at home were actually on command at Lafourche, they were reported so from ignorance of the Captain, and they have actually performed the service charged for on their rolls." Appears on pay roll for same date, term of service 2 mo. 9 days, pay rate \$8.00/mo., amount of pay \$18.32.

From National Archives Mexican War records: Co I, 2d La. Militia Vols., **Richmond TERREL**, entered Private, ended Private. Appears on muster-in roll for Capt. Rousseau's Co, 3d Regt. (Dakin's) La. Militia (subsequently became Co I, 2d Regt. (Dakin's) La. Vol. Militia) dated 12 May 1846 at New Orleans, enrolled 12 May 1846 at Iberville for 6 mo., age not shown. Appears on muster-out roll dated 8 Aug 1864 at New Orleans.

Generation No. 2

2. **Richmond TERRELL**^{6,7,8,9}, born 1759 in South Carolina or Virginia; died 1815 in Iberville Parish, La.. He was the son of 4. **John TERRELL** and 5. **Elizabeth Harrison**. He married 3. **Mrs. Sarah LISLES** 22 May 1796 in Warren Co, N.C..

3. **Mrs. Sarah LISLES**, born 1747; died 25 Dec 1840.

Dicken: There was a **Richmond TERRELL** b. 1759, a Revolutionary soldier in North Carolina troops, who may have been a brother of **Joel TERRELL**. He was in Warren Co adjoining Franklin where Joel lived. We do not have positive proof that they were brothers. The military records show that Richmond TERRELL was a private in Capt. McRee's Company of the 6th N.C. Regiment on 16 Apr 1776, enlisted as No. 2703. Capt. McRee was transferred to the 1st N.C. Regt., and it appears that in June 1778

his company was placed under the command of Col. Thomas Clark, who had earlier been Captain (Heitman, p. ?). Richmond TERRELL therefore must have served under both officers Clark and McRee, both of whom were taken prisoner at the capitulation of Charleston 12 May 1780. (Heitman, p. 158). In Ramseys Vol. II, p. 321), it is mentioned that 500 of the soldiers were sick in camp when Charleston capitulated. In some records copied in England and now in the possession of the D.A.R. Library in Washington D.C. were names of soldiers taken prisoner by the British at the capitulation of Charleston, and at Gates Defeat at Camden 16 Aug 1780. Among them was Richmond TERRELL, 21 years of age, 5 ft. 4 in. tall. The Revolutionary accounts show that a Richmond TERRELL who served in McRee's Company was paid £131:2:6 for his services. The payment was made at Warrenton, in Warren Co, N.C. in 1786 (Vol. 17, p. 254, St. Rec. of N.C., Vol. XV, p. 719).

By the census of 1790, Richmond, Sarah, and the Martain children seem to have moved to his home town in Union Co, S.C. By 1806, Sarah and her oldest daughter, Nancy, were living in Franklin Co, Ga.

LeBlanc: Richmond TERRELL was born in 1759 in South Carolina or Virginia ("Brown-Terrell Genealogy," 1876, unpub., p. 3) and died in 1815 in Iberville Parish, La. (Ibid., p. 32). He married Sarah Ann LISLES in 1792 in Warren Co., N.C. ("They Came to Iberville" by William Dosite Postel¹). They "moved to Louisiana ... in 1802 ... They first landed at Baton Rouge, but on account of some disagreement with the Spaniards, who were yet in possession of this portion of the Territory, they were compelled to remove beyond the Spanish limits, and thence located on Thompson's Creek in West Feliciana, and there remained until after the cession of Louisiana to the United States (December 1815). Richmond TERRELL, the father, being of unstable mind, was never satisfied long in one locality, consequently he made a number of moves within the State or then Territory before his death which occurred about the year 1815 in the Parish of Iberville." ("Brown-Terrell Genealogy")

LeBlanc: "The story begins with the courage exhibited by a remarkable lady, **Sarah LISLES**, who lived to the extreme age of 93, dying at the home of her daughter, **Rebecca Kuhns**, on December 25, 1840. Sarah Lises first married **John MARTAIN**

by whom she had several children. During the Revolutionary War, while her husband was fighting the British under **Francis MARION**, Tories entered her home and ransacked it looking for money and valuables. She defied them successfully, promising reprisals upon the return of her husband." ("They Came to Iberville," p. 13 et seq.)

- i. **John TERRELL**^{10,11,12,13}, born 5 Sep 1793 in Franklin Co, Ga.; died 1856 in Iberville Parish, La; married **Marie Eugenie LAMBREMONT** 23 Jan 1823 in St. Gabriel, Iberville Parish, La; born 17 Oct 1794 in St. Gabriel, Iberville Parish, La.; died ca. 1857 in Iberville Parish, La.

From War of 1812 personnel files: John TERRELL, 8th Regt. (Meriam's) La., Militia, entered Private, ended Private. Appears on muster roll of Capt. David C. Hatch's Co of Inf. 8th Regt. La. Militia, for 27 Dec 1814 to 4 Mar 1815, roll dated 4 Mar 1815 at Donaldsonville, La., rendezvoused 27 Dec 1814, discharged 4 Mar 1815. Appears on pay roll for the same period, term of service 2 mo. 8 days, rate of pay \$8.00/mo., amount of pay \$18.06.
- ii. **Rebecca TERRELL**^{14,15,16,17}, born Jan 1795 in Franklin Co, Ga.; died 25 Sep 1853 in Iberville Parish, La; married (1) **Nathaniel CROPPER** 14 Aug 1809 in St. Gabriel, Iberville Parish, La; born Bef. 1790 in Maryland; died ca. 1827 in Iberville Parish, La.; married (2) **James JOHNS** ca. 1827 in Iberville Parish, La.
- 1 iii. **Richmond TERRELL**, born 7 Mar 1796 in Georgia; died ca. 1852 in Iberville Parish, La; married **Marie Adelaide La VERGNE** 30 Jan 1826 in St. Gabriel, Iberville Parish, La..
- iv. **Lucinda TERRELL**^{18,19}, born 17 Feb 1800 in Georgia; died in (probably) Iberville Parish, La; married (1) **William WOOTEN**; married (2) **Josiah BROWN** 3 Jan 1822 in St. Gabriel, Iberville Parish, La; born 26 Mar 1789 in North Carolina; died 4 Mar 1838 in

Iberville Parish, La..

- v. **Elizabeth TERRELL**^{20,21}, born 20 Jul 1802 in Iberville Parish, La; married (1) **Needham Nathan BRANCH** 11 Oct 1818 in St. Gabriel, Iberville Parish, La; married (2) **Samuel E. LAWES** ca. 1828 in Iberville Parish, La.

Notes for Elizabeth TERRELL: LeBlanc: No doubt there was a prior civil marriage or marriage under Protestant auspices; his marriage date reflects Roman Catholic church records only.

Generation No. 3

4. **John TERRELL**^{22,23,24,25,26}, born Bet. 1705 - 1710 in New Kent Co, Va.; died Aft. 20 Sep 1783 in Franklin Co, N.C.. He was the son of **8. William TERRELL** and **9. Susannah Waters**. He met **5. Elizabeth HARRISON** in Caroline Co, Va..

5. Elizabeth Harrison, born in Virginia; died in North Carolina.

Dicken: "On 29 July 1761, Lord Granville granted 700 acres of land to **James TERRELL** in Granville County, North Carolina. Land on the north side of Tar River, and on both sides of Mill Run. (Ibid 9, p. 32.) In 1764 **James** sold this land to his brother, **John**, who had settled in North Carolina about 1743. It is believed that if James TERRELL ever moved to North Carolina, he did not stay very long."

John and Elizabeth were never married, and John was disowned by the Quaker church for living with Elizabeth. John Sr.'s family Bible does not list son Richmond, and his inclusion on this list is speculative (see Dicken p. 277).

Researcher Allen: John was called into court for his relationship with Elizabeth Harrison. It was reported that he had taken Elizabeth into his home, even though he had a wife, Sarah TERRELL. [Caroline Co Order Book 1737, p. 460] Three children were born to John and Elizabeth out of wedlock. Each time, John and Elizabeth were tried by the court and placed under a bond of £50 not to meet. Even this did not stop them, and they left the Virginia Colony in 1738 [Caroline Co Order Book 1741, pp. 41-42]. The court was forced to bind out the 3 children to be raised by other families [same, Order Book 1741, p. 437]. They would be required to help with

the family to pay for their upkeep. Finally, in 1749, Sarah TERRELL asked the court to allow her separate maintenance from her husband [same, Order Book p. 425]. John sold land in Caroline Co in Mar 1741 (same Order Book 1741, p. 93) and in April of the next year (1742) the chancery court ordered John to place two Negroes, Beck and Amey, and one grey mare in the possession of **John MAULDIN**, in trust for **Sarah**. She was to "receive the profits from these for her maintenance during her separation and until she shall cohabit with the defendant or until the time of her death." [same Order Book 1742, p. 100]. It would have taken an act of the General Assembly to have granted her a divorce, but the county court could grant her separate maintenance. Sarah was granted permission to take over her husband's estate because he had "fled the colony" with Elizabeth HARRISON. A number of the citizens of the colony of Virginia, who did not feel they could comply with the marriage laws of the colony, went to North Carolina to live.

From "TERRELL Trails" pp. 1076-1081 (Spring 1997, Vol. 13, No. 1), submitted by Mr. James M. Allen Jr. (Rocky Mount, N.C.), from N.C. Archives, Wilkes Co. Wills 1778 to 1948 (and printed again in his 1998 book):

The Will of John TERRELL:

In the name of God amen I **John TERRELL** of the County of Franklin in the State of North Carolina being somewhat in Disposed in body but of perfect sence & Memory thanks be to God for his Mercies but knowing the frailty of human nature & that it is Decreed that all men must surely die do make & ordain this my last will & testament as followeth that I give & bequeath my soul to God who gave it & my body to the Earth to be Decently buried at the Discretion of my Executors & as to my worldly Estate:

I give and bequeath to my reputed wife Elizabeth who is called & known by the name of Elizabeth TERRELL with whom *I have Cohabitated ever since ... my furniture I desire is then provided 5 Negro slaves to wit Mingo big Jack old Saul Lidia & Willy also my Mill on Sandy Creek & all my household Furniture & such of my stock as she may think fit during her life & after her Decease to be Disposed of as hereafter shall be Decreed.

ITEM I Give & bequeath to my reputed Daughter

Loruhimah born of the body of Elizabeth Harrison aforesaid reputed wife the Four Negro slaves towit Mourning Phebe Patch & after her mother's Death old Sal together with the said Negros increase.

ITEM I give & bequeath to my reputed son **Jeptha** called & known by the name Jeptha TERRELL born of the body of the aforesaid Elizabeth the labor of the 5 negro slaves following During his life & after his decease to his children as he shall think proper to them & their heirs forever to wit Sare & her child & their increase James & little Jack & after his mother Deceases big Jack.

ITEM I give & bequeath to my reputed Daughter **Anne** born of the body of the afsd Elizabeth the 4 following Negro slaves to wit Judy & her Child little Amy old Amys Child & little Jenny Lidias child together their increase to her & her heirs For Ever.

ITEM I give & bequeath to my reputed son **Joel** born of the body of the aforesaid Elizabeth 7 Negro slaves to wit Bob Sam Old Amys Child Amy old Sals child little Saul Peter & Priscila Sabine Lidias Children & after his mother's Death Lady I also Give him the plantation & tract of Land whereon I now live together with another tract adjoining thereto to Him & his Heirs & assigns for ever.

ITEM I give & bequeath to my Reputed son **Timothy children** called & known in his lifetime by the Name **Timothy TERRELL** born of the body of the aforesaid Elizabeth the 4 following Negro slaves towit Andi Buck & his increase Nat & after their grandmothers Decease Willy & his increase to be Equally divided among them as they come of age that is the boys to the age of 21 & the girls to the age of 18 It is also my will & Desire that the **widow of my reputed Son Timothy** shall have a childs part during her life that such part shall return to the children of said Timothy & be Equally Divided among them.

ITEM I give & bequeath to my reputed son **Johns children** who was called & known in his Lifetime by the name of **John TERRELL** begotten of the body of the aforesaid Elizabeth as followeth to his daughter **Elizabeth** one Negro Slave old Amy to her and her heirs for ever. To his son **Richmond** one negro Girl Lucie to him & his heirs for ever. Jepthah's will is dated in Granville Co, N.C. on 18 Nov 1809 and proved in Court Feb 1811 (Will Book 7, p. 147). From "The Raleigh Star" newspaper, 8 Nov 1810: "... Jeptha TERRELL, Granville County, North

Carolina on October 30, 1810 aged 77, brother of Hannah Bledsoe..."

Pascoe: Nov. 18, 1809 ... proved February Court 1811 ... Jeptha TERRELL Sr., wills to wife **Margaret** all my estate while she lives, then to my sons, **Patrick, John, Jeptha**; to son, **Solomon TERRELL** and daughters, **Obedience Mays** and **Hariet Davis** each 5 shillings. Execs: my wife, Margaret and sons, Patrick, John and Jeptha TERRELL. Witnesses: **Joel Ferguson Sr., and Jeremiah Bailey...**"

iii. **Hezekiah TERRELL**^{38,39,40,41}, born 15 Aug 1735 in Caroline Co, Va.; died Jul 1767 in Bute Co, N.C; married Phoebe Martin Bet. 1758 - 1759.

Dicken: Hezekiah TERRELL was a private in the North Carolina militia on April 30, 1754, in Capt. **Sugan JONES** company as shown by the muster roll. He was in the 8th Carolina Regiment on October 8, 1754, and again listed in 1756. (N.C. Colonial Records, Vol. XXII, Pg. 367, 377).

- iv. **John TERRELL, Jr.**^{42,43,44,45,46,47,48}, born 15 Nov 1737 in Caroline Co, Va.; died Bef. Sep 1783 in Franklin or Wake Co, N.C; married (1) **Susannah DOUGLAS** 17 Apr 1760 in Granville Co, N.C; born 1735; married (2) **Grace ?**; died Aft. May 1820.

In the S.C. Archives there is a memorial for a land grant to **John TERRILL** for 150 acres "on the northeast side of the Great Lynches Creek, on Sandy Run." The land adjoins **Jeptha VINING, John PERKINS** and **David PERKINS**, as noted in the Craven Co. Survey for this plat certified 26 Jul 1774, a memorial signed 6 Jan 1775. (For a complete transcript of this land grant see "TERRELL Trails" Vol. XIX, No. 1, pp. 1640-1641.) This land is in the southeast corner of Lancaster Co., and it is only a few miles from a later grant to **Richmond TERRELL** on "Lick Creek, waters of Lynches Creek." Surely this John Terrill is the father of William and

Richmond. John and family probably moved down to S.C. from the Johnson-Wayne Co. N.C. area (where most of the records are gone) about 1775. They had apparently come to N.C. from Va. The boys went off to war in 1778, and father John must have died before 1790.

Dicken: "Annals of Georgia," p. 94 gave "Liberty County Connections in South Carolina," from Probate records in Charleston. On 16 Oct. 1773 **Susannah TERRELL** qualified as administrator of **John TERRELL**. On p. 9, **Richmond, Elizabeth** and **Susannah TERRELL**, under 14 years, guardian appointed.

Clarke: John was in the Militia of Granville Co, N.C. on 8 Oct 1754 in Capt. Sugar Jones' Company, William Eaton's Regt. Clarke (quoting researcher McLaurin) quotes from the Early Deeds of Franklin Co, N.C. Book 6, p. 144 as follows: "**Benja. BURNETT** of Lancaster Co, S.C. appointed Capt. **Joseph Green HILL**, his atty., to recover and receive his legacy due from the estate of **John TERRELL Sr.** (late of Warren or Franklin Co and former of Bute Co) left in the hands of Jephtha and Joel TERRELL, exrs. of the said John TERRELL's estate, who was the grandfather of my wife **Elizabeth, dau. of John TERRELL Jr.** dec'd this 20 Feb. 1787."

John TERRELL Jr. would be this John (b. 1737). John TERRELL Sr. would be John (b. 1705-1710). This deed connects John as the senior member of the large TERRELL family arising in Lancaster Co, S.C.

In the "Annals of Georgia" (p. 94) gave "Liberty County Connections in South Carolina," from probate records in Charleston, S.C. On 26 Oct 1773, Susannah TERRELL qualified as administrator of John TERRELL. On p. 95, Richmond, Elizabeth, and Susannah TERRELL, under 14 years, guardian appointed.

- v. **Timothy TERRELL**^{49,50,51,52}, born 22 Jun 1739 in Ashe Co, N.C.; died Bef. Sep 1783 in (probably) North Carolina; married **Elizabeth**

? ca. 1772 in Virginia; born 24 Feb 1753; died 1 Nov 1814.

Some researchers say that Elizabeth's family name was SEXTON and others say that this is not correct. The surviving records are ambiguous.

Clarke: In "The Annals of Tennessee," p. 455, the author told of three men who were killed in the year 1781 in that section of Tennessee by parties of Indians, "in the fall **Timothy TERRELL** of North Carolina was killed." Dicken: After Timothy's death some of the family later moved to Kentucky.

- vi. **Ann TERRELL**^{53,54}, born 10 Jul 1741 in Ashe Co, N.C.; died Bef. May 1811; married **William MARTIN**; born 1732; died Aft. May 1811 in (probably) Wake Co, N.C.

Dicken: **Joel** (sometimes called **Joseph**) lived in John's former home in Franklin Co, N.C. Joseph/Joel was a Revolutionary soldier and proof of his service has been accepted by the D.A.R. Society. It is tradition that he was under Gen. **Francis MARION** and was one of eight survivors of one battle. In "Pension Roll, Senate Documents," published 1835, a Joel TERRELL who must have been the one from Franklin Co, under the Act of 18 Apr 1814, was granted a pension which was retroactive to Dec 18, 1813. However, Joseph/Joel

died shortly prior to 18 Feb 1815 when his estate was administered.

Allen: There was also another **Joel TERRELL** who lived in Rutherford Co, N.C. and had moved there from Albemarle Co, Va. He was placed on the Revolutionary War Pension Roll on 27 Dec 1816 under the Act of 24 Apr 1816. His death occurred 1819. Both made applications for pension at Raleigh, Wake Co, N.C.

Author: The Bill for Joel's pension was introduced in the 13th Congress, 2nd Session, House Bill 344; referred to the whole House 31 Mar 1814 and reported as H.R. 166 and passed by House and Senate 18 Apr 1814 and approved by the President for a pension of \$3.30 a month. National Archives, House of Representatives, Vol. 3, RG 233, HR 13A-B1, HR-166.

The Will of Henry TERRELL

In the name of God, amen - I, Henry TERRELL, Sr. of Caroline County, Virginia, do make and leave these following lines, my last will and testament, as followith, viz.

I lend to my well beloved wife **Sarah Woodson** [name supplied by **Lynch M. TERRELL**] during her natural life for the support of her, my children, and the rest of my family under her care five negroes named as follows: Goliath, Daniel and Jacob, men; Bess and Fanny, women, and twenty five head of cattle and colts, twenty five sheep, thirty head of hogs, and as much of my household goods and furniture and plantation tools as shall be thought needful for the support of her and my family under her care, by my executors and after her decease, the negroes Bess and increase and Goliath to be equally divided among my children by her, and the negroes lent and what lent her to be equally divided amongst all my children, their

heirs, etc.

I lend to my wife during her natural life my home, house, plantation, and three hundred acres of and with adjoining the same; and further. It is my desire that my wife have under her care, and for her assistance toward the upbringing and schooling of her children until they become of lawful age or marry, the negroes and land heretofore mentioned to them etc., and not to misuse or abuse any part or parcel thereof nor suffering it to be done. Second, I give to my son **George TERRELL**, his heirs and assigns forever at the age of twenty one years or marry all the land I had of my father and all the land I had of **Joel TERRELL** and all the land I had of **Roger QUARLES** that lies on the West side of a line to be run due North from mine and **Joel WOOLFOLK**, corner White Oak sapling by a great pine, the east side of a small branch or slash of Crooked Creek to mine and **Francis BURNETT's** line; all of the above said land is in Caroline County, and two negroes and their Increase to wit; Wheeler, a man, and Margaret a girl and twenty five pounds current money (he not molesting, nor suffering it to be done by any under him, his mother in her privileges alone mentioned) and I give George and his heirs forever all the land I had of Carl McGee.

Third, I leave to be sold by my executors my water mill and two acres of land thereto belonging: my Smith's tools or box of files, seven hogsheads of tobacco, three in Hanover County in the hands of **Joel TERRELL's son Henry**, and four at Conway's, all the surplus parts of my estate as they shall think proper, and the money put into interest until the legacies become due.

Fourth, I give to my son **Charles TERRELL**, his heirs and assigns forever, at the age of twenty one years, all the remains of land I had of **Roger QUARLES** and my Topping Castle Plantation and all my lands thereunto belonging, and two negroes, Mancer, a boy, and Nell, a girl, and her increase, and twenty five pounds current money.

Fifth, I give to my daughter **Ursula TER-**

RELL, her heirs, and assigns forever three negroes and their increase: Blackah, a woman, Simon, a boy, and Lymus, a boy, and twenty five pounds current money on the day of her marriage or lawful age.

Sixth, I give my daughter **Judith TERRELL**, her heirs and assigns forever when of lawful age or marriage, three negroes and their increase, Patts, a woman, Hannah, a girl, and Ned, a boy; and twenty five pounds current money.

Seventh, I give to my daughter **Abigail**, her heirs and assigns forever when of lawful age or marriage, three negroes and their increase: Polly, a woman, Tamer, a girl, and London, a boy; and twenty five pounds current money; and my desire is that if any of the above mentioned children die under age or not married, their part of the estate, as well land as other estate, be equally divided amongst my living children by my last wife their heirs and assigns forever.

Eight, I give to my daughter **Ann Lynch** and her heirs forever, besides what I have given her before, one negro by named Abraham.

Ninth, I give to my daughter **Betty Moor-**
man, to her heirs, and assigns forever, besides what I have already given her before, one negro girl now living with her called Viles and her increase.

Tenth, I give to **Menoah CHILES, Sr.** - bro. of his 1st wife **Ann Chiles** - and assigns forever just as he hat devised in his last will one hundred and eighty three acres of land, part of the land I recovered of **John CHILES**; in consideration he, the said Menoah, his heirs and assigns performing faithfully the agreement made with John Chiles the 11th of June last, which one hundred and eighty three acres aforesaid are bounded according to the said agreement which is in my house.

Eleventh, I give to **John CHILES**, son of Micajah Chiles decease, to him and his heirs forever seventy acres of land or thereabout, it being the remainder of the land I recovered of him, be the same more or less, on the condition that the said John Chiles, his heirs and

assigns pay to by executors for the use estate all the expenses I have been or shall be at in preserving and securing the said 250 acres which is given to the said Menoah and John Chiles.

Twelfth, I give to **Micajah CHILES**, son of Micajah Chiles deceased, to him, his heirs and assigns forever 375 acres of land I recovered of him on condition he the said Chiles, his heirs or assigns pay to me or my executors for the use of my estate all the charges and expenses I have been or shall be at in preserving and securing the same lands.

Thirteenth, I give to **Jonathan TERREL**, son of **David TERRELL, Sr.** deceased, to him, his heirs and assigns forever the four hundred acres of land of the estate of David TERRELL deceased; if recovered by me or mine, he the said Jonathan, his heirs or assigns paying all the charges and expenses I have been or shall be at in preserving the said 400 acres of land for use of my estate; but if the said Jonathan Terrel die underage, the said land to belong to his sister **Susannah TERRELL**, her heirs or assigns forever, she or they paying all costs or expenses as above; but if she die underage or before marrying, the said land to be equally divided between **Christopher** and **Rachel TERRELL**, their heirs and assigns paying all cost, charges and expenses as above mentioned.

Fourteenth, I give to my son **Thomas TERRELL**, his heirs and assigns forever, if he is now alive, if not to be sold by my executors and the money to be divided amongst all my children, their heirs and assigns forever, all my land in Albemarle County, Virginia, that lies above a great branch that comes down from a rich cove called Black Walnut, Barhat, a man, and Jane, a woman, and her increase, and forty five pounds current money, to be delivered and paid him, his heirs and assigns directly after the probate of my will.

Fifteenth, I give to my son **Henry TERRELL**, his heirs and assigns forever all the remainder of my land in Albemarle County if he is now alive, if not to be sold by my executors and the money to be equally divided

amongst all my children, their heirs and assigns forever, and two negroes, to wit, Fran, and man, and Sonia, a woman, and their increase; and fifty pounds current money to be paid to him or assigns directly after the probate of my will if he is now alive.

Sixteenth, I leave, if they come, the goods I have sent for, for the use of my wife at least so many of them as my executors find convenient and the rest to be sold by them.

Seventeenth, I have a negro named Peter; if alive, to be hired out by my executors and the money put to interest until my son **George** come to age, and then to be divided amongst all my children, their heirs or assigns.

Eighteenth, I leave under care of my wife three negroes and their increase (for the time to come) to wit: Handy, a man, Lysey and Tamer, women; and my will and desire is if any of my five youngest children's negroes die before they possess them, that their loss, if possible, be made equal to them out of those last three mentioned or their increase; if not, to be equally divided amongst all my children, their heirs, etc.

Nineteenth, It is my will and desire that all my just debts be paid by my executors hereafter named.

Twentieth, and lastly, I do hereby appoint **Samuel HARGROVE**, **Henry TERRELL**, son of **Joel TERRELL** deceased of Hanover Co. Va. and my son **Thomas TERRELL** my executors of this my last will and testament. In witness whereof I have hereunto set my and seal this 26th day of 3rd month in the year of our Lord 1760.

Marriage Notes for Timothy TERRELL and Mary Martin:

Researcher Samples: Marriage of Jemimah to William Reynolds is uncertain.

Researcher Wayland: Father of 14 children. Will dated and probated Feb 1763, Orange Co., N.C. The county seat of Orange was then called Childsburg, but later it was renamed Hillsboro, where his will is still on file. He was in Va. in 1741, when he witnessed a deed in Caroline Court. It is felt that he and his brother John moved to N.C. about 1743-44, probably after the death of their father. Timothy first settled in Bladen Co., where he petitioned for a grant of 600 acres 10 April 1745 ("Colonial Records of N.C.," Vol. 4, p. 764). Timothy was appointed by the Governor as a Justice of the Peace for Bladen at a Council held at Newbern 11 Apr 1749, was reappointed 7 Apr 1750 and again 1 Apr 1751 (Ibid, Vol. 4, pp. 951, 1046, and 1243) Orange Co. was formed from Granville, Johnston and Bladen Counties, so he may not have moved. After his death, Orange was divided into Chatham, Wake and Guilford, which placed his home in Chatham, where some of his children lived. Land records show that the Earl of Granville granted Timothy 400 acres of land on 6 Sep 1754 on head branches of Terrill's Creek (Bk. 12, p. 49). He obtained other grants amounting to more than 2,000 acres, making him a man of wealth.

I **Timothy TERRELL** of the County of Orange and the province of North Carolina, Planta, being in my perfect senses and memory blessed by God for it I do this 1st day of February in the Year of our Lord 1763 do make and publish this to be my last will and testament of this my worldly estate in manner and form as follows -- that I have given to my Daughter **Jimimah** and my Daughter **Ruth** and my Daughter **Millin** and my son **Solomon** and

my son **Micajah**, as much of my estate as I allot them. I give to my son **Nimrod** the plantation where I now live with part of the last survey I made in all to contain 350 acres, he is not to molest his mother during her widowhood of the plantation or any part of the land. Likewise I give him a negro boy named Jack and my still, and a horse named Rock, he is not to have any of his estate till he comes of age -- I give to my son **Simon** 300 acres of land lying at the West end where I now live being part of two surveys and likewise I give him a negro boy named Roger, he is not to have it till he comes of age -- I give to my son Simon all the increase of a negro woman named Cate from this day and the remainder of that tract of land, that my son **Solomon** now lives on, he is not to have it till he comes of age. I give to my son **Moses** that tract of land at Deep river and all the increase that comes of a negro woman named Jinney he is not to enjoy ay thing till he comes of age -- I give to my daughter **Mary** a negro girl named Hannah -- I give to my daughter **Betty** a negro girl named Sarah -- I give to my daughter **Cozziah** a negro girl named Sussan -- I lend to my son **Daniel** a plantation on the last survey I made with part of the tract I live on, with part of another joining survey and if he has any lawful heirs to them forever or their assigns and if no such heir returns to **Nimrod** and **Simon**. I give to Daniel a mare named young Rone, bridle and saddle and I give him a bed and furniture and a cow and calf 260 acres of land lying east in Rowan County and I leave to be sold at Vendue likewise I leave 320 acres of land known by the name of Terrell Richard land to be sold at vendue. Likewise I leave my son **Richard** my great wagon. Likewise I lend the remainder of my estate until my beloved wife during her widowhood, for the support of her and her children and in case she marries to enjoy it no longer and after her decease or marriage for it to be divided into lotts and the lotts drown for betwixt son **Solomon**, son **Nimrod** my son Simon, my son Aron and my son Moses -- I do appoint my friend, **John PILLS** and my wife

two executors of this my last will and testament of this my earthly estate. Likewise I give my wife leave to give to any of the children that now lives with us, when they marry or comes of age, if there is any stock, as she can spare, to give them any part as she shall think fit or longing.

Dicken: A **James TERRELL** reported for duty as a sergeant in Capt. Mercer's military Company in Geo. Washington's (Virginia colonial) Army on 9 Jul 1754, but we cannot be sure it was this James TERRELL.

This previously unknown will was located (ca. 1994) among the Miscellaneous Papers of Cumberland County's "County & Superior Courts, 1760-1850," at the Library of Virginia. This document provides proof of the sons of James TERRELL and identifies, for the first time, his daughters:

The Will of James TERRELL, Planter

In the name of God, Amen, I **James TERRELL** plant'r of St. Margarets Parish, & County of Caroline in the Colony of Virginia, am weak in Body but in a perfect Sense & memory, thanks be given to Almighty God. Therefore calling to mind the Mortality of my Body, and knowing that it is appointed for all men once to die, do make and Ordain this my last Will and Testament, that is to say, Principally revoking & disannulling all other Wills heretofore made by me; first of all I give & Recommend my Soul into the hands of God that gave it to me, and my Body to the Earth to be Buried in a Christian like manner; nothing doubting but at the general Resurrection to receive the same again by the might power

of God; and as touching such worldly Estate wherewith it hath pleased God to bless me with in this Life, I gave and dispose of the same in the following Manner and Form, viz't.

Secondly. I lent unto my beloved Wife **Margaret** a Childs part of my Estate, be it in what place or of what nature or quality Soever, and after my loving Wife Margarets decease my will & desire is that part I lend her should be divided equally between my five oldest children, viz't **William TERRELL**, **Mary Herndon**, my son **James TERRELL**, **Betty Newton** and **Patty Hord**.

Thirdly. What I have given heretofore to my eldest son **William TERRELL**, being a full part of my Estate, to tedious to mention at this time, hoping he will take it kind enough of me, not being well able to give him any more of my Estate.

Fourthly. I give & bequeath to my son **James TERRELL**, the Tract of Land wheron I now live and my Sill as it now stands, & also the fifth part of my Stock after my s'd Wifes part is taken out of my Estate, to him & his Heirs & Assigns.

Fifthly. I give & bequeath to my Daughter **Betty Newton**, one Negro wench named **Janes**, to her and her heirs and Assigns.

Sixthly. I give & bequeath to my Daughter **Patty Hord** one Negro wench named **Fortune** to her & her heirs and Assigns.

Seventhly. I give and bequeath to my son **John TERRELL** two hundred Acres of Land, lying on the north side of Muddy Creek in Cumberland County and five pounds of curr't money, to buy him some stock, to him and his Heirs & Assigns for ever.

Eighthly. I give and bequeath to my son **Dudley TERRELL** two hundred Acres of Land lying on the south side of Muddy Creek in Cumberland County joining the s'd Land as I have given to my son **John TERRELL** and a fifth part of my Stock, to him and his Heirs & Assigns for ever. And the fifth part of my house hold goods after my s'd Wifes part, to him and his Heirs and Assigns for ever.

Ninthly. I give and bequeath to my Son, **Jonathan TERRELL**, three hundred acres of

Land lying in Culpeper County, and the fifth part of my stock & house hold Goods after my s'd Wife's part is taken out, to him & his Heirs & Assigns for ever.

Tenthly. I give and bequeath to my Daughter **Neffe** one negro girl named Rose, and the fifth part of my Stock & house hold Goods after my s'd Wifes part is taken out of my Estate to her & her Heirs and Assigns for ever.

Leventhly. I have and bequeath to my Daughter **Mary Herndon** one negro boy named Charles, to her and her Heirs and Assigns for ever.

Twelfthly. Remembering from the beginning of my Will that all my just Debts & Burial Charges are to be paid before any division of my Estate made between my loving Children; also my Will and desire is, that if any of my aforesaid Children should be so disturbed at this my Will and Occasion Lawsuits to interrupt my Will, that they him or her shall be paid by my Executors one Shilling Sterling and cut of from all other part of my Estate and the part of my Estate left them by this my Will should be equally divided between my Contented Children.

Lastly, I do appoint and Ordain my Son in Law **Thomas HORD** and my Loving Son **James TERRELL** Executors to this my last Will and Testament.

In witness whereof I have set my Hand and fixed my Seal the eighteenth day of October, in the Year of our Lord Christ. One thousand seven hundred and sixty six. {signed} **James TERRELL** (seal)

At that time, Robert, the brother of Richmond was not alive. The land was described as behind the land of Major **William WYATT**, etc., granted for the transportation of four persons. The **Hezekiah TERRELL** mentioned in your reply regarding 1860 Census of Cass Co, GA was in the household of my great uncle, **John SHULER**.

There is a possible tie in with my SHULER family and the TERRELL family. After the Civil War all the SHULER family moved from Georgia to Sebastian Co, Arkansas. Recorded in the 1870 Census of Sebastian Co, AR in the household of **George W. SHULER** (my great grandfather & brother of **John SHULER**) and his wife, **Sidney**, is: **Priscilla TERRELL** (31 yrs.), Female, born North Carolina. Further :

1) **Priscilla TERRELL** married **A. P. HARMON** 8 June, 1873 in Sebastian Co. AR

2) **Priscilla Harmon** died in Sebastian Co AR 13 Jan 1884 & her tombstone states she was born 13 May, 1833.

3) **Priscilla** is buried in the SHULER family plot & surrounded by Shulers at Mountain View Cemetery, Sebastian Co AR

All of the above makes me wonder if there is not a connection between the TERRELL & SHULER families??? Since you are with the Terrell Society of America I thought this information on **Priscilla TERRELL Harmon** would help you and the Society. I am also hoping you might help me with a question that I am trying to solve: What was the maiden name of **Sidney/Sydney** my great grandmother (the wife of **George W. SHULER**)?

Sidney was, like **Priscilla**, born in North Carolina. **Sidney** was born 7 Jan 1831, so there is only two years difference in age. I think it is possible they are sisters or cousins.

Sidney and **George** were married sometime after the 1850 Census of Cass County, GA (when **George** was recorded in **Emanuel SHULER**, his father's, household and the birth of their first child, **Mary J. SHULER**, in July of 1857 in Georgia. I have made extensive searches for marriage record with no success and attribute that to one of those numerous court house fires.

I hope the information on **Priscilla** will be helpful to you and the Society and that you can help me solve

Jerry,
Your information was most helpful. I can now identify **Hezekiah** - he is the younger brother of **Priscilla**. They are both children of **John TERRELL** and **Elizabeth HARPER**. In the 1850 census Hezekiah is listed as born in N.C., in 1860 as GA. I think N.C. is correct. It is known from other sources that **Priscilla** married **HARMON**.

As to a SHULER-TERRELL connection, Priscilla's older sister **Sidney** married "SHULAR." I have one other Shuler in my 41,000 person TERRELL family database (Family Tree Maker), but they are far removed from the TERRELLs. I think **Sidney** is the only link.

The parents of Priscilla and Sidney died before 1850 (mother) and in July 1859 (father). It makes perfectly good sense for the remnants of that family to accept an invitation to go west with the SHULER family.

I will send you a printout Sidney's ancestry, if you will provide me a postal address. Don C. Terrill

I have scoured the Georgia marriage records and have never found the marriage record of **George W. SHULER** and **Sidney** with no success. Also could not find them in the Georgia Census of 1860. I am hoping that that your confirmations have uncovered these mysteries.

John is found in the 1860 Mortality Census for Gordon Co, Ga.

The remains of John TERRELL's family is found in the 1860 census of Fairmont, Gordon Co, Ga., p. 392. The household is headed by **James TERRELL** (b. 1834, N.C.), John's oldest son, and with him are his sisters and brothers **Martha, Priscilla, Henry, and William**.

I placed the following message on the GIBSON Family Genealogy Forum (genforum.genealogy.com):

According to information provided years ago by mildly confused but darling little old ladies, my great-great-grandmother, **Eunice Jane GIBSON**, was born in Virginia on August 17, 1824, the daughter of **Kate GIBSON** and **Unknown GIBSON**. In some family correspondence, it is noted that the "widowed Kate GIBSON returned to Tennessee with her daughter", but no dates or cities/counties are given. Presumably, when Kate GIBSON's husband died, she went home to her family in Tennessee where we are told she was born.

Eunice Jane GIBSON married **Samuel TERRELL** in or near Florence, Lauderdale County, Alabama (early 1840's?). I have no marriage records to support this, but their first child was born in about 1843. Eunice Jane and her husband moved to Tupelo, Miss, in about 1848, per the recollection of one of her sons.

Supposedly Eunice Jane's husband Samuel died between 1855 (last child was born) and 1860 (when she and her children are listed on the census sans Samuel). Samuel reportedly died from "a wound caused by a falling axe".

The 1860 Pontotoc County, Mississippi census shows:

Eunice J. TERRELL, age 34, born Alabama (We'd been told she was born in Virginia, but DOB would be 1826)

James A. TERRELL, age 16, born Alabama (He died in the Civil War, we're told)

John G. (Green/Greene) TERRELL, age 14, born Alabama (my great-grandfather)

Samuel J. (Joseph) TERRELL, age 11, born Mississippi

Martha E. E. TERRELL, age 9, born Mississippi (may have died young or been a niece, as she is not mentioned in later family records)

Mary F. (Frances, a.k.a. Fanny/Fannie) TERRELL, age 7, born Mississippi

Martin L. (Luther), age 5, born Mississippi

Sarah GIBSON, age 58, born Tennessee (Sarah Katherine "Kate"???)

I don't believe that Samuel and Eunice ever purchased their own place, as we can find no records of any land purchase. Based on Samuel's dying from an axe wound, I suspect he was a hired hand.

According to family lore, **Eunice Jane GIBSON Terrell** died in 1908 and is buried in Crowder, Oklahoma (where my grandparents lived). My little sister and I each made trips to the little cemetery there and the headstones are difficult if not impossible to read. Oklahoma became a state in 1907, but didn't start keeping death records until some months after Eunice Jane GIBSON died.
