A documentary on Florida in the Civil War

February Sundown will be an objective, educational, yet passionate documentary look at the Civil War era in Florida including the three bonafide battles that occurred in the state: *The Battle of Pensacola*, *The Battle of Olustee*, & *The Battle of Natural Bridge*. This program will be probably be formatted into both a single 2-hour feature and a 3-7 part 60-90 minute installment miniseries. In the latter form, the project will offer up a tremendous amount of in-depth information. An interactive DVD boxed set release will precede or follow the broadcast.

February Sundown has been lovingly and laboriously under production, filming nearly every weekend for the past 3 plus years. Currently being stored at Continental Film and Video Laboratory in Orlando and Cineworks in Miami is over 24 hours of evocative motion picture footage of sites of Civil War interest in Florida including hundreds of archive daguerreotype and tin-type photos, full-color living histories, battle reenactments, scores of antebellum homes, gravesites, wild landscapes, water-scapes, and indigenous Florida wildlife, all serving to illustrate the wild pioneer Florida of the time. From Pensacola to the Dry Tortugas and also sites in Louisiana, South Carolina,

North Carolina, and Georgia, an attempt has been made to cap

ture a virtually endless array of antebellum and wartime nuances. Principal photography is scheduled to finish in fall of 2004.

February Sundown, named after a climactic blood-soaked sunset North Florida evening in February of 1864, will focus as much on the people of the times through dramatic letter readings and archive photos as it will the mechanics of the occurring battles, skirmishes, and events.

February Sundown, with its numerous locations around Florida, will have local appeal to audiences throughout the state. Moreover, with Florida's status as a vacation and retirement destination nationally, the film will draw interest and viewership from across the country.

February Sundown will examine thoughtfully Florida's Confederate soldiers. The sunshine state sent a higher proportion of men into battle than any other state, and suffered the highest attrition rate as well. The pioneer origins of these men and the Seminole Indian war backdrop to the land will introduce the

piece. The peninsula bore the brunt of the Union's "Operation Anaconda", the naval blockade that attempted to squeeze the

life out of the Confederacy. Blockade-runners, outlaws, Indians, double-crosses, and family hatreds made for an unusually high level of adventure and intrigue. Additionally, Florida had a high concentration of African-American soldiers. Their role will be explored, especially that of the fabled 54th Massachusetts (of *Glory* fame). Their second combat action was in Florida at Olustee where their uncommon valor saved the Army from annihilation that day. The film will strive for "warts-n-all" truth while attempting to enlighten, fascinate, entertain, and inspire people from all walks of life.

February Sundown will see exhibition through eventual donation to the new Olustee Battlefield Museum with clips available for download off the Olustee Citizen Support Organization's website and www.februarysundown.com. It is hoped the film will also eventually be sold at a discount in gift shops at Florida's local, state, and federal parks. Additionally, the film will also be available for sale online. Perhaps the most important goal for the project is a national broadcast on The History Channel or another national or regional broadcast outlet.

February Sundown will take no chances with historical integrity and accuracy. A panel of 12-15 experts in the subject of Civil War events and people in Florida is and will continue to be utilized in the script and final cut approval of the film. Additional credits for the film will range from private individuals, churches, historians, genealogists, University of Florida, Florida State University, Florida State Park Service, U.S. Fish & Wildlife, Army National Guard, U.S. Navy, private themed nature parks, etc. The program is independent and is currently being completely self-financed by myself, wearing the titles of writer/producer/director/editor. I have been working steadily virtually every weekend for the past three plus years. I am currently employed with Clear Channel Worldwide in Jacksonville as a producer/director in the Creative Services department of the CBS and FOX affiliates. I have been in the film/video production business professionally since 1987. After production assistant work on national spots in Miami (*AFI Productions*), I then served for several years as the producer/director of a

collegiate sports magazine series called *Seminole Uprising* (*Seminole Productions*) Also within that time, I wrote, produced, directed, and edited environmental documentaries on such wilderness

regions as the Tongass National Forest in Alaska (*The Voyage of the Observer*) and the nation's first wildlife refuge (*St. Marks National Wildlife Refuge*) . Rounding out the repertoire' are works in cinematic opera (*Reverend Everyman*) and European travel (*Track Florida-The European Tour*), after which I have since and continued to work primarily in local and regional commercials and public service announcements such *Larry's Giant Subs*, *Hungry Howie's*, and *Save Your Planet*. In '96 & '97, I was employed with the Walt Disney Company as a sales agent.

February Sundown reveals there was a surprising amount of Civil War activity throughout the state. Cedar Key on the Gulf coast is an example of that. My own family clan kept transcriptions in its genealogical compilation of letters written by my Great, Great, Great Grandfather James R. Terrell, to his wife Nancy, when he was stationed at the Confederate camp there (Station #4). He would later lose his life at the Battle of Olustee. (These letters were the inspiration for my abiding interest in this subject.) In addition to its historical significance, Cedar

Key is a place of tremendous wild and natural scenery, a slice of the "real Florida". As such, I believe the careful interweaving of places of natural heritage with places of historic heritage as presented through the narrative and visual presentation of the documentary compounds the poignancy of the message. Land-wise, Florida was still in quite a wild, if not "pioneer" state in the 1850's and 1860's. Revealing the "low-key" beauty of these Florida landscapes shows us what much of the terrain and topography looked like in areas of Civil War activity, during this time. Being an environmentally minded native-Floridian myself, I have endeavored here to spark the innate passion of many Floridians for their wild and historic lands. As well, I think most citizens of this state, and even those visitors who have come to love it, will discover a source of pride in the various state parks credited for making the program possible. Seeing the parks showcased in this visual gallery, we are reminded that our tax dollars are anything but wasted in the staffing and maintenance of our historic battlefields, sites, monuments, and natural preserves. These hallowed places, and wild ecosystems are a reminder of not only our historical and natural heritage, but of our contemporary value system, our state and national identity—what we hold dear, who we believe we are, the land of our founders and fathers-- a "piece of ground" that's worth fighting for.

February Sundown may also contrast the military history of the state from this era with its military present. Now home to many bases, including the command center for the entire U.S. Armed Forces, Florida is proud of its military heritage. The serious political, social, and economic implications left by the Civil War endure to this day; a legacy that still craves research and understanding, any of which is relevant to the discussion

and study of modern American society and government.

SOME DESCENDANTS OF JOHN MC TERRELL INCLUDING JAMES R. TERRELL OF GA & FL

This article extracted from: *DESCENDANTS OF PHILEMON TERRELL*; compiled and edited by: Loyce KNABB Coleman July, 1958

FOREWORD

By #593 Brian Terrell; written summer 2004

This compilation *Descendants of Philemon Terrell* was invaluable to me and many others in my Terrell family line for instilling a sense of wonder about our roots and inspiring us to further study. It was authored by Loyce KNABB Coleman of Maclenny, FL in 1958. She was by many accounts a lovely, special person. She has been gone many years now, but the legacy of history she left for so many of us will endure.

Aunt Loyce (as my father knew her) used as the base of her study the genealogical text *Pioneers of Wiregrass Georgia* by

Folkes HUXFORD. HUXFORD was a judge, I believe, who privately oversaw a staff of researchers in preserving the genealogical history of southeast GA. This work, done around the turn of the century, I think, dug into the attics and minds of GA folk across the region. It is a vital, landmark work. Unfortunately, modern researchers have proven it to be fraught with errors. It seems this is true regarding the Terrells at least as far as myself and associate family line researchers have discovered. (See the HUXFORD Museum in South GA for more accurate information on "Pioneers".)

Most overtly is the title itself. My association of researchers (namely **Pauline Brandy**, **Mary Ellen Terrell Alvarez**, and **Elaine Steere** among others past and present) have concluded that the family line of this book is descended instead from **Philemon's younger brother Richmond**. **Richmond** was also a Revolutionary War veteran (roughly 17 at the time). **Both men had sons named John born around 1790 in Liberty County GA** Unfortunately there is little evidence that connects Richmond to his son John. This John is often found in the records as **John McTerrell**. At least this helps us differentiate him from his cousin John. Some of us believe the "Mc" was a middle name given in honor of **John MC REE**. In NC, Richmond was a neighbor of McRee and in the war, served in his battalion. (Ft. McRee at Pensacola was named in honor of McRee. It was demolished in the Civil War.) This text asserts that this Richmond went on to receive a pension in Newton, GA **On-site study has revealed that the Richmond of Newton is not of our particular family line.** (The name Richmond occurs several times through Terrell history so more than one contemporary Richmond would not be unusual.) Our Richmond probably died in Liberty County GA or in SC where he once lived before.

Additionally ... while there is very substantial evidence linking **John McTerrell** to his son **James R. Terrell**, there are no birth certificates or other documents explicitly stating this father-son relationship. For these unfortunate reasons, the Daughters of the American Revolution can not recognize this Terrell family line as "Sons" or "Daughters" of the Revolution. Discovery of "poor school" records might help to correct this.

It has also been discovered that **John Mc Terrell** fathered at least 3 sons from his first wife, **Lydia**, instead of the two listed in this book. **John Mc** also served in the GA Militia in the War of 1812, as well as the Indian War of 1838, which was a south GA extension of the second Seminole War (or the FL War).

The battle of Olustee is given erroneously here. It actually occurred on Feb. 20 1864. The original James R. Terrell **letters** were apparently owned by **Loyce Coleman**. Her family donated the letters to the Emily Tabor Library at Maclenny. The library cannot locate the letters. They may now be in the possession of the **P. K. Younge Library of FL History at the University of FL, Gainesville**. Contact with the director regarding this has been unsuccessful. Two more letters exist which were transcribed and copied in another compilation of the descendants of **Talitha TERRELL ABSTEIN**, James's oldest daughter. A 9th letter was found in the National Archives, part of an affidavit on the part of James's widow **Nancy** to collect Indian War widow's pension from the old War Department. It is only about 75% legible. James served as militia in the 2nd.

[The following are believed to be sons of one **James TERRELL** of either VA or NC. Some have attempted to link them to **James, son of William & Susannah**, but I have not seen any documentation to support that theory. The children of William & Susannah as reported in *Terrell Genealogy* by **Emma Dicken** was based upon the recollections of **John Dabney TERRELL** as related to his cousin, **John Davis TERRELL** in his later years. *DFB*]

Record from Library of Congress in Washington, D.C. shows that **Philemon** and **Richmond TERRELL** were both living in Robeson County North Carolina in 1790, according to the 1790 census which was the first taken in the United States.

1840 census of Pensioners, Newton City, GA, records shows **Richmond TERRELL**, age 80 as receiving pension for Revolutionary of military services.

State Archives of North Carolina shows pay authorizations for **Richmond TERRELL** dated May 1 1792, and for **Philemon TERRELL** dated March 21., 1783 and one in 1782. services in the Militia.

Philemon TERRELL moved to Liberty County, GA before 1800, and died there in 1816.

Census Ref: 1820 Liberty; 1830 Irwin; 1840-1850 Lowndes; 1860 Echols.

Philemon TERRELL owned 650 acres of land in Liberty County, GA at his death as recorded in Deed Book "H", page 107, Liberty County, The children made a deed to their mother on December 9, 1916, for this land.

He was a Revolutionary Soldier and his National D.A.R. number is 437210.

Philemon TERRELL was m. to **Elizabeth**; her Maiden name is unknown. To them were born 9 children:

TO THEIR MOTHER
ELIZABETH TERRELL, 9 DECEMBER 1816,**

STATE OF GEORGIA, This Indenture, made the ninth day of December in the year of our Lord eighteen hundred and sixteen, and in the forty first-year of the Independence of the United States of America, Between **Pierce TERRELL, Josiah TERRELL, John TERRELL, Lucy TERRELL, Malcolm TERRELL, William WILLCOX** and **Edward CURRIE, Jun.** of the County of Liberty and said State, **James WILLIAMS**, of the County of Jefferson in said State and **THOMAS STANALAND**, of the County of Bullock in the said State, heirs and representatives of **Philemon TERRELL** the elder, late of the County of Liberty, deceased, of the one part, Witnesseth, that the said, **Pierce TERRELL, Josiah TERRELL, oc,** for and in consideration of the sum of six hundred dollars, the receipt whereof is hereby, acknowledged, hath granted, bargained, sold, alined, released, and confirmed and by these presents Doth grant, bargain, sell, alien, release, and confirm, unto the said **Elizabeth TERRELL**, her heirs, and assigns forever, all our right title, and interest in and to the four following, adjoining, tracts of land; viz; two hundred acres, granted to **Elizah ANDERSON**, July 6th, 1793; one hundred acres granted to **Eleazar BRACH**, October 17th, 1802, adjoining the above one hundred acres, granted to **Jonathan ROBINSON**, October 17th, 1798, adjoining the last mentioned, and the Eastern Part of a tract of four hundred acres; granted to Mr. **Philemon TERRELL**, November 13 1802, containing two hundred and fifty acres., or thereabouts. Together with all and singular the houses, out-houses. buildings, and improvements, rents, _____ profits, privileges, commodities and all the right, title, interest, inheritances, benefit, claim and demand whatsoever to the said tracts or parcels of land, and all the appurtenances thereunto belonging, or in Any wise To have and to hold the said tracts of land, and singular the premises above with their and every of their rights, members, and appurtenances together with all things there unto appertaining to any & part thereof, to the only proper use, benefit, and behoof of the said **Elizabeth TERRELL**, her heirs and assigns forever. And the said **Pierce TERRELL, Josiah TERRELL, oc** their heirs and assigns, the said tract of land, and premises above mentioned and all and every part and parcel thereof, unto the said **Elizabeth TERRELL**, her heirs and assigns, against them, the said **Pierce TERRELL, Josiah TERRELL, oc,** their heirs and assigns, and them only, Shall and will

Elizabeth TERRELL sold this land to **John DANIEL** for \$800,00, deed being dated 26 Dec. 1816 and recorded 19 Jan. 1818,

5. John [Mc] TERRELL born in 1790 in Robeson County, North Carolina, a son of Philemon and Elizabeth TERRELL. [or Richmond as Brian & others now believe]

John TERRELL was born in Robeson County, North Carolina, in 1790, his father moved to Liberty County, GA sometime before 180? and he was m. first to Lydia ELLIS on 3 December 1815 at Hinesville, Liberty County, GA and to this union were born two boys, James R. and Reason TERRELL. Lydia died sometime between 1825 and 1827 and he then m. Nancy OVERSTREET, who was born in 1799 in South Carolina. To this union were born eight children.

John and his wife Nancy were members of the Antioch Primitive Baptist Church in Echols County, GA.

John served in the Indian War in 1838 in Capt. David R. Bryan's Company in Lowndes County Militia.

Record is found where John TERRELL granted land in Liberty County, GA, 100 acres on Doctor's Creek being surveyed for him 14 January, 1815, and 200 acres on 25 June 1816. He sold out and moved to Irwin County about 1825, and about ten years later moved to what was then Lowndes County; in 1858 he was cut out of Lowndes into Echols County when the latter was created, and he lived in Echols County until his death about 1870.

John TERRELL is buried in the CARTER Graveyard, near Statenville, Echols County, GA, although there is no tomb to his grave. No record is found where either of his wives were buried but it is assumed that Nancy is buried beside him in the CARTER Graveyard.

[**John Mc TERRELL & John Jr.** served as privates in the Indian War. Capt. **Samuel E. SWILLEY's Co.**, Lowndes Co. militia June 16 -- Dec 16, 1837; second service in Capt. David R. BRYAN's Co., Lowndes Co. militia 1838; they enrolled as John McTERRELL and John McTERRELL, Jr. TT p. 45] He was m., first to **Lydia ELLIS** on 3 December 1815 in Hinesville, Liberty County, GA and to them were born [three] children:

13. James R. TERRELL was probably born Liberty County, GA, the eldest child of **John [Mc] TERRELL** of Robeson County, N. C., and his first wife, **Lydia ELLIS**. He was born 9 May 1820, and died 23 March 1864, on the battlefield of Olustee, Baker County, FL, during the 'War Between The States'. At the time, of his death he was the father of thirteen children,

the youngest having been born less than a month before his father's death.

James R. TERRELL was m. 10 March 1841, to **Nancy GUTHRIE** the daughter of **Samuel** and **Nancy GUTHRIE**. She was born in GA according to the 1850 Marion County, FL census and she died 16 December 1899, at the age of 74 years, and was buried at Hawthorne Cemetery, Hawthorne, Alachua County, FL.

According to the 1850 U.S. Census for Marion County, FL, taken 26 October 1850, **Jasper**, the first child above, was born in FL; **Talitha** was born in GA, and **Lydia**, as well as the following children, were born in FL.

By 1856 James had moved to Alachua County, FL as he shows up on the county tax roll with real estate valued at \$600.00, live stock at \$193.00 and furniture at \$25.00, paying tax of \$1.06. He also is enumerated in the 1860 Alachua County, FL census, taken on the 7th of June.

James R. TERRELL enlisted for Company "F", 9th FL Infantry at Lake City, FL on 12 August 1863. His name last appears on Muster Roll under date of 31 December 1863. The roll for this company as published in "Soldiers of FL", page 216, shows, that he was killed at Olustee, February 20, 1864. According to the FL Military Department his name does not appear on the roll covering period of 28 February 1864 to 30 April 1864. The date of his death given at the beginning of this sketch is family data.

James R. TERRELL was a member of the Hawthorne Baptist Church. Several of his letters written during the War are still in possession of the family, one of which was written from Camp Finnegan, Cedar Keys, FL, wherein he requested potatoes and soap, and stated that he had had no bread in two weeks. He marched from Cedar Keys to Olustee.

Both James and Nancy TERRELL's grandfathers were Revolutionary Soldiers, or so it is believed concerning **Samuel GUTHREY'S** father, and James TERRELL was the grandson of Revolutionary Soldier Philemon TERRELL of North Carolina and GA.

James R. TERRELL's Bible is in possession of **Loyce KNABB Coleman (Mrs. Asa COLEMAN, Jr.)**, which lists all of his family births and deaths, as are six letters, mentioned above. The last letter being dated 16 February 1864 just four days before his death.

It will be noted that the date of his death is listed as 20 February 1864 and 23 March 1864. The first date being as listed in Soldiers of FL and the other as listed in his Bible. It is assumed that his wife received notice of his death on the 23 March 1864 and listed the same in the Bible on that date.

ISABELLA GLASS TERRELL 1796-1869

By #641 Deloris Riley

I have been researching my WYNNE?TERRELL family 40 years. My travels carried me from TX to Great Britain, to Wales. I still haven't found ALL the answers!

I found graves or death dates of most of my direct TERRELL line, but was lacking when and where one particular gr-gr-gr grandmother, **Isabella GLASS Terrell** died. Her trail ended in Mansfield, LA. Isabella was the widow of **Hiram TERRELL**, s/o **Moses TERRELL**; s/o **Timothy TERRELL**. Hiram d. 1846 in Pike Co MS.

In 1997, I made a trip to Madisonville, TX to meet with a fellow **SAVELL** (my mother's family) researcher. After a day of **SAVELL** research, my friend, **Maxine CANNON** took me to an old cemetery about six miles outside of Madisonville, Rock

Prairie Cemetery. Right in the middle was Isabella Terrell's grave! It was as if God led me to it. I had no idea Isabella had come to TX and at the time, I was not concentrating on TERRELLS.

Evidently, Isabella traveled to Madisonville with her daughter **Martha Ann TERRELL Ford** and her family. **Mary Ragland TERRELL** m. **Benjamin FORD** and **Martha Ann TERRELL** m. **Joshua FORD** (sisters married brothers). **Mary Ragland TERRELL Ford** d. 1853 in DeSoto Parish, LA and is buried there.

Seven years later, 2004, I made a return trip to Madisonville and found that vandals have broken Isabella's small thin stone in half and both pieces are lying on the ground.

But the good news is that just outside the gate, there stood a Texas Historical Society Marker. At the top is the seal of the State of Texas. Below is

Rock Prairie Cemetery

Pioneers William D. and Delina Walker Hollis arrived in Texas in 1837 and purchased land in what became the Hollis Community in 1855.

Joshua and Martha Terrell Ford bought adjoining land in 1860. Oral history relates that a baby born to slaves was buried on the Hollis farm prior to the Civil War. The first marked burial on Hollis land was William B. Best in 1861. The first marked grave on Ford's adjoining property was that of Martha Ford's mother, Isabella Terrell in 1868. Each family set aside acreage out of their property for a community cemetery. Later owners of the land included J. W. Eaves and J. Milton Jackson whose heirs later deeded the cemetery land to the Rock Prairie Cemetery Association

It is interesting to note that I have clear pictures of Isabella TERRELL's gravestone before it was vandalized and the date of her death is definitely "September 24, 1869" not 1868; (Even the state of Texas makes mistakes.)

The cemetery association takes perpetual care of the cemetery but it is up to family members to do restoration to grave sites.

Is there anyone who would like to make a donation toward replacing Isabella's stone? It is too brittle to repair. If so, please notify me by email and I will give you the name and email address of the President of the Cemetery Association. They have an annual meeting in July.

My line does go through **Eli**. **David Ezra** was a son of **Eli** and **Martha**. My mother is **Marie TERRELL Smallwood**. by a **William TERRELL** who lists a **Coleman FORD** and a **William TERRELL** alias **William FORD**. William George (FORD) TERRELL is my 5th cousin 4 Generations removed. Our common ancestor is **Richmond TERRELL**. On www.roots web.com it shows **William George Ford - TERRELL** as son of **Coleman FORD** and **Matilda TERRELL**. Why did he go by TERRELL and not by Ford? Matilda is daughter of **William TERRELL** b. 6 Aug 1760 NC d. 4 Jul 1851 DeKalb Co., GA. (spouse unknown). **William** was son of **John TERRELL Jr.** and **Su-sannah DOUGLAS**. Does your line go through **William George TERRELL's** son **Eli**? **Paul Anderson** a TERRELL Cousin

Paul, Thanks for the information. My husband's lineage goes through **William Peter** youngest brother of **Eli**. Why did William George go by the name of TERRELL instead of Ford? The story as it is told by a granddaughter of William Peter goes that the **FORD** man was either sent to prison or otherwise disappeared and **Matilda** died when "**Billy**" was very young. "**Billy**" was then taken by his maternal grandparents (**William & Unknown**) and they raised him. When he was 21 his TERRELL grandfather gave him the choice of legally becoming a TERRELL or a **FORD** and he chose his mother's name, **TERRELL**.

Before the [Civil] war, **Billy & Mariah** owned a mercantile store at Little Five Points in DeKalb, GA. The family also owned land around Grants Park (in Atlanta, GA) which was later lost in a land dispute in which the Ford family played a part.

When the war came, Billy became a confederate soldier. Later when rumors came that Sherman was going to burn Atlanta, Mariah moved her family to Carroll Co. Billy survived the war and is buried with

...after this tour in the Army, he began his life in Beaumont with his wife, **Jimmie**, and their eldest son, **Frankie**. With the faith he learned from his mother and the knowledge and experience he gained in the Army as an Engineer, Bill set out to be a builder. He knew that the public needed housing but wanted to give more than just "a roof over their head". He strived to build a reputation on a custom built home with all the newest innovations. Whether it was the latest model of a product or the best and most efficient way to build a quality custom home, his trade mark soon became the "extra mile". From the dirt work before the slab through the building process to the custom built cabinets that would go into the new home, he supervised it personally. He was a strong believer in building the slab and structure sound. Bill would say "you can always gingerbread it later". He was a member of the National Association of Home Builders and the Sabine Area Builders Association.
