I am at a genealogy brick wall. My gr gr grandparents were **William TERRELL** and **Nancy COLVIN Terrell**. They were both born in KY. Do you have any information on my gr gr grandparents? Are William's father and mother, **Thomas TERRELL** and **Nancy BLACKERBY Terrell**? If so, do you have any in-

Gail,

I have thus far been unable to link this Terrell clan to the Virginia TERRELLS descended from either Richmond or Timothy Terrell/Terrill, although I am certain that they are descended from one of them. My earliest record is the 1850 census of Washington Co, Ky. (p. 165); next 1860 Ky., Washington Co, Mackville, p. 215. I could not find them in 1870, but found them next in 1880 at Ky, Washington Co, Willisburg, p. 409c. Found again in 1900 Ky., Washington Co, ED 124, S 2, L 89 - William is gone, but Nancy is living with her married daughter Mary.

According to Annabelle Terrell (612 N. Miami St., West Milton, OH 45383), whose ancestry chart is printed at pp. 494 & 504 of "Terrell Trails" newsletter for Spring 1990, **William TERRELL** was born 1816, Lincoln Co, Ky.; and died 3 Nov 1897, Tatum Springs, Washington Co, Ky.; he married **Nancy COLVIN** (born 29 Oct 1820, died 4 Mar 1906) on 14 Jul 1847 at Lancaster, Garrard Co, Ky. William served as Pvt. in Co F, 6th Ky. Cav. Regt. (Union).

William's father is **Thomas TERRELL** who married **Nancy BLACKERBY** (bond dated 27 Feb 1815, Lincoln Co, KY). Her father was **Thadious BLACKERBY** who appears in the 1820-30 census of Ky.

According to my data **Richard William HILTON** (b. ca. 1796, d. 1840) married Gracy Sessions **TERRELL** (b. ca. 1800, d. 1865). Their children were **Samuel HILTON** (b. 1817, d. 10 Apr 1847), **Tillman HILTON** (b. 1826), **Martha C. HILTON** (b. 25 Jan 1829, d. 9 Jan 1820, m. **James C. MASSEY**), **Mary Ann HILTON** (b. 2 Aug 1830, d. 14 Apr 1896, m. **Howell Jackson GREGORY Sr.**), **Bilza HILTON** (b. 1831, m. **W. B. MORRIS**), **Edward HILTON** (b. 1832), **William R. HILTON** (b. b. ca. 1833, d. 20 Aug 1847), **Minor HILTON** (b. ca. 1834, d. 12 Apr 1847), **Jerome B. HILTON** (b. 1835), **Grace HILTON** (b. 1840, m. **GREGORY**), **Catherine Jerome HILTON** (b. Aug 1841, d. 22 Mar 1922, m. **Leroy R. HILTON**), and **Seabourn J. HILTON** (b. 8 Aug 1842, d. 22 Dec 1922, m. **Mary Jane C. WELBORN**). [Primary source "Falkenberry Family," by Waymon Griffin, griway@bellsouth.net, Jun 2001] The same source says that **Richard William HILTON** was the son of **Samuel HILTON** (b. 1765, d. 1826 Lancaster Co S.C.) and **Edith _?_**.

I do not know if you have the ancestry of **John Wesley TERRELL**, but I can provide it back to 1545. **Eliza Jane TERRELL** was related to John Wesley **TERRELL** and shares the same ancestral **TERRELL** line.

It appears to be the same. Page 571 of **TERRELL TRAILS** contains a query submitted before fall 1991 as follows:

OH in 1860; children: **Emery Wallace COSSET** b. 09/06/1846 (VT?) d. 12/24/1918 Hancock Co. OH m. **Mildred E. BROBECK**; **Amanda E. COSSETT** b. c1853 OH, d. 1881 Union Co. OH; m. **Owen LONGBERRY**, res. Union Co. OH 1880; **Laura P. COSSETT** b. c1846 OH m. (1) **Mr. LARCOM** (2) **James FURROW** res. Hardin Co. OH & Paulding Co. OH. Need proof of parents of **Milo COSSITT**. His widow, **Ann Jane TERRELL Cossitt** m. 04/04/1887 Union Co. OH to **Israel BROBECK**. She d. 10/01/1896 Paulding Co. OH. Will exchange info and welcome all correspondence. Mrs. Caroline Wells Longardner; Rt 2 Box 187; Antwerp, OH 45813; phone 419-258-2222.

I noted that she has Amanda's birth as c1846 where you have c1853. This is not unusual. I doubted that two children had been born in 1846, but had no personal knowledge to base a change upon, so I quoted it as received.

Unless you already know her, you have found a cousin. Please note that the address and phone number above was at least 14 years ago. Area has probably changed to street addresses by now instead of rural route. Also, telephone area code and/or zip code may have changed. I have not heard from her since, so I have no idea whether she is still there.

She shows Milo b. Connecticut; thinks that eldest son may have been born in Vermont. If these assumptions are correct, then Jane is of one of the New England families. There were at least two of those: **Roger TERRILL** and **Abigail UFFORD** of New Milford CT; and **William THERRELL** and **Rebecca SIMPKINS** of Boston MA. Both arrived early 1600s. Descendants of both mingled and migrated across New England then south and west.

If the first son was born in VT, they probably married either in CT or VT. Check with the Connecticut Genealogical Society. They have transcribed city records back into the early 1600s and may have a record of the marriage.

I regret that we do not have more but very little has been shared with us by descendants of the New England lines. I am sending a copy of this to our president, Mr. Don C. Terrill, in case he has something in his "family tree" database that I do not. Dan Brinson
