### STONE AGE

The Proven; The Probable; The Possible; and The Mythological from Europe
Walter Garland Duke wrote a book in 1949 titled HENRY DUKE, COUNCILOR. Pages 398-400 contain the lineages from Pepin Le Gros of Heristal through 25 descendents ending with Sir Thomas Tyrrell, of Heron, Sheriff of Essex and Herts in England in 1460. The line of Ralf, Sire de Tirel continues:

- 109 Fulke De Tirel, md. the "noble lady" Orielda; in old age became a monk of St. Evroult which he endowed.
- 110 Sir Walter I de Tirel, b. c1010; Lord of Poix, Castellan of Pontoise, Viscount of Amiens, a Baron of France & England; Lord of Laingaham, Essex, and Kingsworthy and Avon, Hants, England. He built the castles of Poix and Famechon, in 1046; and Moyencourt in France; was present at the battle of Hastings 1066 with William the Conqueror his kinsman; md. Olga, a Saxon, from whom the continuing line is descended; afterwards md. in France, Alix, Lady of Fremontiers and of Famechon before 1046; In the Primal Church of Rouen, in 1030, he is mentioned as a wealthy nobleman; d. 1080.
- 111 Sir Walter II de Tirel; md. Ann de Clare, dau. Gislebert Crispin, Count d'Eu and Brionne who was a grandson of Richard I, 3d Duke of Normandy, and was murdered in 1040. Gislebert Crispin is stated to have married Arlotta, dau. of Fulbert de Croy, a blacksmith in Falaise, who was the mother of William the Conqueror by Robert II, "le Diable", 6th Duke of Normandy. Unless Gislebert Crispin married subsequently, Ann de Clare was half-sister to William The Conqueror; contrarywise, she was no relation.
- 112 Sir Walter III de Tirel; Lord of Poix, Laingaham, Kingsworthy, and Avon and a Baron of France and England; Castellan of Pontoise 1091; was present at the siege of Jerusalem, First Crusade, 1096; accidentally killed William II,

Rufus, King of England 1087 -1100 by a glancing arrow while hunting in the New Forest; md. Adeliza, dau. of Richard Fitz-Gilbert, founder of House of Clare, and Rohaise de Bolebec who was dau. of Walter Giffard, the elder, Count of Longueville in Normandy, created in 1066 Earl of Buckingham, who was the owner of 107 lordships and commanded the army of King William, Rufus, of England, in Normandy in 1089; Sir Walter III de Tirel died in the Holy Land in 1136, Second Crusade.

- 113 Sir Hugh Tirel; Prince of Poix; md. Ada, dau. of Etienne de Champagne, Compte d'Aumale; sold Laingaham in England prior to joining the Second Crusade in 1146; died in 1159.
- 114 Sir Hugh Tyrrell; Lord of Poix and first Baron of Castleknock, Ireland, in 1173; was with "Strongbow" of Ireland in 1169; was Governor of Trim in 1183; was at the siege of Acre in 1191 (Third Cursade) and was known as "The Grecian Knight", one of "De Lacy's Barons". He md. Isabel de Viganacourt in 1161 and secondly Marie de Senarpont 1173; died 1199; buried at Selincourt, Picardy, France. (continued next issue)

William Dicks 02/07/1787 Guilford County NC (Ency. of American Quaker Genealogy, Vol 1 p. 577) New Garden Monthly Meeting N. C.

Terrell, Aggatha AGGA; Miss; (12/17/ 1749--1769+) born Caroline County VA dau of David & Sarah Johnson T.; member of Cedar Creek Monthly Meeting of Friends; (Ency American Quaker Genealogy Vol VI p 274); Caroline Co, VA.

Terrell, Amelia; Miss; (c1796--) dau of Simon & Sarah Thompson T.; md. Thomas Hollingsworth.

### WAGONS WEST Revolutionary War to WWI

TERRELL, JOHN (Continued from previous

issue): 02/11/1811: John Terrell of Randolph Co. (original name of Jasper Co. between formation 1807 & 1812) GA sold unto Johnathan Hammond of Greene Co. GA for \$100.00, 50 acres in Greene Co. on the waters of Richland Creek bounded on the south and west by Prince on the north by Ralls?, and on the east by Baldwin. Signed John Terrell; witnesses William Hammond, Susannah x Hammond, George W. Dillard, J. P., recorded 06/30/1818. (Greene Co. GA., Deed Book &&, 1818-182?; p76-77) 02/14/1812, Thomason Welborn and Williamson Robey of Putnam Co., GA sold unto John Terrell of Randolph (soon to be Jasper) Co. GA for \$212.00, half of Land Lot 42, 15th. Dist. of Baldwin Co. at the time of survey, but now Randolph Co., containing 101-1/4 acres bounded by John Edwards, lying and being on the waters of Murder Creek. Signed Thomas Welborn, Williamson Robey, witnesses: John Wright, Williamson Boswell, Johnathan Hearne, J.P.; date recorded was not shown but was probably 05/04/1813. (Jasper Co., GA. deed book 5, part 2, p.556-557) We believe our John Terrell was active in the Baptist church and possibly in some others when no Baptist church was available. One John Terril was charter member of Providence Baptist Church, Shadydale, Jasper Co., GA 12/15/1810; 04/22/1815, minutes mention three members including bro Terril - - -: 05/27/1815, Bro. John Terril refused to hear the church, the church thought him to be wrong and excluded him from us; 12/25/1819, restored bro. John Terril to fellowship; 01/22/1820, dismissed bro. John Terril at his request; 03/24/1821,

received bro. John Terril by letter from Mirtle Springs Church. Some time betweeen 1821 and 1823, he moved to Henry Co., GA. 11/01/1823, John Terrell was commissioned Justice of the Peace, Henry Co., GA Dist. 552, Capt. Holden's Co. (I believe dist 552 is now in Butts Co., indicating that

he lived in SE section of original

Henry Co. GA.)

08/28/1828, the Justices of Inferior Court (forerunners of Co. CODMIS-

sioners) Henry Co., GA. ordered a road built which later became known as Macon road, beginning at Camp's Ferry on South Ockmulgee River to McDonough to pass in front of . . . "Jesse Travis' land, William Copeland's, Harper's Ford on Walnut Creek, William Hooten's, James Sellars, Jesse Oslins, between 7th and 8th dists. Henry Co. on the district line to R. Hull's, JOHN TERRELL'S, Daniel Nolley's, Mc Kibben's, Phillippi Meeting House (Baptist?), J. A. Ellis, Woolf Creek. R. Cheek, Moses Rossers, McCorley's, to McDonough. Later, possibly until today, it became known as North and South Ola Rd. (Minutes Henry Co., GA)

TERRELL, ANTHONY LAIRD (06/27/1961--) probably born Fulton Co., GA; son of Ronald Marlin Terrell, Sr. and his first wife; married Kimberly Newton 08/12/1979; no further info.

TERRELL, BARBARA JACKSON (05/08/1931--) born Fulton County, GA; daughter of Lowell Sylvester & Eleanor Jackson Pace T.; reared in Clayton Co. GA; married 02/28/1954 at Hapeville Presbyterian Church, Fulton Co., GA to Thomas Frederick McDonald; mother of 5 children; teacher; address, 9725 Brown Rd, Jonesboro, GA 30236, ph. 404-478-9216.

Beulah was daughter of John Thomas Huett (11/04/1874--08/10 /1902) and his first wife Susan Alice Wilson (11/20/1875--10/06/1900) daughter of Thomas Lorenza 'Dow' Wilson, of Coosa County Alabama. Beulah married Linson Theodore Palmer (07/01/ 1889--?) on 11/24/1912 in Coosa County Alabama. They farmed a few years Coosa County then moved to more lucrative employment in the textile mills in Sylacauga. Theodore and Beulah lost a daughter, Era Mozelle

Palmer (11/16/1913--03/25/1914). Their other daughers, Nora 'Dessie,' Avis Idelle, & Jewel Faye all are still living and have lovely families. Patricia is now Patricia Ludlum and lives in or near Macon, GA.

Terrell, Charles Lynch; Mr; (--1781+) son of Micajah & Sarah Lynch T.; 10/ 09/1779 complaint against him discontinued; 01/13/1781 member of Caroline Meeting reported that he 'has agreed to take the place of a soldier in a military capacity & also active in horse racing; under care of MM; 07/14/1781 condemned for misconduct; deferred; condemned again in 10th month; 11/10/1781 dismissed sundry disorders & military services; family listed in South River Monthly Meeting; (Ency. VA; son of David & Sarah Johnson T.; 01/19/1782 received by South River MM of Friends on certiffrom Cedar Creek MM icate 08/24/1781; 06/15/1782 one David Terrell in South River MM reported married to Sarah Goode; 01/19/1793 one David Terrell of South River MM granted certificate to Cedar Creek Meeting to marry; 01/21/1794 David Terrell Jr. of South River condemned misconduct; 02/13/1796 Patty wife of David received on certificate from Cedar Creek MM dated 06/13/1795; 03/12/1796 one David Terrell under care of South River MM for dancing; 06/11/1796 one David Terrell Jr condemned for dancing and fiddling; acc & read at Hills Creek meeting; 12/08/1798 David Jr. disowned; paper read at Hills Creek Meeting; (Ency.
