!nez Christian Doshier 85, of Amarillo, Texas, died Saturday, September 16, 1989 at 2:46 a.m. Services were held Monday, September 18, by Rev. Roy Wheeler, pastor of Paramount Terrace Christian Church with the Rev. Jim McCullom officiating at the burial. Burial services were in the Claude Cemetery by N.S. Griggs Funeral Home.

Inez was the daughter of James Terrill and Georgia Jones Christian. She was born December 16, 1903 on th Christian Ranch, 14 miles south west of Claude. She had an older brother, Jones Richard and sister, Avis Ela Christian Nelson, and an younger brother, William Terrill. Her early education was secured at the Llano Community School near her childhood home. Later she attended Clarendon Methodist College, where she met her future husband.

She married Forrest Brooks Doshier, August 4, 1921. They farmed in the

Llano Community on what was known as the Hughlett place, until 1949, when they moved to Amarillo, they built their home at 1501 South Rusk, Mr. Doshier died January 1972. Inez sold her home in January 1989 and then resided in the Continental Retirement Center, 1300 Jackson, in Amarillo.

Her interests before retirement were ranch and farm life. her Llano Community Club, church and school activities. All of her life she was interested in local and family history. Much local history has been preserved because of her deep love of it. Several family histories have been published as well as the life of her father and fatherin-law, both early cowboys of the JA Ranch, perserved for the families. She had a talent for poetry and published a book of her own poems as family Christmas

She devoted her adult life to research, the preservation of Texas history and to genealogy. Many of her articles have been published in Western magazines. She was included in "The Texas Women of Distinction", and "The Hereditary Register of the United States of America", 1975.

She was a member of the "Daughters of the American Revolution, Colonial Dames of the 17th Century, Daughters of the Republic of Texas Magna Charta, The Amarillo Genealogy Society (life member), The Panhandle Plains Historical Society, as well as many other historical and genealogical societies.

Her contributions to the Amarillo City Library Genealogical Department, resulted in hundreds of volumes. Hours were spent helping many people on their family lines either at the Library, by mail or at their home. Her private books were loaned to people all over the nation.

Terrell Gives Land To UGA Foundation

School Of Forestry Resources Will Use It

Charles W. Terrell is giving one thousand acres of north Grady County land to the University of Georgia Foundation for educational use by the university's School of Forest Resources because, he said this week, he's "trying to pay a debt".

"If we're honest with ourselves, we will admit that we all owe the earth something and those of us who can should pay on that debt by trying to leave it better than we found it," he explained while discussing the gift and his decision to make it.

Mr. Terrell is not, however, just seeking preservation of his thousand acres of woodland and open fields, although, he admits that protection of forested land and its inhabitants has become almost a religion with him over the past thirty-

"Although it's vital that man starts taking care of the earth, I realize that man will also be served so we must find ways to make forests productive while preserving them and, in my weak way, I'm trying to show that the land can produce and still be a pleasant environment," he said.

His decision to make the deed of gift to the University of Georgia is based on a conviction that the university will see to it that his land management efforts would be continued.

The transfer of title to the one thousand acres in three tracts in the Blowing Cave militia district of north Grady County from Terrell to the University of Georgia Foundation is an accomplished fact and a detailed agreement on how the property will be used is now being formulated, most of the specifics having been agreed upon during months of negotiation.

"I've been working on the agreement for a long time and I'm enthused about developments," Terrell said, emphasizing that he envisions the property being used forever as a "tree farm" with mature trees harvested for timber, not as a reserve or preserve in which nothing is altered or disturbed.

"We must now learn to have our cake and eat it, too, when it comes to forests," he said, adding, "A combination of productivity and preservation is necessary."

Mr. Terreil also wants the property made available for public use and the public encouraged to use it for any purpose other than hunting and killing its wild inhabitants.

"We've got to start taking care of our wildlife as well as the land and forests," he said.

He is a Navy veteran and a graduate of the Massachusetts Institute of Technology (MIT) and he moved back to his native south to work as an engineer on construction of the Jim Woodruff Dam in Seminole County.

Clearing for the dam and Lake Seminole behind it first prompted his interest in trees and a corresponding concern over the mass destruction of forests, the result being the purchase of various tracts of south Georgia property and the beginning of thirty years of work at reclaiming eroded and abused land with reforestation and at teaching himself good forest management practices.

"There's a lot to learn in foestry," he said, adding, "It's not a dull, dead subject."

Terrell has healed most of the wounds inflicted on the thousand acres he is giving to the University of Georgia Foundation with the planting of both pines and hardwoods as well as cypress in appropriate places and, in his agreement with the foundation, he is making sure that future abuses will not occur.

Paved roads will never be built on the property and, in discussing the gift with foundation authorities, he first requested that no buildings be allowed to disturb the pristine state of his woodlands. He withdrew this objection, however, on realizing that at some point educational buildings may be needed to enhance the School of Forest Resources' use of the property or for other University of Georgia purposes.

Mr. Terrell, who is 73 and has lived alone since his wife, Margaret, died ten years ago, will live in his current residence and manage the woodlands for the remainder of his

life

And, for as long as he lives, he will continue to devote his time and talent to making sure the Charles W. Terrell Memorial Tree Farm will not only be a lush and beautiful laboratory in which University of Georgia forestry students can further their education but also the best example possible of forest land that can be both productive and protected.

Nancy Terrell, aged 73 years, a resident of Campville, in the state of Florida, who being duly sworn according to law, declares that she is the widow of James Terrell. deceased, who was the identical person who served under the name James Terrell, as a private in the company commanded by Capt. David R. Bryan, commanded by Robt Brown in the Seminole War: that her said husband enlisted at Troublesome, Lowndes County, on or about the 1st day of July, A.D. 1838 for the term of 3 months, and was honorably discharged at Troublesome, Lowndes County, on the 15th day of October, A. D. 1838; that he also served in Capt. Solomon W. Morgan's Compnay 7 days in Oct. 18??(not legible) Regt. (Mounted Militia) Vols, and in Capt. Saml. E. Swilley's Co. Mills 2nd Regt., East Florida Vols. from June 16 day 1837 to December the 18th 1837: that he was not otherwise employed in the military or naval service of the United States.

That at the time of entering the service claimed for her said husband was 19 years of age, 5 feet 6 inches in height, with grey eyes, black hair, fair complexion, by occupation a farmer, and that he was born at Liberty County, state of Georgia.

After leaving the service, he resided at Lowndes County, Georgia 3 or 4 years, then in Marian County, Fla a few years, then in Alachua Co. Fla. to his death in 1864.

That she was married to him on the 10th day of March. A. D. 1841 at Lowndes County. Ga. By Samuel Clyatt. a Justice of the Peace under the name of Nancy Guthrie: that she had not been previously married.

That her husband died, or was killed at the battle of Ocean Pond or Olustee, Fla. the __ day of __ 1864; that she has not since remarried; that she has not heretofore made application for pension.

Hand written letter:

Sept the 1, 1863

Dear Wife. I seate my self to let you know that their is a great deal of sickness in this place for nearly one half of the men is sick. I have been too trips to see the yanky vesel. I saw her once. Dear Wife. I have just done washing and set down to write you a few lines. I received your letter dated August the 24 which gave me a great pleasure to hear that you all well and to hear them prayer. Don't forget to pray my Dear Children. I remember you all in my prayers. I

to see you verry bad. Dear wife, you wrote about the nine children law. There is no such law. if there was, I would try to get out. their is a great dissatisfaction in the army and I hope will be the means of Peace. Dear wife. I want you to kiss all the children for me and kiss yourself a thousand times for me and then kiss that darling babe. I want you to get me a fine tooth comb and send it to me. Whenever you can and as soon as you can. O my Dear wife, I would give thousands of dollars to see you, how is your Potatoes and Pees coming along. Dear wife, you need not send for sait til you hear from it. I sent it, but it went wrong. You must keep inquiring at Waldo for it and when you hear of it get [Yoman?] Dyess or Billy Perry/Percy? to go with James after it. I have paid the expenses on it. Sept. the 2. Dear Wife, I have tried to get of to see you all this morning but can't so this leaves me in tolerable health except a cold. Nothing. I Remains your affectionale husband till Death. Signed James R. Children were appointed guardians upon being orphaned. In addition, male children were bound out to be taught a trade. During this apprenticeship period, the apprentice usually resided with the journeyman and would of the original purchaser. appear as a male youth in the household.

GA for the wedding of Dean TERRELL and Nina SHEPPARD and was driven by the couple on their honeymoon.
