A few years ago, a leaky battery destroyed the 286 board and Dan replaced it with a 386 board and an additional 2 MB of RAM.

All this has been done at Dan's expense. The TERRELL SOCIETY has not paid for anything except expendable items such as paper and printer toner.

The major bottleneck in the system is an old MFM controller and hard drive limited to 42MB. This limitation has made it impossible for us to maintain an electronic library of TRAILS, much less to begin accumulating an electronic collection of other data such as the volumes in the LENDING LIBRARY.

We have some members who have computers and who have expressed an interest in electronic volumes consisting of TRAILS Index, membership list, and other information. We have been unable to respond favorably toward those requests.

Dan currently exists on a monthly income about equal to what the average family in this country has per week. He no longer has the funds to enlarge and improve this computer system.

The board of directors (excluding Dan Brinson) voted to make improvements on the existing system in the form of a 500-600MB Hard Drive and a 14.4K modem.

In order to prevent a dual ownership system, the officers voted to transfer ownership of the hard drive and modem to Dan Brinson at the end of 1 year if he continues to edit and publish TRAILS for that period.

Dan Brinson abstained from voting on these improvements. A NO vote would continue to cripple our ability to serve you. A YES vote might be misconstrued as self-serving due to the one

KILLER SENTENCED TO LIFE IN PRISON

John Paul KNOTTS, self-confessed killer of our son, Charles Daniel BRINSON, was convicted of felony murder by jury trial in Dallas, Paulding County, GA. He was sentenced to life in prison on Nov 17, 1994. Currently, the average time served on a life sentence in GA is 14 years.

Since true justice, bringing our son back to life, could not be obtained; I am content with the result.

I do not want Mr. KNOTTS executed. I want him to live to bury at least one of his children, then live a lot of years thereafter to know exactly how we feel.

I trust that his years in prison will result in more pain and suffering than he inflicted upon our son. At least, it will be a long time before he will be free to harm anyone else.

Thanks again to each of you who called or wrote expressing sympathy. Just knowing you cared helped to make the burden lighter.

Yesterday I received the following information in a letter from the Indiana Commission on Public Records. I thought it might be of interest to anyone with ancestors who were in Indiana Civil War units.

"The State Archives does have a card file of all those who served in Indiana regiments... Because of the wealth of resources at the Archives concerning the Civil War, and the number of patrons requesting information on Indiana veterans of the war, the Archives staff has put together a package of records for the researcher and family historian.

For a \$5.00 fee, the staff will compile, for any individual soldier, a copy of his muster roll entry card, a copy of the company roster from Terrell's 'Report of the Adjutant General' and the brief regimental history written by Terrell.

All a patron need do is send a letter with all the information available for the veteran, along with a check for \$6.00 (the \$5.00 fee, plus \$1.00 for postage and handling). The check should be made payable to the Commission on Public Records..."

He was commissioned on 4 December 1776; was promoted to the grade of Second Lieutenant on 16 April 1777, and to the grade of First Lieutenant on 1 November 1777. His name last appears on a return for the period of 1 January 1777 to 24 Jun 1778, without a remark relative to his service. This information was documented by **June Oglesby Pickett** for entrance into the DAR, **Cornelia Greene Chapter**, St. Louis MO on 3 May 1916 and accepted on 22 Jun 1916 with a national number of 123807. (REFN DAR LB 118070 and 123492)

CHEROKEE EMIGRATION & ENUMERATION TIME LINE

1782--Cherokees who fought on the British side in the Revolutionary War petitioned the Spanish Governor at New Orleans for permission to settle on the west side of the Mississippi within Spanish territory; permission was granted

1794--a group of Cherokees under The Bowl settled in the St. Francis River valley in present southeastern MO; may have joined others who had already emigrated there & were joined from time to time other tribesmen

1808--the number of Cherokees, large & small west of the Mississippi were computed from public documents at 1,000

1811--December, great MO earthquake occurred; Cherokees feared the Great Spirit had put the country under ban; moved en masse to territory between the Arkansas and White rivers in

present day Arkansas during the winter of 1811-12; other Cherokees from the old nation joined them; emigration was irregular and the number uncertain with no record to be found but the number is supposed to have been about 1,000

1817--July 8 at Turkey Town (in present day AL) Cherokees ceded two large and two small tracts of land east of the Mississippi for one of equal area in the West between the Arkansas & White rivers; inducements included "to give all poor warriors who remove a rifle, ammunition, blanket, and brass kettle or beaver trap each with full compensation for improvements left behind by them." Several hundred Cherokees emigrated in 1818 & 1819

1819--February 27, Cherokees ceded several other large tracts of land in another treaty; Secretary of War instructed Governor McMinn to give no further encouragement to emigration to Arkansas but to proceed at once to wind up business under the treaty of 1817

1820--June 15, Secretary of War instructed agent MEIGS that emigration to Arkansas under patronage of the Government had ceased; those who had enrolled for removal and those who determined to go later must do so at their own expense; emigration was sharply curtailed until the next treaty

1828--May 6, the Cherokees ceded their lands in present Arkansas for lands in the present state of Oklahoma; Article 8 provided that "each head of a Cherokee family east of the Mississippi desiring to remove to . . . be furnished by the U S with a good rifle, a blanket, a kettle, five pounds of tobacco, compensated for all improvements he may abandon; also a blanket to each member of his family. U S pay expenses of removal and furnish subsistence for one year thereafter. Each head of family taking with him four persons to receive \$50. This inducement increased Cherokee emigration to the west once again

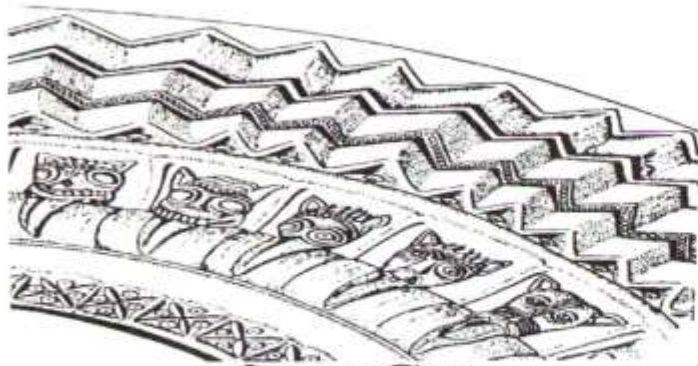

Kitty Tyrrell, or is it Kathleen?

A little casual research at the British Library in London and the collection of the Tyrrell Family History Society in England has turned up an odd coincidence. Pictured here is sheet music from two songs, written during the same era, having similar titles, and having quite different lyrics.

The first, from the T.F.H.S., is titled "Kathleen Tyrrell" and was collected by Edward Bunting. We know that he was "born in Armagh in 1773 and died in Dublin in 1843. He was an organist in Belfast who attended the final meeting of Irish harpers in 1792, recorded their music as played, and then travelled, adding to his collection. He published volumes of the music in 1796, 1809, and 1841." (*The Oxford Companion to Music*, by Percy A. Scholes). This particular sheet music was taken from *The Oxford School Music Books, Teacher's Manual Junior (Books 1-3)*, ed. Roger Fiske and J.P.B. Dobbs (Oxford University Press, London, 1953), pp. 246-247, from which we also find the above description of Edward Bunting.

The second was found in an old folio in the British Library and is titled "Kitty Tyrrell!" (Charles Jefferys, "Kitty Tyrrell" (a song), folio, London 1860, Brit. Lib. 11621.k.5 (327)). As you can see, "Kitty Tyrrell!" is quite different from "Kathleen Tyrrell." Also, this version consists of lyrics only and is attributed to "E. Hodges, Printer, Soho" [London]. I might have supposed it to be a poem, but the index says it is a song.

The folio itself is dated 1860; however, the contents are considerably older. It consists of clippings of lyrics cut from newspapers and weeklies. From the type faces, they seem to date from the late 1700s to 1860. The type face on this one looks like about 1830-1840, which makes it fairly contemporary with the publication of "Kathleen Tyrrell," above. The two dissimilar songs with similar names form one of the strange little footnotes in Tyrrell history.
