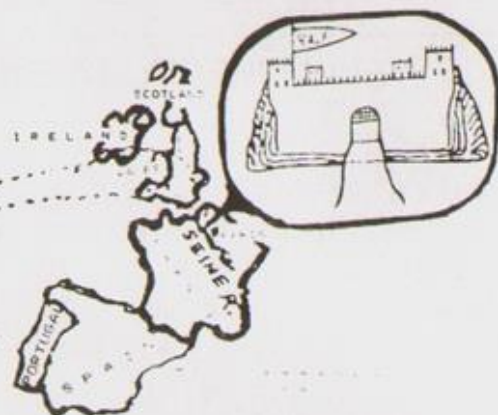

WILLIE LONG TERRELL PASSES

I was informed by **Vernon TERRELL** that our member, **Mr. Willie Long TERRELL** of Newnan GA passed away in March, 1998. He promised a copy of the obituary, but none has been received.

Mr. Terrell was our first (and to the best of my knowledge only) black member. He claimed to have descended from **Dr. Joel Wingfield TERRELL**, physician of Newnan GA prior to 1850.

BOBBIE TERRELL LEDFORD PASSES

I received a note from **Lucretia LEDFORD Etienne** that her mother, **Bobbie LaVall TERRELL Ledford** of Longview WA passed away March 1, 1999. I have not received a copy of that obituary either. If one is received on

either of these deaths, I'll pass it along in the next available issue.

PRIVACY POLICY

I haven't addressed this issue in several years. There appears to be a need to restate our privacy vs. publication policy.

The Terrell Society of America, Inc. has always operated on the premise that if we each share our information, it will eventually compile a more accurate, complete picture of the TERRELLs in America.

Everything submitted to the Society is considered to be for publication unless you tell us differently.

You may appear first in TRAILS under WELCOME NEW MEMBERS. You may appear next in TRAILS in the form of a TERRELL lineage chart. The membership list is also posted on our web page, complete with addresses and phone numbers—unless you have told us to withhold all or part of that info. It may appear again under CHANGES when you change residence address, phone number, or e-mail address. **Your name and address will always appear with a query. How else can anyone with the info you seek contact you?**

The mere fact that a form has a blank asking for information does not obligate anyone to supply the requested information. The blanks on forms are designed to paint as accurate and complete a picture as possible. However, it is not required that the picture be complete.

If you or some of your living ancestors don't want birth or other dates and/or places published; simply list them as "living" and omit the data that is confidential.

If your telephone is unlisted; tell us! I'll code it so I will know not to publish it. The alternative is not to reveal your phone number to us.

If you consider your residence to be a "private safe haven" and do not want that revealed, tell us! I can insert a place for a code to alert me not to publish that. It is a simple operation.

If you have submitted information to us in the past that you do not want to appear in TRAILS or on the WEB, write to Dan Brinson immediately and explain exactly what you do not want published. We will make every effort humanly possible not to publish it; or not to publish it again if it has been published.

The one exception is the index to TERRELL TRAILS. This is a comprehensive index of every name appearing in the 1200 plus pages. A publication of that size without an index is useless as a research tool. **If a name has been printed in TRAILS, it will appear in the index along with the page number(s) where it appears.**

We want to abide by your wishes, but we cannot do that unless we know about your special desires.

CORRECTIONS

I haven't gone to sleep at the wheel—yet. Although I cannot say the same about the computer. My TERRELL volunteer work is frequently done in the wee hours—without the benefit of caffeine.

On page 1211, I erroneously listed Beatrice TERRELL as the daughter of Henry & Maria TERRELL. I overlooked a generation.

Mr. John F. TERRELL

was kind enough to point out that she was their granddaughter; daughter of Edmund Duggan TERRELL & Adelia O'NEAL. Reference

DICKEN, p. 137.

Mr. TERRELL

added, "Beatrice TERRELL did marry Robert Franklin BAGLEY. Another daughter of Edmund & Adelia, Winnie TERRELL, married William BAGLEY, Robert's brother. All lived in San Marcos. Henry TERRELL and Maria DUGGAN were my g-great grandparents and are buried in the Old San Geronimo Cemetery along with other family members including my parents." (see photo)

About the same time, I erroneously listed the CHAMLEE WEDDING as a BARRETT WEDDING from Mr. CHAMLEE's middle name. Mrs. Chamlee called this to my attention in the following note.

Alan Barrett CHAMLEE, and **Beth Ann NOLAN** (of Macon). Please note on page 1206, under their picture, it says "BARRETT WEDDING" — well, of course, it is a "CHAMLEE WEDDING" —

Our son, Alan, carries the middle name **BARRETT** because that is my maiden name. My sister and I are the only children of **Howard & Juanita TERRELL BARRETT**, so I elected (and my husband agreed) to give our son the middle name of Barrett in honor of my dad's family.

I was glad to see the note from **John F. TERRELL** of Texas — he and I have chatted on the phone and he is so interested in the Terrell history.

Charlene TERRELL (married to **David TERRELL** of Big Canoe, GA, is a very interesting person and her writing is exemplar.

We always enjoy your *TERRELL TRAILS* — keep up the good work!!

Had a chat with **Jeddie Mack [TERRELL]** the other day — I had no idea he had had surgery, but he sounded so good on the phone and was so chipper — he is one Special Guy!

I am going to give you the information that I can find or should say that I have obtained and lets hope you can assist me in my quest. We will begin with Susan: I have it listed as **Susanna Adaline TERRELL**, b. 1827, d 13 Sep 1873, age. 46, of typhoid fever near So. Union, Oconee Co. SC, dtr. of **Aaron & Clarissa TERRELL** of Pickens Co. SC. All their children it appears were born in Oconee Co. SC.

The records I have are from Vandiver p.101, Will, Fed. Census 1860 p.69, 1870 p. 44.

I did find out that Susan died when she went down to GA to care for her son **William F. SPEER** who had typhoid fever, and he lived at Franklin Co. GA. The information states that William and his daughter were both gravely ill with the disease when the mother died, but he apparently lived. Now he had a daughter named **Hepsy Ida SPEARS or SPEER**, and a son **Clifton** both born in Franklin Co. GA.

In looking at the old history at one time Franklin Co. GA was a part of Anderson Co. SC or visa versa. I tried the Methodist records and could find nothing in S.C. and have not been able to go further.

If I could find out the newspapers or where the White Rock or Clearmont Academy were at it would help to maybe pin-point more. **Yolande Josephson "Fred Josephson"** <ozelloborries@worldnet.att.net>

Thank you for your response. I now have more information than I did.

Josephine TERRELL was the daughter of **Edward S. & Nancy**. **Edward S.** married **Lucinda PEVELER** in TX. In the brief biographies from Young Co. TX, there is no mention of his first wife and child. I haven't been able to find where Nancy died. Between KY and TX, there seems to be no trace. He was in KY in 1836 when **Josephine** was born, and in TX in 1844, according to his records. Again, Thank you. **Donna** E-MAIL: Dstadgen@aol.com

(1769-1817) **Jepthah TERRELL** - 1811 from land records

(1791-1859) **Matthew TERRELL** - 1812 from land records

(1796-1881) **Eppy CONNELL** who married **Matthew TERRELL** in 1816

All are from Champaign County. Their records are on file with the Ohio Genealogical Society in Mansfield, OH.

I am enclosing a family group sheet on **Marshall TYRRELL** and his wife, **Sarah CURTIS**. I have them on 1850 census at Warner, Bradford PA, indicating both were born in CT. I know from their obituaries that they lived in Fillmore, Fillmore, MN before coming to Madison Lake, SD (apparently to be near their daughter **Olive TYRRELL Miller**).

Marshall TYRRELL (09/10/1808—06/05/1883) m. 11/27/1831 at CT to **Sarah CURTIS** (08/01/1808—06//1883) both b. CT, d. Madison Lake SD, & buried in Graceland Cemetery there. No parents known for either. Children:

1. **Olive Ellie TYRRELL** b. 1832 CT, d. 06/11/1883 Madison Lake SD, buried Graceland Cemetery; m. **Hiram MILLER**.
2. **Harriet TYRRELL** b. 1832/33 PA; no further info.
3. **Ellen TYRRELL** b. 1832/33 PA; no further info.

4. **Preston C TYRRELL** b. 1843, unlisted location; d. 05//1883 Madison Lake SD, Graceland Cemetery; m. **Francis NOT LISTED**.

Editor's Note: It is unusual for that many members of a family to die within 2 months. Does anyone know what epidemic or local disaster struck Madison Lake SD in 1883? Shirley did not join us but she is interested in any and all information you may have about this ancestor of her husband. *DFB*

This enquiry was passed on to me by **Richard Tyrrell PRICE** (31) who had received it from his son who in turn had found a request for information from a **Sylvan F. TYRREL** from Dallas Texas on the Internet. Sylvan was seeking information about the parent's of **Roger TERRELL** who sailed to America arriving at Connecticut on 26th June 1637 and who married **Abigail UFFORD** the same year.

Members may recall reading my report of a similar enquiry from **Sherman Lee THOMPSON** from California in the June newsletter.

As with Sherman I provided as much information as I could about Roger and explained that there were two Rogers born at the beginning of the 1600s namely 1605 and 1610. To the best of my knowledge no one has yet been able to prove which of these Rogers was the one who settled in America.

There is a leaning by our American cousins towards the **Roger** who was baptized at St. Giles without Cripplegate on the 4th April 1605 the son of **John**. They believe that this may be the **John Terrell** who married **Xpian FINCHE** on the 7th Nov. 1602 at St. Gregory by St. Paul. However I do not believe that this is the case as **John** the father of **Roger** baptized 1605 also had other children baptized at St. Giles in 1599 and 1602 which predates the marriage of **John TERRELL** and **Xpian** at St. Gregory, also why did they not marry at St. Giles where they had their children baptized?

Roger Terrell & Abigail Ufford 1638

This was yet another of the many inquiries which we get mainly from the United States regarding the **Roger TERRELL** who settled in America in the early 1600s.

This enquiry came from **Pricilla WOOD** of Chula Vista California. I replied with the information that we have about Roger explaining that there were two Rogers born at the beginning of the 1600s and that to the best of our knowledge

no one has yet been able to prove which of them was the one that settled in America. In fact the information provided was identical to that reported in the last newsletter and previously provided to **Sherman Lee THOMPSON**.

Whilst replying I put Priscilla in touch with Sherman who also lives in California and who is also descended from Roger. Priscilla replied to my letter and in addition to sending me a very detailed account of her family history right back to "Roger" also sent me a number of interesting articles relating to the early Terrells of America. One of these was an extract from *Burnett Genealogy* which states that **Roger** was probably a young man, in company with **Lord Leigh**, son of the Earl of **Marlborough**.

One view is that Roger may have traveled to America on the ship *Hector* in 1637 rather than the *Lion* in 1632, and it would seem that Lord Leigh was aboard the *Hector* although there is no mention of a Roger. [Ships log]

Priscilla has a copy of the will of a **Charles TERRELL**, Gent. So was Lord Leigh a relative of Roger? Can anyone help on this link between Lord Leigh and Roger?

MADISON for himself his heirs executors and administrators does covenant with the said Lindley TERRELL his heirs and assigns that he the said William J. MADISON will and his heirs execs and admins shall warrant and defend the same to the said Lindley TERRELL his heirs assigns forever against the lawful claims and demands of all person whatsoever upon trust nevertheless that the said Lindley TERRELL his heirs and assigns shall permit the said William J. MADISON to remain in quiet and peaceable possession of said property and its appurtenances until default be made in the payment of said sum of eighty dollars in whole or in part and then upon this further trust that the said Lindley TERRELL shall and will so soon after the happening of such default of payment as be shall be requested be the said George H. TERRELL his admint or assigns so to do sell all of said property and its appurtenances or such part thereof as shall be sufficient for

the purpose at public auction to the highest bidder for ready money after having fixed the time and place of sale at his own discretion and given fifteen days notice thereof at three of the most conspicuous places in the neighborhood and also notified the same by advertisement the door of the courthouse of Caroline County on some court day previous to the day of the sale and out of the proceeds of sales shall after satisfying the expenses thenceof and all other expenses attending the execution of this trust pay to the said **George H. TERRELL** his exec admins or assigns the debt of aforesaid and the interest thereon or such part thereof as may then be due and the balance if any shall pay to said **William J. MADISON** his heirs execs or admins or assigns. But if the whole of said debt and accruing interest shall be fully paid off and discharged to the said **George H. The National Archives has now placed online at NAIL (National Archiveal Information Locator) the index for the Guion Miller rolls. These are applications for Cherokee enrollment.

MANY folks applied and were rejected. Nevertheless their information is available, so for example, if you had Creek ancestors who applied and were rejected you still are able to view their application if you have the correct number and name from the index.

There is an excellent site online that you can use to guide you through the Index and it is **Jerry Wright Jordan's** site at http://www.tngenweb.usit.com/cherokee_by_blood/miller.htm.

Once you find your people you may order the applications for a fee. There are usually 3 generations stated on each application.

They lost all their land. A lot of them were 3/4 or more white. The purpose of moving the "Indians" to Oklahoma was to void all land titles in Indian lands. Then the U.S. government took it and sold the land to white people. They voided Indian titles and issued their own.

There are stories about those same people coming back and purchasing their farm back without anybody complaining. Once they bought it from the United States they could stay there. Only the poor ones had to stay away.

THE EARLY TYRRELS OF HERON IN EAST HERNDON; PART ONE

By G. Andrew Moriarty, A.M., LL.B., F.S.A

Communicated by the Committee on English and Foreign Research

Submitted by Mr. James M. Allen, Jr. with following edited comment:

"In researching another line, I happened across [this article] on Family Tree Maker CD 181, English Origins of New England Families, Series 1, Vol. 3. The CD was apparently produced from articles that originally appeared in The New England Historical and Genealogical Register, and published in print form by the Genealogical Publishing Co. Inc. in 1984."

[By reference to The Register (volume 98, pages 277-8) it has been seen that the wife of John BLENNERHASSET, the ancestor of John THROCKMORTON of Providence, R. I., was Elizabeth, daughter of Sir John CORNWALLIS of Brome co. Suffolk. Sir John was the grandson of Thomas CORNWALLIS of Brome and his wife, Philippa, daughter and co-heiress of Edward TYRREL, Esq. of Downham co. Essex, a cadet of the TYRELLS of Heron.]

It is somewhat surprising that, so far as the writer is aware, no critical study of the TYRELLS of Heron has yet appeared. The following paper is far from complete and does not deal with the family prior to its appearance in "Essex in the reign of Edward I, and even then, the first generations of the family are not completely proven, but it does clear up some points in their pedigree and corrects some generally accepted statements before the pedigree becomes well authenticated at the close of the fourteenth century.

The Visitations of Essex for 1558 & 1662 contain long pedigrees of the family and the former deduces their descent from WALTER TYRREL, the Lord of Poix, who slew

William Rufus and who held the Essex manor of Langham of the de CLARES at Domesday. Walter had married Adelizer, daughter of Richard de CLARE of Bienfait by Rohese, daughter of old Walter GIFFARD (ROUND's *Feudal England*, pp. 468-479).

The TYRRELS were a great French house and their history is considered in two French works: *Histoire Genealogique et Heraldique de la Maison de Tyrel, Sires Puis Princes de Poix* by M. Curvillier-Morel-Acy (1869); and by the Abbe DELGROVE in *Memoires de la Societe d'Antiquaires de Picardies* (vol xxv, p. 287 sq., 1876).

Their pedigree also appears in the *Visitations of Bucks*, 1566, 1634. It follows the pedigrees given in the *Essex Visitations*. These Visitations being, of course, undocumented and compiled in a very uncritical period of genealogical research, cannot be accepted without further study.

In 1910, Joseph Henry TYRREL, Esq. published in his *Supplement to his Tyrrel History* (1909) an account of the Heron TYRRELS, but this is entirely undocumented, contains obvious errors, and shows no critical study of the family, for Mr. TYRREL had concentrated in his *history* on his own family, the Irish TYRRELS.

Walter [TYRREL], the Domesday tenant of Langham, was succeeded by his son Hugh, who went on the Second Crusade in 1147. Shortly before his departure, 1145-6, he sold Langham to the City Magnate, Gervase de CORNHILL, which sale was confirmed by the overlord, Gilbert de CLARE, Earl of Hertford, 1146-48; and still later about 1153 by Roger de CLARE, Earl of Hertford, who made another confirmation of the sale (Sir Christopher HATTON's *Book of Seals* nos. 84 and 105).

This appears to have ended the connection of the family with Essex until the TYRRELS reappear in Essex at the beginning of the fourteenth century in the reign of EDWARD I, and MORANT'S statement that they were evidently introduced into the county by the marriage of Sir James TYRREL with Margaret [?], daughter and heiress of Sir William HERON, is, undoubtedly, approximately correct (MORANT'S *Essex*, vol I, p. 208). Prior to this the TYRRELS, who undoubtedly sprang from the Sire de Poix, are found in Hampshire, Devon, Cornwall, Salop, and Beds. From evidence, which will later appear, it would seem that, as Mr. TYRREL has suggested, the Heron family sprang from the Hampshire TYRELLS. However, the writer has no evidence of their descent prior to their arrival in Essex early in the fourteenth century.

Accordingly, the evidence and records regarding them will now be presented, followed by a discussion of the descent of the Heron family.
