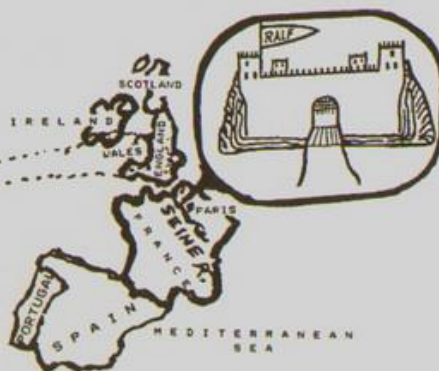

WITNESSETH that the said James Terrell for an Consideration of the sum of **three hundred pounds** lawfull money of the State aforesaid to him in hand paid by the said Moses Quals at and before the Ensealing and delivery of these presents the Receipt whereof is hereby acknowledged Hath Granted Bargained Sold and by these presents doth Bargain Sell Allien Convey and Confirm unto the said Moses Quals his Heirs and assigns for ever all the Right Title Claim or Interest and Demand Whatsoever of him the said James Terrell To a Certain Tract of land laying on Broad River in Union County Containing **One hundred and thirty four Acres**

James TERRILL to Nathaniel GUITON

THIS INDENTURE Made this seventh day of November in the year of Our lord One thousand Seven hundred and Ninety one and Sixteenth year of the Sovereignty and Independency of the United States of America Between **James TERRILL** of Spartanburgh County of the One part and **Nathaniell GUITON** of Union County and State of South Carolina of the other part.

Witnesseth that the said **James TERRILL** for and in Consideration of the sum of Fifty Pound Sterling Money to him in hand well and truly paid by the Said **Nathaniel GUITON** at and before the Sealing and Delivery of these presents the receipt whereof is hereby acknowledged he the said James

TERRILL hath bargained Sold Enfrossed Conveyed and confirmed unto the said **Nathaniel GUITON** and his Heir and assigns forever all the Right Title claim Interest and demand whatsoever of him the said **James TERRILL** a certain tract of Land lying and being in the County of Union and State of South Carolina on Broad River Containing One hundred and Fifty acres Originally granted to **Mannon GORE** by his excellency the Governor of North Carolina by a Pattent bearing date the Twenty second day of December in the year of our Lord 1768 and Conveyed from the said **GORE** to **Hugh QUINN** and from said **Quinn** to **Moses QUARRELS** from said **QUARRELS** to **James TERRILL** apurtained by Courses and distances as Follows (Towit) Beginning at a Chesnut and Hickory on the N. Side of the River on the side of the Island and Runs Thence crossing the Island and River South 60 W. 155 Poles to a pine thence S. 30 E. 155 poles to a White Oak thence N 60 E. 155 poles to a stake in the River thence to the beginning. Now This Indenture Witnesseth that the said **James TERRILL** hath bargained sold and conveyed and Confirmed unto the said **Nathaniel GUITON** and to his heirs and assigns forever all the aforesaid tract or parcel of Land Containing 150 acres as aforesaid Situate as aforesaid Together with all and Singular the houses orchards buildings Improvements woods ways water water Courses Rents Issues profits and advantages thereof or belonging or in any wise appertaining and the reversion and Reversions Remainder and Remainders and every part and partel thereof and all the Estate Right Title Interest use trust or possession property claim and demand whatsoever of him the said **James TERRILL** of into or out of the said premises and every part and parcel thereof to have and to hold the said Plantation or tract of land Containing 150 acres as aforesaid and every of the premises unto the said **Nathaniel GUITON** and to his heirs and assigns forever and the said **James TERRILL** doth hereby for himself his heirs and assigns Covenant and agree to and with the said **Nathaniel GUITON** his heirs and assigns in manner as follows that the said **Nathaniel GUITON** his heris and assigns shall and May from time to time and at all times hereafter peaceably and Quietly have hold use Occupy and enjoy the Plantation or tract of land Containing as aforesaid without Any Manner of trouble hindrance Molestation or denial of him the said **James TERRILL** his heirs or assigns and all and every of them and Them and from every other person or persons Will Warrant and forever defend the premises aforesaid unto the said **Nathaniel GUITON** and to his heirs and assigns forever.

TERRELL TRAILS

William S. TERRELL was a Baptist Minister in Rapides and Vernon Parishes in the mid 1800's. He constituted the *Laurel Hill Baptist Church* in Hicks (Vernon) LA in 1869. He was married to **Mary SAUCER**, probably in Mississippi, and 13 children were born.

After Mary's death, William Terrell married a much younger woman, and had 3 additional sons.

The second Ms. Terrell and children lived in Longleaf LA after her husband died, but no information is available on this second family. The Bible is currently owned by **O. C. TERRELL** of West Monroe LA. Date of publication of Bible was not available. All entries appear to be made by one person in beautiful script handwriting, and were transcribed by **Jane P. McManus** exactly as recorded in the Bible.

DEED 49-132 **CLAYTOR, Thomas C. (fr.) HUDGINS, Robert tr.**

This indenture made and entered into this 10th day of April 1843, between **Robert HUDGINS** and **Samuel C. SCOTT** of the first part and **Thomas C. CLAYTOR** of the second part whereas **Herbert ANDERSON** being indebted to **Pleasant TERRELL** in the sum of one thousand dollars with interest thereon from the 12th day of July 1841 did in order to spare this payment thereof by an indenture bearing date on the said 12th of July covey to the said **HUDGIN** his heirs and assigns, all that tract or parcel of land on which the said **ANDERSON** thus resides situated in the County of Caroline adjoining the lands of **Lewis GEORGE** and **Robert DICKINSON** and containing between six and seven hundred acres and also sundry slaves, in trust that in case said **ANDERSON** should make default in he payment

of the said debt it should be the duty of the said **HUDGIN** at the request of the said **TERRELL** to take possession of the said land and slaves and after having first duly advertised the time and place of sale for at least thirty days by advertisement to be posted at the front door of the courthouse of said county and at one or more public places near said land and inserted in some newspaper published in the city of Richmond ...the said land and slaves to sale by public auction to the highest bidder for cash and whereas the said **Herbert ANDERSON** and Francis his wife did by their indenture bearing date of the 11th of June 1842, in order to secure **Robert HUDGIN** the payment of the sum of six hundred and eleven dollars and forty seven cents and by single bill dated on the 10th of November 1841. Convey to the said **Samuel C. SCOTT** a certain tract or parcel of land upon and being in the said county of Caroline bounded by the land of **Robert DICKINSON** to theirs being the same land conveyed by the said **ANDERSON** to the said **HUDGINS** by the indenture aforesaid, upon trust that if the said **ANDERSON** should make default in the payment of the said debt to said **HUDGIN** by the said **Samuel C. SCOTT** should proceed to sell ...by public auction to the highest bidder for cash or by private sale for cash or upon a credit ...he should ...best the contingent right of dower for the said Francis in the land aforesaid reference in which deed are here made and are to be considered as apart of this indenture and whereas the said **Herbert ANDERSON** having failed to pay as ... the debt due to the said **TERRELL** as the debt due to the said **HUDGINS** and the beneficiaries under said deeds having required a sale of the said tract of land and Negroes named in said first deed the said **HUDGIN** in execution of the trust created by the deed after having given thirty days notice of the time place and terms of sale, by causing an advertisement of such sale to be inserted and regularly continued in the **Richmond Whig**, a newspaper published in the City of Richmond and by advertisement posted at **Ruther Glen [VA]** and at the front door of the courthouse of said county expose to sale at public auction to the highest bidder upon a credit of one and two years (except as to the sum of twenty-five dollars which was required in cash) purchaser to give bonds with approved security bearing interest from the day of sales and a deed of trust upon the land sold (said terms of sale being attended from the time prescribed by the deed of trust with the sanction and approval of the.....

In 1917 and 1918, approximately 24 million men, (98% of men present in America), born between 1873 and 1900 completed draft registration cards.

This civilian registration is often confused with induction into the military; however, a minority of the civilian men who registered were actually never called up for military service. During these two years, three registration days were held in which the registrants completed a registration card that generally included, among other information, birth date, birth location, father's birth location, and the address of next of kin. This updated file adds over 200,000 names to the previous database, bringing the total number of names provided to almost 900,000. It adds information from Alabama, Arkansas, Hawaii, Illinois, Louisiana, Maine, Maryland, Massachusetts, Michigan, New York, North Dakota, Oregon, and Vermont.

TERRELL R. BRYANT OF AR

Excerpted from *PEOPLE AROUND ENOLA* (Faulkner Co., AR) 1830 TO 1880 by **Debrill INGRAM**

In discussing the early history of this part of the country, and its settlement, we have to bring in just a bit of history. Where we are now was a part of Missouri territory until 1819. We were a part of New Madrid County, and this county reached from New Madrid, Missouri, to the north Louisiana line. Louisiana was made a state in 1812, Missouri in 1819 and Arkansas in 1836.

The principal settlements in Arkansas in 1819 were: Davidsonville, Arkansas Post, Cadron, Hopefield, Camden, Helena, Washington and Little Rock. A few settlers were scattered around Pine Bluff, Batesville, Grand Glaize, Giltrough and Jacksonport.

November 20, 1819, was the first election of any kind in Arkansas. On February 4, 1820, the county seat of Pulaski county was moved to the mouth of the Cadron, to the town of Cadron, and what we now call Cedar Park. Little Rock was made the state capitol in 1821. At that time, it only had one store, with very scanty supplies, but with a large supply of "Old Bald Face".

By 1825 the Greathouse Home was already built at what we now call Liberty. It was 38 miles north of Little Rock and 8 miles east of what is now Conway, on the Little Rock and Clinton road, which were by Holland, by **Jonathan HARDIN**'s house, by where my great grandfather **INGRAN** later lived, and on to Clinton. It joined the Batesville road there.

The Searcy-Springfield road crossed this road at **Jonathan HARDIN**'s house. The Des Arc-Lewisburg road came by El Paso, which was called Peach Orchard Gap in those days; by Bristol, a mile south of Enola, on by Union Valley Church, and joined the Little Rock-Clinton road at the Bowie place. Most of the early settlers in this part of the country, settled on or near one of these roads.

I have heard all my life of the settlement of **Jonathan HARDIN** at the Hardin Hill on the Cadron. What has intrigued me even more is Who were the next settlers? In this connection, you must remember that roads were almost

nonexistent, in those days. The first road of any kind to touch Faulkner county anywhere, was the Little Rock to Cadron road in 1807.

Cadron was one of the early post offices, having been established in 1820, with **Eli J. LEWIS** as the Postmaster. Cadron was dying out in the late 1820's and the office was discontinued. The people around what is now Conway then got their mail at a new office called Green Grove. It was near where **Bill ROSS** now has a store. Cadron was reestablished in 1848 and the office was at **Jonathan HARDIN's** house in 1850. Census records for 1860 show it at Greatgrand Pa **INGRAM's** post office. About his same time, we had an office at Caney Creek. It was about a mile and a half southeast of Enola. Muddy Bayou township reached from Mt. Vernon to the Cadron, and south of the Searcy-Springfield road to the Bayou. North of this road was Benton Township and it reached north to Quitman and Heber Springs. West of the Hardin hill to about 5 miles west of Greenbrier was Hardin Township. East Fork was south of that and Cadron was south of East Fork.

Mail service in those days was even worse than it is at present. You had to go get your mail, when you thought you might have some, and you had to do that until 1904. There was no RFD service at Enola until Sept. 17, 1914, and **Marvin MATTHEWS** was the first carrier.

The first steamboat to go up the Arkansas River, by Toadsuck, was the *Eagle* in 1822. The worst river accident that ever happened on the Arkansas River was the Lewisburg in 1820, when the boilers blew up on the *Cherokee*. It was bound for Ft. Gibson. It sank in 15 feet of water, with 17 killed and 20 seriously wounded.

I offer these bits of history just to show what a primitive state this country was in, which our forefathers began to come in, in the 1830's. The families that I will discuss settled within five or six miles each way of Enola. If I overlook some early settler, or make you kin to the wrong person, it's just and error on my part. Lots of early history is very hard to prove.

Jonnie BRYANT 45, and his wife **Hannah MITCHELL** 46, both from South Carolina, and his son **Absolum** 18, and **Terrell R. BRYANT** 20 and his wife **Clausa** 19, both from Tennessee, came to Enola in 1855. **Jonnie BRYANT** settled about a mile north of the Marcus Hill Church.

I have heard a story about **Absolum BRYANT** not wanting to come to Arkansas, and almost every nite he would run off and try to go back to Mississippi. This finally got old, and one nite before he made his trip, **Terrell BRYANT** wrapped

a white sheet around himself and disappeared. A little later, as **Absolum** was making his return threat, **Terrell BRYANT** stepped out from behind a tree and greeted him. **Absolum** immediately reversed his direction, and after that he lead the way into Arkansas.

In 1858 **Terrell BRYANT** bought 65 acres, lying south of the Searcy-Springfield road and one half mile east of Marcus Hill Church, for \$100. He bought this place from his uncle **Jonnie** and I'm looking at the original deed as I write this. It was witnessed by **Absolum** and **Hannah BRYANT** and I saw from this deed that they could both read and write.

Terrell BRYANT's son, **Marcus**, was the first one buried in the Marcus Hill Graveyard, and that how the church and graveyard got their names. I have heard that his first wife, **Clausa**, is buried in the **HARDIN** family graveyard. There are doubtless others there, but she is the only one that I know about. His second wife was a **LAVINDER**, **Jane MATTHEWS** was his third and **Matt SPENCER** was his fourth. All these are buried at Marcus Hill.

I examined a lot of his old papers in 1971. Among them is his certificate of appointment as justice of the peace for Hardin township in 1866. It's signed by **Powell CLAYTON** and has the oath of allegiance written in with red ink. I found his certificate of appointment as postmaster at Enola in 1886. I found his certificate to practice medicine, and that's why he moved to Enola. I found a deed for the land just south of the Marcus Hill Church in which my great grandfather, **A. G. Ingram**, sold to my wife's great grandfather, **Terrell R. BRYANT**. This deed is dated 1874 and made by **Steven E. LAMAR**. I saw from this deed that both my great grandparents on the **INGRAM** side could read and write. Many of his early deed are signed by his or her mark. He was quite a community leader. He was their doctor for many years, a druggist and merchant, a postmaster on two occasions, and a justice of the peace for many years. He is probably the cause of my father being a doctor and **L. T. and Steve LASLEY** being merchants.

Reuben SANDERS 37, and his wife **Susan** 21, and children **Hiram** 12, **John** 11, and **Mary** 5, settled just east of Mt. Vernon in 1857. **Reuben SANDERS** was born in South Carolina in 1819, and his father was **Jonathan SANDERS**. **Reuben SANDERS** came to Mt. Vernon from Morgan County Alabama. He married **Lucinda MATHERSON** September 10, 1839 and **Margaret PULLEN** October 20, 1843. She was probably the mother of the above children. **Hiram SANDERS** married **Adeline BRADY** in 1866 and

she died before 1870. He then married **Sarah Ann HEFFINGTON**, a daughter of **Thomas. John SANDERS** married **Mary E. HARRISON** December 24, 1873. She was a daughter of **Dr. R. T. HARRISON** of Mt. Vernon. He moved to Conway and was an early city official and druggist there. **John SANDERS** later married **Lucinda BRYANT**, and she was the mother of his children.

In 1858 **Steven E. LAMAR** 23 from Alabama, and his wife **Florina BRYANT** (sister of Terrell) 27 from South Carolina, came to Enola from Mississippi and settled three fourths of a mile north east of Enola, on the **Bud BRYANT** place. **Joseph MILAM** from Alabama came here with the **LAMARs** and married **Steve LAMAR's** sister. **Joseph MILAM** was **papa's** first patient when he began the practice of medicine in 1906. **Steve LAMAR** was the first postmaster at Enola in 1879. **Steve LASLEY**, **Steve ELLIS**, **Ellis LASLEY** and **Ellis HAILEY** are all named for Uncle **Steve LAMAR**.

Francis Marion LASLEY 18, from Soddy, Tennessee, and his wife **Frances Marsena BRYANT** 16, settled about a half a mile east of Marcus Hill in 1874. They were married at **Dr. Terrell BRYANT's** house on May 21, 1874 by Uncle **Steve LAMAR**. She is buried near Sheridan. He is buried at Marcus Hill. They were my wife's grandparents. Both her grandfathers died the same day.

Papa told me that the first church and school, near Marcus Hill, was one half mile south of **Dr. Terrell BRYANT's** house on the west side of the road just north of where **Barn SANDERS** lived when I was a child. It was next at the southwest corner of **Grandma INGRAM's** field.

Some of the early doctors around Enola were: **Dr. Anthony HINKLE**, **Dr. HARRISON**, and **POWERS** at Mr. Vernon, **Dr. Terrell BRYANT** at Marcus Hill and Enola, and soon to follow were **Dr. Jess REYNOLDS**, who lived on the **Tom GRIMES** place, **Dr. OWNS** lived just south of Uncle **Dave SMITH**, **Dr. BENNETT** lived 100 yards east of town, **Dr. PASCAL** lived where the school house now stands, and **Dr. Fred BROWN** lived on the **Steve LASLEY** place.

Some of these doctors were educated in medicine and some just decided to be a doctor and paid their license fees. That's all you had to do in those days. I found one of **Dr. Terrell BRYANT's** prescriptions for liniment in **L. T. LASLEY's** old trunk in 1971. He was **L. T.'s** grandfather. Here it is: quart of apple vinegar, 1 oz oil of cedar, 1 oz oil of winter-green, 1 oz oil of spook, 1 oz spirits of camphor, 1 oz

turpentine, and 1 oz oil of pole cat. It was like **Brylcream**-a little dab would do you.

Some of the folks who lived around Enola in the 1880s were: **Steve LAMAR**, **Johnny CUMMINGS**, **Jim REYNOLDS**, **Jess REYNOLDS**, **Jim REYNOLDS, Jr.**, **Dr. Jess REYNOLDS**, **Jimmie CUNNINGHAM**, **Bell MARTIN**, **Jeff MIDDLETON**, the **MUNGERS**, **Colonel HARPER**, **Sam MORRIS**, **Sam JOSLIN**, the **SAMON's**, the **SHOCKs**, the **MATTHEWS**, **Belton SETZLER**, **David & Jonathan HAILEY**, **John AUSTIN**, **Joseph & George DALTON**, **Usley SMITH**, **A. A. WILSON**, **Dr. Terrell BRYANT**, **Willis GUNTER**, **Jap & Jack STARR**, **Man SMITH**, **Anthony BRADY**, **Tom GRIMES**, **Spanker MC GLONE** and the **BAILEYs**. Lots of these I never heard of and many I have left out.

Early merchants at Enola were: **Jimmy CUNNINGHAM**, a Mr. **HAINES** who ran the Grange Store, **Dr. Terrell BRYANT** and **Quenton BRYANT** ran a drug store, and **Jimmy REYNOLDS, Jr.** ran a general store. The Grange Store seems to have been the uniting force and the main thing that made it a town. **Mrs. Georgia HARPER Graham** said that it was already a small village when she moved her in 1881. **Frank BAILEY's** father was running a gin at Enola at that time. It was later run by **Belton SETZLER** and then by **Sam JOSLIN**. **George SHOCK** ran a gin about two miles east of Cross Roads about this same time.

Southern soldiers around Enola were: **William & Ambrose HARDIN**; **Bob & Roe BRADY** at Naylor; **Dr. Terrell BRYANT**; **James & Wes BRADY**; **Lish BAILEY's** grandfather; and one or two of the **MABRYs**. **Terrell R. BRYANT** was a Lt. in the southern army.

Postmasters at Enola have been: **Steven E. LAMAR**, 1879; **John ALLEN**, 1883 (I know nothing about him or who he was); **Jonathan HAILEY**, 1883; **Dr. Terrell BRYANT**, 1886; **J. H. REYNOLDS, Jr.** 1887; **J. H. CUNNINGHAM**, 1887; **Dr. Terrell BRYANT**, 1889; **Wm. P. BRYANT**, 1889; **J. H. CUNNINGHAM**, 1895; **Belton SETZLER**, 1897; **J. Walter HENRY**, 1910; **L. B. SETZLER**, 1910; **J. H. CUNNINGHAM**, 1914; **L. B. SETZLER**, 1919 to 1943; and **Ruth SETZLER Bailey** 1943 to 1972. Some member of the Setzler family has been postmaster at Enola for more than 70 of the 92 years that I has been a post office. Evidently their service has been quite satisfactory.

Lots of early settlers around Enola paid no taxes at all for 15 or 20 years. These men paid these amounts in these years

and its is all they did pay. This is from the official Conway county tax records. In 1840, **Granville & Tillman HOGUE** paid \$.50 poll taxes. In 1841 **Coney BRADY** paid \$4.20. In 1842 **Sampson ADKISSON** paid \$.97, **Francis Patrick HENRY** paid \$.75, and **Richard MIDDLETON** paid \$1.05. In 1843 **David, Henry, & Stephen HEFFINGTON, Elijah & Gibson HOGUE, G. W. STARR and W. TERRELL** each paid \$.50 poll taxes. In 1845 **Dr. Anthony HINKLE** paid \$.86, and **Thomas HEFFINGTON** paid \$.90. And that's all they paid for these years.

Will of Edward Tyrrel of Downham

(Register Henry Chicle, vol. II, p. 628; Cant. & York Pub., vol 42) [Emphasis added, broken into paragraphs for easier reading.]

The will of **Edward TYRELL** squyer, the elder, dwelling at Downham, co. Essex, 10 October, 21 Henry VI (1442).

Bequeathed his soul to the Virgin and all the Saints of Heaven. Bequests of personalty to servants and friends. To be buried in the church of the Freres of Chelmsford in the chapel I have made there in the nave.

To the church at Downham for tithes forgotten 40/. To poor men at my obit 10 marks.

To servant **Eleanor PRESTON** 10 marks at marriage, if she be with me at the time of my death.

To every yeoman of mine and every woman servant in my service at the time of my death, who have been with me for 3 years previously thereto, 26/8 each. To such as have served me 7 years 40/. To every groom in my service for 3 years at the time of my death 12/4 and for those in my service 7 years 20/ each.

To **William HAULTE**, squyer, one of the executors, my testament, a pair of sheets of Reyns and another pair of Holland cloth. To **Peryn FRENSSHMANA**, my servant, 40/. To every yeoman and woman servant who has served me for two years before my death 6/8 and to every groom of like service, 3/4.

To my son **Edward**, bed linen at age 21.

To **Thomas BERWYKE** 40/.

To **Thomas HYLINGESTON** 40/.

To godson **Edward CORNY** 40/, if he take no advantage of the gifts to servants. A like bequest to **William LAMBE**.

To the marriage of five maidens 100/, in worship of the 5 joys of Our Lady. Servants, **Crystean** and **Alison** to be two of said maids, if they take no advantage of gifts to servants.

To **Johne**, old coachman's wife, 20/. To **Lowys** my servant

in the kitchen, if he take no advantage of the other gifts to servants.

Residue to my executors to dispose of to the intention of my will, namely **William HAULTE** squyer, **Thomas TYRREL** squyer (i.e. Sir Thomas of Heron), **William MELRETH** citizen and alderman of London, **James KILOM** and **Robert BEAUCAMP**. To each executor 10 marks. Supervisors **Humphrey**, Earl of Stafford, **John**, Earl of Oxford, **Henry BOURCHIER** Earl of Eu, Sir **Nicoll DIXON** clerk, **Robert DARCY** squyer and **Thomas GLOUCHESTER** squyer.

Testment of **Edward TYRREL**, squyer the elder made at Downham in Essex 9 December, 21 Hery VI (1442)

The debts to my mother Dame **Eleanor HAULTE** and to my brother **William LYSLE** (TYRREL struck out) to be paid.

The Lords of Stafford and Oxford, who stand enfeofed to my use in the manors of Shepereth, Malketon, and Melreth and in rents in said manors and in other rents and services in the vills of Shepereth, Melreth, Melboume, Foxston, Malketon, Royston, Waddon, Baryngton, Foulmer, Wendy, and Kmesworth and elsewhere in Cambridgeshire to make an estate for my wife **Anne** for life and when my son **Edward** come to the age of 21 winters, to make an estate in reversion to him and to the heirs of his body and, if he die without such issue, then to **Philip** and **Margaret** my daughters for their lives and on their decease to my nephew **Thomas TYRREL** and the heirs male of his body and if he die without such issue then to my right heirs, provided always that my nephew **Thomas** within three years of my decease fulfill the will of my brother Sir **John TYRREL** touching the remainders, so that my nephews **William** and **William** nor my male issue be not defrauded of said remainders and if he break not any article in my will and if he fail in this the remainder here made to my nephew **Thomas** shall be void.

My feoffes who are enfeofed of my lands and tenements in Harrow-on-the-hill shall make an estate to my son **Edward** at 21, providing also for my wife's dower.

My feoffes of certain messuages and tenements called "Colkyrk", sometime Lancaster's, in Hatfield to be sold and the proceeds expended for an honest priest to sing yearly in Downham church for my soul and that of my wife **Anne** and **Walter TYRRELL** my father and **Eleanor** his wife, my mother and for the souls of Sir **John TYRREL** and Sir **William LYSLE** knights and of **Richard**, **Thomas**, &

William my brothers and of **John BASSINGBORNE** and for all I am bound to pray for and for all Christian souls.

My feoffes of certain lands and tenements calld "Gyffardes", "**Toraldes**" and "**Buskyns**", sometime called "Flemynges" in Sowthhanyfeld and Downham to make an estate for **Anne** my wife, remainder to my son **Edward** and the heirs of his body and if he die without such heirs the said lands are to remain to my daughter **Philip** for life, remainder to my daughter **Margaret** for life, remainder to my right heirs.

The feoffes enfeofed by me at the commandment of my brother's will and also the will of Sir **William MOUNTENEY**, that did make an estate for **Robert MOUNTENEY** his cousin and heir and for **Margaret** my daughter, his wife, to hold said manor to the use of Robert and Margaret and the heirs male of Robert by said Margaret and if Robert die without such heirs to remain to **Elizabeth** that was the wife of **John CHAMBERLAIN** sister of the said Sir **William MOUNTENEY** and the heirs male of her body who shall bear the name and arms of said Sir **William MOUNTENEY**, after the form of his last will.

If the said **Elizabeth** die without such issue male, then to **Margaret**, wife of Sir **John GERMAN** knt., sister of the said **Elizabeth** and the heirs male of her body and, if she have none, then to **John MOUNTENEY** of Yorkshire and the heirs male of his body and if he die without such heirs male then to come to me and them enfeofed by my said brother Sir **John TYRREL** and our heirs and the said manor to be sold and the proceeds used for the souls of Sir **William MOUNTENEY** and of his parents and for the souls of all Christians, according to the will of Sir **William**.

The feoffes of my lands, rents, and tenements called Porters in Rochefort Hundred, co. Essex shall make an estate for the said **Robert MOUNTENEY** and **Margaret** my daughter, his wife, when Robert shall attain when Robert shall attain 21 years, and for the assigns of said Margaret. He refers to his suit against the Duke of York for the wardship and marriage of the said Robert.

My Lords Stafford and Oxford and **Robert DARCY** squyer and my executors to have my term in Tyrrell's manor in Downham for the support of my wife, as I have said manor by lease from my brother, Sir **John TYRREL** and confirmation from **Thomas TYRREL**, my nephew.

My feoffees of a tenement called "Daniels" in Ingegyngeroberlaundry (Buttsbury), now called "Herford-

stock" and in Buttsbury to sell the same to make an annuity for **Robert BEAUCHAMP**, my servant.

To **Anne**, my wife, my place at Dougate, London, for life, reversion on her death to be sold and the proceeds applied to charity.

My plate &c to wife **Anne** together with my goods at Downham.

The proceeds from the forfeiture of the marriage of my wife's son, **John BASSINGBORNE** to be divided into 3 parts. The first part to the said **John BASSINGBORNE**, the second to my wife to pay the debts of her husband, **John BASSINGBORNE** and for alms for her soul and the third part to my executors for the performance of my will.

To my servant, **John FRYTH** an estate in the house he dwells in called "Dunmowes" in Downham.

To my servant **William BAKE** an estate called "Perkyn Feyrehede" in Southhanyfeld.

To **Thomas BOTILER** the lands and tenements called "Barons" in Downham for life, reversion to my bastard son, **John**, and my lands and tenements called "Bartlottes" in Retyngdon and South Haneyfeld.

Confirms the gift to his wife of the Cambridgeshire lands, as in his will indented, for her life, remainder to his son **Edward** at age 21 and the heirs male of his body and if he and **Thomas** my nephew die without heirs male, then to the heirs general of my son **Edward**, begotten by him and if he die without heirs of the body then to my right heirs. Dated 14 December, 21 Henry VI (1442)

Buttsbury. Sir **Thomas TYRREL**, who died in 16 Edward VI (1476/7), held

White's manor in Buttsbury of **Elizabeth**, the Queen, by fealty and 2d rent per annum and Tyrell's manor in the same parish held of the Prioress of Hakelynton by fealty and 6/ rent and 20 messuages, 200 acres of arable land, 40 acres of meadow, 40 acres of wood in Buttsbury, Ynggingberdlaundry (in Buttsbury) and Hereford Stoke held of the Queen as of the Duchy of Lancaser (Inquisition, 16 Edward IV, fo. 116).

Sir **Thomas TYRREL**, who died 2 Henry VIII (1510), held Tyrell's manor in Buttsbury of the Prioress of Hakelynton and White's manor in Buttsbury held of **Catherine**, the Queen as her Duchy of Lancaster. **Thomas**, his son and heir,

was aged 22 years (Inquisition, 21 November, 5 Henry VIII, 1513, fo. 28)

Vol I, p. 206. Downham. Sir **Thomas TYRREL** died 1476. He held Hemnales manor in Downham and 300 acres of arable land, 40 acres of meadow, 100 acres of pasture, and 4 acres of wood in Downham, South and West Hanningfield, Wykford, and Ramsden Belhouse of **Henry**, Earl of Essex by fealty and rent of 40d p.a. (Inquisition, 16 Edward IV, 1476/7).

When Sir **James TYRREL** married **Margaret** ?, daughter and heir of Sir **William HERON**, in the time of Edward II or III (sic), the Tyrrels undoubtedly got Heron. **Thomas TYRREL** in 1363 had license to impale 400 acres of pasture and wood in Horndon and Ingrafe (Patent Roll, 37, Edward III). **John TYRREL** was one of the founders of a chantry in Wivenhou church in 1413, he held the manor of Heme in East Hemdon of the King as of his manor of Rochester (Inquisition, 1 Henry V, 1413/14).

Vol. III, p. 468. Chilworth. In 1365, **Thomas PEVEREL** sold Chilworth to Sir **Thomas TYRREL** of Essex, knt. (Cl. R., 38, Edward III, m. 32, 28), who prior to 1372 conveyed it to **John DACCOMBE** (Chanc. Inquisition Post Mortem, 45 Edward III (2nd nos.) 48).

Ibid, p. 483. Mainsbridge. **Thomas PEVEREL** in 1365 sold the manor of Mainsbridge to **Thomas TYRREL** knt. of Essex (Cl. R., 38 Edward III, mm. 32, 28) who almost at once sold it to **Thomas DACCOMBE** (Abb. Rot. Orig., Rec. Com., p. 318).

Vol V, p. 125. Milton Manor. In 1365, **Thomas**, son of Sir **Henry PEVEREL**, granted Milton to Sir **Thomas TYRREL** knt. (Cl. R., 38 Edward III, mm. 32, 28), whose son **John** (sic) in 1428 held 1/2 knts. fee in Milton (Feudal Aids,

II, 359). In 1475, Sir **Thomas TYRREL**, son of **John**, was seised and settled it in that year upon his grandson, **Thomas TYRREL** in tail (Anc. D. C. 1358). Ibid, p. 118. Milford. The manor of Pennington's in Milford was conveyed in 1364 by **Thomas PEVEREL**, son of Sir **Henry**, to Sir **Thomas TYRREL**, knt. (Cl. R., 38 Edward III mm. 32, 28).

The family of **BELE** held the manor from 1285-1347, and it reverted to **BELE** in 1391, who conveyed it to Sir **John KNOTTINGLE** and his wife for life. (Plac. Abb., p. 209; Hants Fine, file 29, no. 11.) When **Eleanor**, widow of **Walter TYRREL**, died in 1422 she owned the manor of Avon TYRREL and also an estate in Ripley called Knottin-gale (Inquisition Post Mortem, 10 Henry V, no 29a; Hants. Fines, file 21, no. 46; file 29, no. 38; file 31 no. 5).

From the above records a fairly satisfactory pedigree of the TYRRELS of Heron may be compiled and some previous errors may be corrected.

Morant's statement that the family were probably introduced into Essex by the marriage of **James TYRREL** with **Margaret**, heiress of Heron, in the reign of either Edward II or III would seem to be substantially correct.

However, the fines of 1304/5 show that Sir **James** was already in Essex towards the end of Edward I's reign, and that his wife's name at that date was not **Margaret** but **Alice**. It is, of course, possible that he married twice. The three fines of 1304/5 show him owning lands in Buttsbury, which descended to later members of the family. In 1304/5, he was evidently providing for a daughter, **Joan**, undoubtedly a minor at the time.

James must have been born some time back in the thirteenth century, about 1265-1270. He occurs in 1317 (Cal. Pat. R.,

op. cit.) and must have been alive as late as 1343 when **James TYRREL** the younger occurs (Essex Fines, *op. cit.*), but he evidently died soon after, before 1345 when **James TYRREL**, evidently the younger of 1343, was complained of for riot (Cal. Pat. R., *op. cit.*).

Besides **Joan**, he was undoubtedly the father of **James** the younger and of a son **Thomas**, who was apparently his heir, as he appears in a fine at Buttsbury in 1332 as "**Thomas TYRREL** the elder" (Essex Fines *op. cit.*). It is difficult to say just when he died. He is evidently the "**Thomas TYRREL**, the elder" who occurs in the Close Roll in October 1342 (Cal. Cl. R., *op. cit.*), and he is probably the **Thomas TYRREL** the elder who occurs frequently in the records 350—360. "**Thomas TYRREL**, the elder" last appears as knight of the shire from Essex in 1360 (Parliament of England, *op. cit.*), but as he must have been born about 1288—1290, it would seem that he would have been about 70 when he was M. P. in 130, and it may be that the **Thomas**, the elder, of 1360 was Sir **Thomas** who was buried at Downham about 1382, who may have had a son **Thomas** who died a young man shortly after 1360. **Thomas TYRREL**, the elder of 1332, married **Alice**, daughter of **Thomas BLAUND** and **Agnes**, his wife (De Banco Rolls, *op. cit.*). They were clearly the parents of Sir **Thomas** of Heron who died about 1382.

The first appearance of the latter was in 1335, when, as **Thomas TYRREL** the younger with his wife **Alice**, he was dealing in land in Great Burston and Ramesden Craye, which descended in the family, Ramsden Craye being held in 1476 by Sir **Thomas TYRREL** of Heron. **Thomas TYRREL** was a prominent man in Essex in his day and was evidently a lawyer. Born about 1310—1315, he married, prior to 1335, his wife **Alice**. He was already knighted by 1355 and was knight of the shire in Essex in 1355, 1357, 1364/5, 1366, 1369, 1372, and 1373. He was Steward General of **King Edward III's** daughters in 1363 (Calendar of Ancient Deeds, C 2529, *op. cit.*).

In 1364/5 he was buying the fees of **Thomas**, son of Sir **Henry PEVEREL**, in Hampshire at North Avon, Chilworth, Milton, Mainsbridge, and Milford (V. C. H. Hants, *op. cit.*). Some of these he retained, but others he soon disposed of. The manor of North Avon and that of Milton descended in the family and were held in 1476 by Sir **Thomas TYRREL** of Heron.

It is possible that the Essex TYRRELS may have descended from the Hampshire TYRRELS of the thirteenth century as suggested by Mr. TYRREL. Sir **Thomas** died shortly before 10 June 1383, when he is mentioned in the Close Rolls as "lately deceased." He is buried in Downham church with his wife, **Alice**, his brass showing him in full armor. His brass is inscribed: "*Mons. Thomas Tyrrel gist ici dieu de slame eit verrote mercy*". His wife's inscription reads: *Alice q fut la*

feme de Mons' Thoms Tyrrel gist ici dieu de slame eit mercy" (Essex Arch. Soc. Trans., n.s., vol 6, p. 233).

The pedigrees state that Sir **Thomas** married, first, **Alice d'ADLEIGH**, whose arms "chequy gold & sable" appear with the **TYRREL** arms "silver, two chevronels azure, a bordure engrailed gules", on their brass above mentioned, and that his second wife was **Eleanor**, daughter of **John FLAMBARD**. However, the writer has found no evidence of the second wife. On 7 June 1384 "Dame Alice **TYRREL**, who was the wife of **Thomas TYRREL**, knt. is mentioned in the Close Roll, and again on 2 Aug. 1395. From an entry in the Patent Rolls of 2 Aug. 1398 it appears that Alice was dead at that time (Calendar of Patent Rolls, *op.cit.*).

All pedigrees state that Sir **Thomas** was the father of Sir **John TYRREL** who died in 1437, but the evidence of the will of his brother, **Edward** of Downham, and the Fine Roll of 1422 (*op. cit.*) show conclusively that they were sons of **Walter TYRREL** and the latter was evidently the son of Sir **Thomas**; **Walter's** descendants held the Essex and Hampshire lands of Sir **Thomas**. In 1370, Sir **Thomas** gave the manor of North Avon, Hants., to **Walter TYRREL** and **Eleanor**, his wife (Cal. Inq., vol II, 302; Woodward & Lockhart's Hants., *op. cit.*). Accordingly, it is not unreasonable to assume that **Walter** was the son of Sir **Thomas**.

Coram Rege Roll, Hilary, 8 Henry V, m. 21 (1420/21) Cambridge. **William POTTON**, clerk, and **William BATEMAN**, on the 27th November 12 Richard II, before the mayor of the staple at Westminster, recognised that they owed **Elizabeth FLAMBARD** and **John FLAMBARD** then dead (*iam defunctis*), 200 pounds, to be paid by Easter next, which had not been paid.

Nicholas HAUTE [?HANTE] knight, and **Aliamor** [**Eleanor**] his wife, daughter of the aforesaid **Elizabeth** and executrix of the testament of the said **Elizabeth**, which the said **Elizabeth** outlived the said **John FLAMBARD**, demanded satisfaction of the debt.

The aforesaid **William POTTEN** died and **William BATEMAN** could not be found, so an inquisition was ordered to be made into their property in co. Cambridge, i.e., the manor of Huntingfields, etc.

Ralph BATEMAN appeared and said he now held the said manor, and cited an agreement made with the said **Elizabeth** for repayment of the debt over a longer period. The said **Elizabeth** died on the feast of the Nativity of St. John the Baptist 1394 and never received any of the money agreed to be paid.

The final decision of this court is that the said **Alianora** is to be awarded the said manor of Huntingfields in Harleton, also the manor called Ladysmanor in that township, and two messuages and eighty-two acres of land in Harleton, in settlement of the above debt and her costs and damages in this case.

Concerning **Walter TYRREL** of Essex the entries in the records are not numerous. In 1364 he witnessed an Essex deed (Cal. Cl. R., *op. cit.*). He is probably the **Walter TYRREL** who, on 15 Feb. 1367 was granted a ferry over the Tweed at Berwick for his good services to the King and his daughters, **Joan** and **Isabel** (Calendar of Patent Rolls., *op. cit.*). In 1363 he is named as Steward General to the King's daughter **Isabel** (Cal. Anct. Deeds, *op. cit.*). In 1370 he, together with his wife **Eleanor**, received from Sir **Thomas TYRREL** the Hampshire manor of North Avon. On 3 Dec. 1376 he, together with Sir **Thomas**, witnessed an Essex deed (Calendar of Fine Rolls, *op. cit.*).

He occurs in the Fine Roll on 11 Nov. 1391 as "Walter **TYRREL** of Essex", and again on 12 March 1406 (Calendar of Fine Rolls, *op. cit.*), but died sometime thereafter, as on 12 May 1422 his widow **Eleanor**, who had married Sir **Nicholas HAULTE** was dead. The entry of her death in the Fine Roll states that Sir **John** of Heron was the son and heir of **Walter**, and so does the will of **John's** brother, **Edward TYRREL** of Downham.

Walter & Eleanor had issue: Sir **John**, the eldest son and heir who held Heron, the Buttsbury manors in Essex, and the Hampshire manors of North Avon, Ripley, and Milton. Sir **John** was knight of the shire for Essex in 1411, 1413, 1417, 1419, 1421, 1422, 1425, 1429, 1430/1, 1433, and 1436/7. He was Speaker and died in 1437, leaving by his wife **Alice** daughter and co-heiress of Sir **William de COG-GESHALL**, a son and heir, Sir **Thomas TYRREL** of Heron, born in 1411, died in 1476, the ancestor of the later **TYRRELS** of Heron (cf. "Wedgewood's History of the Parliament, Biographies, 1439—1509" p. 891, for his life).

Sir **John's** other sons were **William** of Gipping co. Suffolk, and **William** of Beeches, co. Essex (cf. Wedgewood, *op. cit.*). **William of Gipping** was the father of Sir **James TYRREL**, the creature of Richard III, who murdered the little princes in the Tower.
